As most of you know, the 111<sup>th</sup> Congress has been a particularly active one in its first two months. Unfortunately, just because Congress is doing *a lot* doesn't always mean it's doing *what's best*.

The Education and Labor Committee has been in the thick of this activist Congress, with major labor legislation brought to the House floor as the first substantive matter considered in the 111<sup>th</sup> Congress. You can read more about our concerns about the Ledbetter bill here.

Our Committee's issues were also front and center in the debate over the government stimulus package crafted by congressional Democrats. Unfortunately, our Committee itself was completely excluded from the development of the legislation. It seems that in Democrats' haste to enact the \$787 spending bill, they didn't feel the need to involve the committees of jurisdiction.

While the stimulus package contains funding for a number of education programs that Republicans support, we have serious concerns about the manner in which these funds were allocated, and the financial controls that will be used to ensure taxpayers' interests are protected. If the first two months are any indication, the 111th Congress is going to be one of the busiest ever and not always with pro-student, pro-worker, or pro-taxpayer results. ### The Battle Over the Secret Ballot Heats Up

The Education and Labor Committee will be home to one of the fiercest debates on this year's legislative agenda, and although the bill at issue has not even been formally introduced, we can tell you that the fight is already well underway.

Special interest groups including top labor bosses have mobilized in support of the misnamed *Employee Free Choice Act*, a bill that would actually *take away* an employee's right to freely choose by secret ballot whether to join a union.

Republicans aren't going to stand by while workers' democratic rights are taken away. That's why we're fighting back. Just this week, we <u>introduced</u> a bill of our own to ensure that workers are *guaranteed* the right to a secret ballot: it's the *Secret Ballot Protection Act*.

We're also putting out regular email updates highlighting strong opposition to the card check plan among newspaper editorial pages and the American public. And we're exposing little known facts about this dangerous legislation. ## Education & the Stimulus: What About the Taxpayers?

On February 17, President Obama signed into law a staggering \$787 billion "stimulus package" that includes roughly \$100 for various education billion programs. While Republicans are strong supporters of some of the programs funded in the stimulusfor example, Title I, IDEA, and Pell Grants—we have serious concerns doubling the Education about Department's budget without the

necessary safeguards in place to protect taxpayers.
