### **CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES TEACH FOR AMERICA GRANT FOR VALLEY SCHOOLS**

Washington, DC-Congressman Rubén Hinojosa demand by organizations seeking AmeriCorps announced today that Teach for America-Rio Grande Valley has received a \$370,000 Ameri-Corps grant from the Corporation for National and Community Service.

The grant will support 185 AmeriCorps members who will serve as teachers to ensure that the students are given the tools, encouragement and high expectations required to succeed academi-

cally in low-performing schools located in the Rio Grande Valley.

"Citizen service is an essential part of the solution to many of the social challenges facing our communities, especially in tough economic times," said Rep. Hinojosa. "These AmeriCorps members will

meet pressing local needs and strengthen our communities as they develop civic and leadership skills that can last a lifetime. I congratulate Teach for America-Rio Grande Valley for receiving this grant and thank all those who have answered the call to service by joining AmeriCorps."

In addition to grant dollars, the Corporation is setting aside funding to pay for Segal AmeriCorps Education Awards for individuals who will serve in positions funded by these grants. After completing a full term of service, AmeriCorps members receive an education award of \$5,350 that they can use to pay for college or to pay off student loans. The current year's AmeriCorps grant cycle was highly competitive, due to the strong and growing



resources. Organizations requested nearly twice the number of grant dollars and AmeriCorps positions than could be funded.

The grants focus AmeriCorps resources on six key areas: strengthening education, fostering economic opportunity, preparing for and responding to disasters, improving health, meeting environmental and energy efficiency needs, and assisting

veterans and military families.

AmeriCorps is a national service program that engages Americans of all ages and backgrounds in service to meet critical needs. Its members serve in thousands of nonprofit and faith-based organizations in rural and urban communities throughout the nation. Among other

activities, tutor and mentor youth, expand health services, build affordable housing, run after-school programs, support veterans, help communities respond to disasters, and recruit and train volunteers.

AmeriCorps, which is administered by the Corporation for National and Community Service, engages 80,000 people each year in intensive, results-driven service through more than 14,000 nonprofits across the country. Since 1994, more than 700,000 Americans have provided more than 860 million hours of service to their communities and country through AmeriCorps. ## CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES OVER \$100,000 IN A GRANT TO HELP SMALL BUSINESSES AND CREATE JOBS

Washington, DC-Today-Congressman Rubén Hinojosa announced a grant for \$114,150 was awarded to the Pharr Economic Development Corporation by the United States

Department of Agriculture (USDA) Rural Development Program under the Rural Business Enterprise Grant (RBEG) program to help small businesses in rural communities and create jobs.

The RBEG program provides grants for rural projects that finance and facilitate development of small and emerging rural businesses help fund business incubators, and help fund employment related adult education programs. To assist with business development, RBEGs may fund a broad array of activities. ## IRS IDENTIFIES ORGANIZATIONS THAT HAVE LOST TAX-EXEMPT STATUS

WASHINGTON — The Internal Revenue Service today announced that approximately 275,000 organizations under the law have automatically lost their tax-exempt status because they did not file legally required annual reports for three consecutive years. The IRS believes the vast majority of these organizations are defunct, but it also announced special steps to help any existing organizations to apply for reinstatement of their tax-exempt status.

Congress passed the Pension Protection Act (PPA) in 2006, requiring most tax-exempt organizations to file an annual information return or notice with the IRS. For small organizations, the law imposed a filing requirement for the first time in 2007. In addition, the law automatically revokes the tax-exempt status of any organization that does not file required returns or notices for three consecutive years.

For several years, the IRS has made an extensive effort to inform organizations of the changes in the law through multiple outreach and education avenues, including mailing more than 1 million notices to organizations that had not filed. In addition, last year the IRS published a list of at-risk groups and gave smaller organizations an additional five months to file required notices and come into compliance. About 50,000 organizations filed during this extension period. Overall, the IRS believes the vast majority of small tax-exempt organizations are now in compliance with the 2006 law.

"During the past several years, the IRS has gone the extra mile to help make tax-exempt groups aware of their legal filing requirement and allow them additional time to file," IRS Commissioner Doug Shulman said. "Still, we realize there may be some legitimate organizations, especially very small ones, that were unaware of their new filing requirement. We are taking additional steps for these groups to maintain their tax-exempt status without jeopardizing their operations or harming their donors."

As part of this, the IRS issued guidance today on how organizations can apply for reinstatement of their tax-exempt status, including retroactive reinstatement. In addition, the IRS announced transition relief for certain small tax-exempt organizations – those with annual gross receipts of \$50,000 or less for 2010 – that were made subject to the new "postcard" filing under the PPA. The relief allows eligible small organizations to regain their tax-exempt status retroactive to the date of revocation and pay a reduced application fee of \$100 rather than the typical \$400 or \$850

fee. Full details are available in <u>Notice 2011-43</u>, <u>Notice 2011-44</u> and <u>Revenue Procedure 2011-36</u>.

If an organization appears on the list of organizations whose taxexempt status has been automatically revoked it is because IRS records indicate the organization had a filing requirement and did not file the required returns or notices for 2007, 2008 and 2009. The list of organizations whose tax-exempt status has been revoked for failing to meet their filing requirement, which will be available on the IRS website at www.IRS.gov, includes each organization's name, Employer Identification Number (EIN) and last known address. It is searchable by state. It also includes the effective date of the automatic revocation and the date it was posted to the list. The IRS will update the list monthly to include additional organizations that lose their tax-exempt status.

The vast majority of tax-exempt groups file their required returns and are unaffected by the revocation listing. In addition, the IRS believes the vast majority of the newly revoked groups are no longer in existence and need to be removed from the tax-exempt listing as the 2006 law requires.

This listing should have little, if any, impact on donors who previously made deductible contributions to auto-revoked organizations because donations made prior to the publication of an organization's name on the list remain tax-deductible. Going forward, however, organizations that are on the auto-revocation list that do not receive reinstatement are no longer eligible to receive tax-deductible contributions, and any income they receive may be taxable.

Publication on the list of organizations whose tax-exempt status has been revoked serves as notice to donors and others that they may no longer rely on a prior listing in IRS Publication 78, *Cumulative List of Organizations*, as an indication of an organization's tax-exempt status or its eligibility to receive tax-deductible contributions. An updated version of Publication 78 with current listings will be published on the IRS website later this week. Nor can donors rely on an IRS determination letter issued to the organization prior to the date of automatic revocation. Existing organizations that seek to have their tax-exempt status reinstated must complete an application and pay a user fee regardless of whether they were originally required to file such an application. #### Public Television Digital Transition

The Rural Utilities Service (RUS), an agency of the United States Department of Agriculture (USDA), announces its Public Television Digital Transition Grant Program application window for fiscal year (FY) 2011. The FY 2011 funding for the Public Television Station Digital Transition Grant Program is \$4,491,000. As part of the nation's transition to digital television, the Federal Communications Commission (FCC) required all television broadcasters to have converted their transmitters to broadcast digital signals by June 12, 2009. While stations must broadcast their main transmitter signal in digital, many rural stations have yet to complete a full digital transition of their stations across all equipment. Rural stations often have translators serving small or isolated areas and some of these have not completed the transition to digital. Because the FCC deadline did not apply to translators, they are allowed to continue broadcasting in analog. Some rural stations also have not fully converted their production and studio equipment to digital, which has impaired their ability to provide the same quality local programming that they provided in analog. The digital transition has also created some service gaps where households that received an analog signal are now unable to receive a digital signal. For rural households the digital transition has meant in some cases diminished over-the-air public television service. These rural households are the focus of the Agency's Public Television Station Digital Transition Grant Program. Most applications to the Public Television Station Digital Transition Grant Program have sought assistance towards the goal of replicating analog coverage areas through transmitter and translator transitions. The first priority has been to initiate digital broadcasting from their main transmitters. It is important for public television stations to be able to tailor their programs and services (e.g., education services, public health, homeland security, and local culture) to the needs

Eligible Applicants: Public television stations which serve rural areas are eligible for Public Television Station Digital Transition Grants. A public television station is a noncommercial educational television broadcast station that is qualified for Community Service Grants by the Corporation for Public Broadcasting under section 396(k) of the Communications Act of 1934.

In order to achieve this, successful applicants will implement policy, environmental, programmatic, and infrastructure changes described by the strategic directions listed to achieve the intended outcomes. This FOA specifically addresses five "Strategic Directions:" tobacco-free living, active living and healthy eating, high impact evidence-based clinical and other preventive services, social and emotional wellness, and healthy and safe physical environment. Among these priorities, capacity building and implementation programs should focus on tobacco-free living, active living and healthy eating, and evidence-based quality clinical and other preventive services, specifically prevention and control of high blood pressure. #### Robert Wood Johnson Foundation Announces Call for Proposals for Active Living Research: Building Evidence to Prevent Childhood Obesity

#### Deadline: 07/01/2011

Active Living Research is a national program of the Robert Wood Johnson Foundation that supports research to inform policy and environmental strategies for increasing physical activity among children and adolescents, decreasing their sedentary behaviors and preventing obesity. The program places special emphasis on reaching children and youth between the ages of three and 18 who are at highest risk for obesity — black, Latino, American Indian, and Asian/Pacific Islander children, as well as children who live in under-resourced and lower-income communities. The program has released a call for pro-

posals for opportunistic, time-sensitive studies on emerging or anticipated changes in physical activity-related policies or environments. Rapid-response grants are expected to accelerate progress toward policy and environmental strategies to prevent and reduce childhood obesity. For maximum impact, studies should be completed in as short a time frame as realistically possible and results disseminated using methods designed to reach local, state, or national decision-makers in time to help inform key policy decisions. For Fiscal Year (FY) 2011, the Department of Health and Human Services (HHS), Community and Economic Development (CED) program, administered by the Office of Community Services (OCS) in the Administration for Children and Families (ACF), will provide up to \$16 million in grants (\$800,000 maximum per project) to Community Development Corporations (CDCs) for projects designed to address the economic needs of low-income individuals and families through the creation of employment and business opportunities. #### Emergency Capital Repair Grants for Multifamily Housing Projects Designated for Occupancy by the Elderly

#### Deadline: Open/Rolling

The definition in Section 1701q also includes a for-profit limited partnership the sole general partner of which is (1) nonprofit or (2) a corporation wholly owned and controlled by a nonprofit. Limited Liability Corporations (LLCs) are not included in the definition of the term "private nonprofit organizations". Unless a project is located in a presidentially declared disaster area, it must have had final closing on or before January 1, 2005.
