

CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES HUD GRANT AWARDED TO MCALLEN HOUSING AUTHORITY FOR HOMELESS VETERANS

Washington, D.C.--- Congressman Rubén Hinojosa announced the McAllen Housing Authority was awarded \$40,138 by the U.S. Department of Housing and Urban Development (HUD) to assist homeless valley military veterans, and their families, find and pay for existing housing with tenant-based vouchers.

"We owe a great deal to our returning veterans especially when it comes to making sure that they, and their families, have a comfortable place to call home," said Rep. Hinojosa. "For some veterans, returning home can be a very difficult process, and finding an affordable place to live can be one of the most difficult tasks. This program is designed to help our veterans in need."

Each veteran who receives a voucher will also receive various supportive services provided by the Veteran's Administration.

The HUD-Veterans Affairs Supportive Housing (HUD-VASH) program combines Housing Choice Voucher (HCV) rental assistance for homeless Veterans with case management and clinical services provided by the Department of Veterans Affairs (VA). VA provides these services for participating Veterans at VA medical centers (VAMCs) and community-based outreach clinics.

the U.S. Department of Education has awarded the Karnes City increase mental-health services. Independent School District \$602,128 under their School Climate Transformation Grants Program to school districts. Karnes City ISD will use the funds for several programs that will improve the learning environment in schools.

They include:

- Counseling (mental & conflict resolution)
- Training of students, teachers, and staff
- Character Building, Self-Esteem Building, Conflict Resolution
- Hiring of 2 counselors, and a preventive specialist

These programs will be implemented beginning January 1, 2015. "Creating a safe learning environment in our schools is the first step in encouraging our students to learn and to build confidence," said U.S. Rep. Hinojosa. "I congratulate Karnes City ISD for their dedication to assisting their students in every way possible. This grant funding will help the school district build on an already sturdy foundation of educational success."

The grant funding to be used to help keep students safe and improve their learning environments, the U.S. Department of Education awarded more than \$70 million to 130 grantees in 38 states. The Department made the awards under four new grant programs that were among the common-sense proposals included in President Obama and Vice President Biden's "Now Is The Time (link is external)," a comprehensive plan to make our schools safer, re-

The School Climate Transformation Grant funds will be used to develop, enhance, or expand systems of support for implementing evidence-based, multi-tiered behavioral frameworks for improving behavioral outcomes and learning conditions for students. The School Climate Transformation grants to school districts provide more than \$35.8 million to 71 school districts in 23 states, Washington, D.C., and the U.S. Virgin Islands. The goals of the program are to connect children, youths, and families to appropriate services and supports; improve conditions for learning and behavioral outcomes for school-aged youths; and increase awareness of and the ability to respond to mental-health issues among school-aged youths. School districts also will use funds to implement models for reform and evidence-based practices that address the school-to-prison pipeline—the unfortunate and often unintentional policies and practices that push our nation's schoolchildren, especially those who are most at-risk, out of classrooms and into the juvenile and criminal justice systems. The grants provide funding for up to five years, for a total of nearly \$180 million. Many of the school districts receiving this funding also will coordinate their efforts with support from Now Is The Time programs administered by other agencies. One hundred school districts received the Department of Health and Human Services' Project AWARE grants, including 29 of the Department of Education grantees. In addition, five grantees will receive assistance through the Department of Justice's School Justice Collaboration program.



CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES OVER \$1 MILLION GRANT FOR THE CITY OF PHARR

Washington, D.C.-- Congressman Rubén Hinojosa announced the City of Pharr has received a \$1, 200,000 grant from the Economic Development Administration (EDA) for the construction of an International Trade Center which will also serve as a disaster recovery center when needed. The 15,000 sq. ft., two story building will be a regional international trade center for education and professional association meetings. This Center will serve as a focal point for business and trade along the Texas/Mexico border.

"This is exciting news for the City of Pharr as well as Hidalgo County because this will continue the incredible progress already achieved in creating international trade on our border with Mexico", said U.S. Rep. Hinojosa. "I congratulate everyone involved in obtaining the grant from the EDA. This will be a great asset to our community and to all of the residents in the region."

The job creation and/or career training will take place with the assistance of South Texas College's (STC) manufacturing training department: North American Advanced Manufacturing Research and Education Initiative. Along with the cooperation of the Manufacturing Skill Standards Council (MSSC), STC has agreed to assist with providing national trade/logistics certification and training at this Center where international trade is taking place. Three office spaces will be leased to the Mexican governmental agencies involved in international trade with the City of Pharr. The projected economic benefits are as follows:

- Increase cross-border traffic (commercial/domestic).
- Growth in manufacturing (light/heavy), logistics, cold storage and other related industries.
- Higher demand for skilled workers/higher demand for specialized training.
- Continued attraction of service industries.
- Expansion of markets.
- Boom in property tax revenue from new commercial and residential.
- Spike in sales tax revenue.
- Decrease in unemployment rate.

The total project is expected to cost \$2,900,000. EDA grants are awarded through a competitive process based upon the application's merit, the applicant's eligibility, and the availability of funds.



CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES \$1.5 MILLION FEDERAL GRANT AWARDED TO AFFORDABLE HOMES OF SOUTH TEXAS

Washington, D.C.-- Congressman Rubén Hinojosa announced a federal grant of \$1.5 million was awarded to Affordable Homes of South Texas by the U.S. Department of Treasury to help finance homes for families in South Texas.

"For many years now, Affordable Homes of South Texas has been helping so many families buy homes," said U.S. Rep. Hinojosa. "In most cases these families would not be able to call a home their own without the assistance and guidance of those who work at Affordable Homes of South Texas. I have seen the face of a young working mother, who was also tak-

ing college classes, filled with joy after being given the keys to a home she could now afford and where she could live with her children. These grants provide a way for organizations like Affordable Homes of South Texas to help many of our families live their lives with a sense of pride in being homeowners. I congratulate them on their good work."

The U. S. Department of the Treasury's Community Development Financial Institutions Fund (CDFI Fund) selected Affordable Homes of South Texas for this award through the FY 2014 CDFI Program funding round.

CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES FEDERAL GRANTS AWARDED TO EDINBURG AND MCALLEN FOR POLICE EQUIPMENT

Washington, D.C.--Congressman Rubén Hinojosa announced grants from the U.S. Department of Justice were awarded to the cities of McAllen and Edinburg for over \$43,000 to be used to increase public safety.

The **City of Edinburg** was awarded **\$24,028** through the Edward Byrne Memorial Justice Assistance Grant Program (JAG) for the purchase of portable radios for law enforcement officers. The **City of McAllen** was awarded **\$19,614** to upgrade the Police Department's Explosive Ordinance Device Unit by purchasing a F6A Bomb Robot. The project goals are to enhance public and officer safety.

"I would like to congratulate those who dedicated their time and efforts to ensure that the Cities of Edinburg and McAllen would be recipients of the JAG grants awarded by the U.S. Department of Justice," said U.S. Rep. Hinojosa. "Funds provided by JAG grants are used to buy equipment or to provide training for our law enforcement officers in an effort to help them protect our residents."

The Edward Byrne Memorial Justice Assistance Grant Program (JAG) allows states and units of local government, including tribes, to support a broad range of activities to prevent and control crime based on their own state and local needs and conditions. Grant funds can be used for state and local initiatives, technical assistance, training, personnel, equipment, supplies, contractual support, and information systems for criminal justice, including for any one or more of the following program areas: 1) law enforcement programs; 2) prosecution and court programs; 3) prevention and education programs; 4) corrections and community corrections programs; 5) drug treatment and enforcement programs; 6) planning, evaluation, and technology improvement programs; and 7) crime victim and witness programs (other than compensation).

USER ID REQUIREMENTS

The purpose of this message is to remind AFG applicants of the "User ID" requirements for creating or accessing AFG applications or awards. The FY2014 Assistance to Firefighter Grants application is now available and we want to remind everyone that only the unique "User ID" associated with your organization may be used to create or access an application. Please read the following information to ensure a smooth start to your application process.

 If your organization has applied in the past, you MUST use the user ID used to submit previous AFG applications. If you do not have access to that information, please do the following to request that information:

Send a letter explaining why you need this information, and if you also need to change the Primary Contact information. Please be aware changing the Primary Contact on one grant will cause the Primary Contact to be changed on all other department grants submitted under the same user ID. Contact changes may take up to three days to process. The letter must be on fire department letterhead and signed by the Fire Chief of the department. Once processed, you will receive an e-mail from Pinky Sheets indicating the online system has been updated. You will also receive an automated e-mail from EOPS@dhs.gov with your user ID and temporary password.

If you do not receive this automated e-mail from EOPS@dhs.gov within two days of faxing your request and receiving the e-mail from Ms. Sheets, you should look in your junk mail file. The electronic e-mails are sometimes filtered and sent directly to junk mail.

If you are still unable to get a new user ID and password, go onto the Web site at www.fema.gov/firegrants and choose e-grant application. You will get an application sign-in screen. Click on forgot password, answer the two security questions and submit your request.

- 2. If you have represented a different organization in the past, YOU CANNOT use the user ID used to submit applications for the previous department. USER ID's belong to the organization and NOT to the person filling out the application. In this instance use the USER ID that belongs to the new organization that you represent.
- 3. The creation of a NEW USER ID is only for organizations who have NEVER applied for AFG Grants in the past. This is for truly "New Users(organizations)"

Heritage Preservation, in partnership with the American Institute for Conservation of Historic and Artistic Works, is seeking nominations for the AIC/Heritage Preservation Ross Merrill Award for Outstanding Commitment to the Preservation and Care of Collections. The award is presented annually to an organization in North America that has been exemplary in terms of the importance and priority it gives to conservation concerns and in the commitment it has shown to the preservation and care of cultural property within the context of its broader mission, which may include interpretation, research, scholarship, education, and/or public outreach. Anyone may submit a nomination. Doris Duke Charitable Foundation Accepting Grant Proposals to Strengthen Performing Arts

Deadline: 02/27/2015

Through its Fund for National Projects, the Doris Duke Charitable Foundation awards up to \$1 million in grants annually in support of national projects in the professional nonprofit dance, jazz, presenting arts, and/or theater fields. Specifically, the fund supports projects that strengthen the national infrastructure of the nonprofit performing arts, as well as those that improve conditions for the national community of performing artists in professional nonprofit dance, jazz, and theater. Eligible projects engage a broad constituency, occur once (or periodically) rather than annually, and have the potential to significantly impact a field, including research projects assessing the national health of professional nonprofit arts groups or of individual professional artists. Projects may also involve special national convenings for entire professional nonprofit performing arts fields (beyond traditional national annual conferences) and efforts to address unique circumstances that impact an entire professional nonprofit field. Highest priority will be given to projects that improve the health of the foundation's priority performing arts fields and do not duplicate ongoing efforts or existing services. Grant amounts will range between \$60,000 and \$200,000, and may not exceed 40 percent of the total project cost. The fund does not support projects by single performing arts entities; ongoing annual conferences; individually produced conferences, performances, or symposia; re-granting programs; translations or commissions of new works; production start-up activities/production costs; arts education; avocational arts activities; capital projects; and endowments.

Stand Down Grants

U.S. Department of Labor (DOL)

"Stand Down" is a military term referring to an opportunity to achieve a brief respite from combat. Troops assemble in a base camp to receive new clothing, hot food, and a relative degree of safety before returning to the front. Today more than 160 organizations across the country partner with local businesses, government agencies, tribal governments, community, and faith-based service providers to hold Stand Down events in local communities for homeless veterans and their families.

Each year, the Assistant Secretary for Veterans' Employment and Training awards Stand Down grants to assist with the reintegration of homeless veterans into the labor force through programs that enhance employment and training opportunities and promote self-sufficiency. Typically, services available at these events include temporary shelter, showers, haircuts, meals, clothing, hygiene care kits, medical examinations, immunizations, legal advice, state identification cards, veteran benefit information, training program information, employment services, and referral to other supportive services. Stand Down funding is provided in the form of non-competitive grants that are awarded on a first-come, first-served basis until available funding is exhausted. For the purpose of a Stand Down grant award, applicants must describe a plan that clearly demonstrates how grant funding will be used for homeless veterans only. While both veterans and non-veterans may participate in Stand Down events, grant funding can only be used to purchase items, to include food and meals, for homeless veteran participants. The following minimum services must be available for homeless veteran participants:

- •Department of Veterans Affairs (VA)--benefits, medical and mental health services;
- •Department of Labor--State Workforce Agency employment and training services to include Disabled Veterans' Outreach Program (DVOP) specialist or other American Job Center staff, where available; and
- •Referral services to secure immediate emergency housing.

Eligible Applicants: The following organizations may apply for grants under this solicitation: state and local Workforce Investment Boards, Veterans Service Organizations, local public agencies, tribal governments, and non-profit organizations including community and faith-based organizations. Organizations registered with the Internal Revenue Service as 501(c)(4) organizations are not eligible to apply for this funding opportunity.

Food Insecurity Nutrition Incentive Grant Program

U.S. Department of Agriculture (USDA)

Deadline: 12/15/2014

The primary goal of the FINI grants program is to fund and evaluate projects intended to "increase the purchase of fruits and vegetables by low-income consumers participating in [SNAP] by providing incentives at the point of purchase" (FCEA, § 4405(b)(2)(A)(ii)(II)). For FINI grants, NIFA defines "fruits and vegetables" as "any variety of fresh, canned, dried, or frozen whole or cut fruits and vegetables without added sugars, fats, or oils, and salt (i.e. sodium)." The program will test strategies that could contribute to our understanding of how best to increase the purchase of fruits and vegetables by Supplemental Nutrition Assistance Program (SNAP) participants to inform future efforts, and develop effective and efficient benefit redemption technologies. The Act requires the Secretary to conduct an independent evaluation of funded projects, to measure the impact of projects on: "improving the nutrition and health status of participating households receiving incentives" and "increasing fruit and vegetable purchases in participating households." Incentivizing purchases of fruits and vegetables increases their affordability and consumption. For example, USDA recently completed an evaluation of the Healthy Incentives Pilot (HIP), which investigated the impact of making fruits and vegetables more affordable to SNAP participants. Under HIP, SNAP households received 30

cents on every SNAP dollar they spent on targeted fruits and vegetables at participating SNAP-authorized retailers including large supermarkets, grocery stores and farmers markets. This pilot operated in Hampden County MA between November 2011 and December 2012. A rigorous evaluation showed that HIP significantly increased the consumption of targeted fruits and vegetables and this increased consumption was on the order of about one quarter of a cup per day. All FINI projects must (1) have the support of the State agency responsible for the administration of SNAP; (2) increase the purchase of fruits and vegetables by low-income consumers participating in SNAP by providing incentives at the point of purchase; (3) operate through authorized SNAP retailers, and in compliance with all relevant SNAP regulations and operating requirements; (4) agree to participate in the FINI comprehensive program evaluation; (5) ensure that the same terms and conditions apply to purchases made by individuals with SNAP benefits and with incentives under the FINI grants program as apply to purchases made by individuals who are not members of households receiving benefits as provided in 7 C.F.R. 278.2(b); and (6) include effective and efficient technologies for benefit redemption systems that may be replicated in other States and communities.

Eligible Applicants: Eligibility to receive this grant is limited to government agencies and non-profit organizations (FCEA, § 4405(b)(2)(A)). Eligible government agencies and non-profit organizations may include: an emergency feeding organization; an agricultural cooperative; a producer network or association; a community health organization; a public benefit corporation; an economic development corporation; a farmers' market; a community-supported agriculture program; a buying club; a SNAP-authorized retailer; and a State, local, or tribal agency. All applicants must demonstrate in their application that they are a government agency or non-profit organization.

Tony Hawke Foundation Skatepark Grant Program

Deadline: Open/Rolling

The primary mission of the Tony Hawk Foundation is to promote high quality, public skateparks in low-income areas throughout the United States. While we realize that not every area can afford to build big, expensive skateparks, we feel strongly that public skateparks should be designed and constructed by experienced contractors. We also believe that local officials should treat public skateparks the same way they treat public basketball courts or tennis courts, meaning that anyone may show up and use them anytime, unsupervised. The foundation primarily considers skatepark projects that: are designed and built from concrete by qualified and experienced skatepark contractors. include local skaters throughout the planning, fundraising, and design process. are in low-income areas and/or areas with a high population of "at-risk" youth. can demonstrate a strong grassroots commitment to the project, particularly in the form of fundraising by local skateboarders and other community groups. have a creative mix of street obstacles (rails, ledges, stairs, etc.) and transition/vert terrain (quarterpipes, bowls, halfpipes, etc.) don't require skaters or their parents to sign waivers. encourage skaters to look after their own safety and the safety of others without restricting their access to the park or over-regulating their use of it. are open during daylight hours, 365 days a year. don't charge an entrance fee.

are in areas that currently have no skateboarding facilities.

If your proposed skatepark is not located in a low-income area, if you are not able to illustrate strong community and grassroots support for the project, and if your project does not meet the criteria listed above, you are unlikely to receive a significant grant from our foundation. All Tony Hawk Foundation Grant Applicants will receive a detailed review of their projects and skatepark designs, whether a grant is awarded or not. BoatUS Foundation Accepting Grant Applications for Safe and Clean Boating Projects

The BoatUS Foundation for Boating Safety and Clean Water is accepting applications to its Grassroots Grants Program, which annually awards funds to nonprofit organizations, boating clubs, and student groups in the United States that provide education about safe and clean boating. The foundation is looking for creative projects that promote safe and clean boating on local waterways. Past topics have ranged from PSAs on the effects of boating under the influence to hands-on education about the effects of marine debris. Projects the foundation is most interested in funding will be unique (topic, methods, or delivery mechanism); include extensive outreach to boaters; use technology to educate boaters, including social media and the Web; have a widespread reach (not just a handful of boaters); include hands-on work with the boating community; and have a way to measure the success of the program. Applicants can include boating groups, clubs and associations, student groups, and local nonprofit organizations, including local chapters of national organizations. Grants will not be awarded to government agencies, international organizations, for-profit businesses, or individuals. Applicants may request up to

\$10,000. Funded projects must be completed within a year. After review by foundation staff, the top-ranked applications will be posted for public voting on the BoatUS Foundation website. Grant applicants will have several weeks to promote their project and encourage others to vote.
