## CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES FEMA GRANT AWARDED TO SCHERTZ FIRE DEPARTMENT

Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced a grant of \$31,041 was awarded to the Schertz Fire Department by FEMA under the U.S. Department of Homeland Security through the Assistance to Firefighter's Grant (AFG).

Schertz Fire Chief David A. Covington submitted the grant proposal that would provide funding for equipment to increase firefighters ability to safely provide service to the traveling public and freight haulers along interstates and state highways.

The grant would replace worn and broken equipment hydraulic rescue tools. It will add equipment that the Schertz Fire Department had not had before such as cribbing, shoring, cutting saw, warning signs, extrication PPE, and upgrade equipment that does not meet the most current safety standard traffic vests.

"I commend and congratulate Chief Covington for all that he and his fellow firefighters do every day and every night to provide essential services to the residents of Schertz," said U.S. Rep. Hinojosa. "Federal grants such as the AFG provide a significant boost to the budgets of fire departments and EMS services across our great country."

The AFG Program award grants directly to fire departments and Emergency Medical Services organizations (EMS) that are unaffiliated with a hospital.

## **CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES OVER \$6 MILLION IN FEMA FUNDING TO BUILD 4 STORM/COMMUNITY CENTERS IN CITY OF PHARR**

(Funding for these projects and others in Texas are associated with Hurricane Ike)

Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced the U.S. Department of Homeland Security's of Texas for the aftermath of hurricane lke in 2008. Hurri-Federal Emergency Management Agency (FEMA) has granted \$6,412,500,000 to the City of Pharr in partnership with Hidalgo County for the construction of 4 hurricane/ tornado safe room shelters that will also serve as community centers.

This federal funding is a result of funds provided to the state cane lke is recorded as the costliest hurricane in Texas history, and the second costliest hurricane in the United States, surpassed only by hurricane Katrina of 2005.

"The Rio Grande Valley is no stranger to the damage hurricanes can and have caused to property and lives and this is why the funding from FEMA is not only greatly appreciated it is much needed for our increasing population in the Pharr area," said U.S. Representative Hinojosa. "The new shelters will be able to facilitate our residents who have special needs and will be equipped to also handle those with medical special needs so that families can stay together. The construction of the new structures will also create local jobs during the duration of the projects."

The 4 domed structures will serve residents with special needs and medical special needs in times of severe storms. The shelter locations and federal funding amounts are as follows:

\$1,800,000.00 - 920 S Fir Street Pharr, TX \$1,800,000.00 - 400 W. El Dora street Pharr, TX \$1,800,000.00 - 1011 W. Kelley Ave Pharr, TX \$1,012,500.00 - 1201 W. Rosa Ln Pharr, TX

The structures will be built of concrete and will be multipurpose serving centers that can be used yearly as community centers. Total project cost for each shelter is estimated at \$1.350.000 -\$2.400.000.

NAMM Foundation Announces Wanna Play Fund Grants for Instruments Available to Schools and Community Organizations for Music Education Programs

#### **Challenge Grants**

National Endowment for the Humanities (NEH)

Deadline: 05/01/2013

NEH challenge grants are capacity-building grants, intended to help institutions and organizations secure long-term improvements in and support for their humanities programs and resources. Through these awards, many organizations and institutions have been able to increase their humanities capacity and secure the permanent support of an endowment. Grants may be used to establish or enhance endowments or spend-down funds that generate expendable earnings to support and enhance ongoing program activities. Challenge grants may also provide capital directly supporting the procurement of long-lasting objects, such as acquisitions for archives and collections, the purchase of equipment, and the construction or renovation of facilities needed for humanities activities. Funds spent directly must be shown to bring long-term benefits to the institution and to the humanities more broadly. Grantee institutions may also expend up to 10 percent of total grant funds (federal funds plus matching funds) to defray costs of fundraising to meet the NEH challenge. Because of the matching requirement, these NEH grants also strengthen the humanities by encouraging nonfederal sources of support.

Maximum Grant Size: \$500,000

Eligible Applicants: With the exception of elementary and secondary schools (public or private) and school districts, any U.S. nonprofit institution (public agency, private nonprofit organization, federally recognized Indian tribal government) working wholly or in part with the humanities may apply for a challenge grant. Affiliated institutions (for example, a university museum) should consult with NEH staff on questions of separate eligibility. Institutions that support research, education, preservation, and public programming in humanities disciplines are eligible to apply for an NEH challenge grant.

#### Preservation and Access Education and Training Grants

National Endowment for the Humanities (NEH)

Deadline: 05/10/2013

The Preservation and Access Education and Training program is central to NEH's efforts to preserve and establish access to cultural heritage collections. Thousands of libraries, archives, museums, and historical organizations across the country maintain important collections of books and manuscripts, photographs, sound recordings and moving images, archaeological and ethnographic artifacts, art and material culture collections, electronic records, and digital objects. The challenge of preserving and making accessible such large and diverse holdings is enormous, and the need for knowledgeable staff is significant and ongoing.

Preservation and Access Education and Training grants are awarded to organizations that offer national or regional (multistate) education and training programs. Grants aim to help the staff of cultural institutions, large and small, obtain the knowledge and skills needed to serve as effective stewards of humanities collections. Grants also support educational programs that prepare the next generation of conservators and preservation professionals, as well as projects that introduce the staff of cultural institutions to new information and advances in preservation and access practices.

Preservation and Access Education and Training grants support activities such as these:

preservation field services that provide a wide range of education and training programs (for example, surveys, workshops, consultations, reference services, and preparation of informational materials about the care of humanities collections), especially for staff at smaller libraries, museums, archives, and other cultural organizations;

master's degree programs in preservation and conservation; and

workshops that address preservation and access topics of national significance and broad impact, such as:

o preventive conservation and sustainable preservation strategies;

o the preservation of and provision of access to recorded sound and moving image collections;

o digital preservation;

o collections care training for staff members who are responsible for the day-to-day care and management of humanities collections;

o disaster preparedness, response, and recovery; and

o best practices for enhancing and integrating access to collections in libraries, archives, and museums.

Eligible Applicants: Any U.S. nonprofit organization with IRS tax-exempt status is eligible, as are state and local governmental agencies and federally recognized Indian tribal governments. Individuals are not eligible to apply.

The Open Society Foundations' Audience Engagement Grant program is designed to support photographers in taking an existing body of work on a social justice or human rights issue and devising an innovative and effective way of using that work as a tool for social change. The program seeks proposals for projects that will serve as interventions on pressing problems and provide concrete ways for photographers, organizations, and their target audiences to create a positive impact. To be eligible, partnerships should include a photographer or curator/project organizer whose expertise is in the production or presentation of documentary photography, and an audience engagement partner(s) with expertise in a specific issue and existing connections to the target audience. Partnerships may also include a distribution partner with expertise in the dissemination or presentation method. Choice Neighborhoods will ensure that current public and assisted housing residents will be able to benefit from this transformation, by preserving affordable housing or providing residents with the choice to move to affordable and accessible housing in

another existing neighborhood of opportunity. Choice Neighborhoods is focused on three core goals:

Housing: Replace distressed public and assisted housing with high-quality mixed-income housing that is well-managed and responsive to the needs of the surrounding neighborhood; People: Improve educational outcomes and intergenerational mobility for youth and supports delivered directly to youth and their families; and Neighborhood: Create the conditions necessary for public and private reinvestment in distressed neighborhoods to offer the kinds of amenities and assets, including safety, good schools, and commercial activity, that are important to families' choices about their community.

US Department of Justice (DOJ), Office on Violence Against Women (OVW)

Deadline: 05/14/2013

The Office on Violence Against Women (OVW) is a component of the United States Department of Justice (DOJ). Created in 1995, OVW implements the Violence Against Women Act (VAWA) and subsequent legislation and provides national leadership on issues of sexual assault, domestic violence, dating violence, and stalking. Since its inception, OVW has supported a multifaceted approach to responding to these crimes through implementation of grant programs authorized by VAWA. By forging state, local and tribal partnerships among police, prosecutors, judges, victim advocates, health care providers, faith leaders, and others, OVW grants help provide victims with the protection and services they need to pursue safe and healthy lives, while improving communities' capacity to hold offenders accountable for their crimes.

The primary purpose of the OVW Technical Assistance Program is to provide direct technical assistance to existing and potential grantees and sub grantees to enhance and support their efforts to successfully implement projects supported by OVW grant funds. In addition, OVW is focused on building the capacity of criminal justice and victim services organizations to respond effectively to sexual assault, domestic violence, dating violence and stalking and fostering partnerships among organizations that have not traditionally worked together to address violence against women.

#### **Face Forward Serving Juvenile Offenders Grants**

U.S. Department of Labor (DOL), Employment and Training Administration (ETA)

Deadline: 05/10/2013

The U.S. Department of Labor (we, the Department or DOL), Employment and Training Administration (ETA), announces the availability of approximately \$26,000,000 in grant funds to award approximately 26 Face Forward grants. "Face Forward" conveys the idea of youth leaving their past transgressions behind and looking forward towards a promising future. Through diversion and/or record expungement strategies, these grants will give youth a chance to succeed in the workplace and to avoid the stigma of a juvenile record. Diversion and expungement strategies are part of the Juvenile Justice system. These functions, operations and processes are under their jurisdiction. However, in order to provide the best possible outcomes for these youth, it is imperative to provide these additional supportive services. Diversion is "an attempt to divert, or channel out, youthful offenders from the juvenile justice system" (Bynum and Thompson, 1996). Expungement focuses on having juvenile records expunged, or eliminated. The purpose of these grants is to improve the long-term labor market prospects of both court involved youth prior to adjudication and juvenile offenders. Grantees must utilize a strategy where they collaborate with non-profit legal services providers to assist participants with expungement actions, and/or be designated by the juvenile justice system as a diversion program.

Maximum Grant Size: \$1,000,000

Number of Grants: 26

Eligible Applicants: Any non-profit organization with IRS 501(c)(3) status, unit of state or local government, or any Indian and Native American entity eligible for grants under WIA Section 166, may apply for these grants to provide services to eligible participants (as defined in Section III.C.3.) in areas with high-poverty and high-crime rates.

#### Wildlife Without Borders: Critically Endangered Animals Conservation Fund

U.S. Department of the Interior (DOI), Fish and Wildlife Service (FWS)

Deadline: 05/01/2013

The Wildlife Without Borders - Critically Endangered Animals Conservation Fund will fund projects that conserve the world's most endangered species. Species eligible for funding are those that face a very high risk of extinction in the immediate future. Species should meet the criteria to be listed as "Critically Endangered" or "Endangered" on the International Union for the Conservation of Nature (IUCN) Red List. Species listed as "Data Deficient" on the IUCN Red List are also eligible if the applicant can provide information that suggests a similar urgency for conservation action. Species listed as "Extinct in Wild" are eligible if the applicant is proposing a reintroduction attempt.

The goal of this grants program is to reduce threats to highly endangered wildlife in their natural habitat. Proposals should identify specific conservation actions that have a high likelihood of creating durable benefits. Project activities that emphasize data collection and status assessment should describe a direct link to management action, and explain how lack of information has been a key limiting factor for management action in the past. Proposals that do not identify how actions will reduce threats, or do not demonstrate a strong link between data collection and management action, are not eligible for consideration.

Maximum Grant Size: \$25,000

Eligible Applicants: Applicants under this program can be: individuals; multi-national secretariats federal, state and local government agencies; non-profit, non-governmental organizations; and public and private institutions of higher education. U.S. non-profit, non-governmental organizations must submit documentary evidence of their Section 501(c) (3) non-profit status.

## ING Run for Something Better Offers Grants to Establish Youth Running Programs Deadline: 05/15/2013

With the goal of empowering school-age children nationwide to achieve and maintain a healthy lifestyle, the ING Community Fund, in partnership with the National Association for Sport and Physical Education, conducts the ING Run For Something Better initiative, a school-based running program designed to fight childhood obesity and improve the self-esteem, school performance, and overall well-being of children in grades K-8. The program uses activity plans created by NASPE and based on the National Standards for Physical Education to help children get off to a healthy start in life and spark an interest in exercise before obesity becomes a problem. The ING Run for Something Better program will provide a minimum of fifty grants of up to \$2,500 each for schools to establish a running program or expand an existing one. The first \$1,000 will be awarded to winning schools upon notification of the grant, while the second installment will be distributed upon conclusion of the program and evidence of a culminating running event, receipt of PACER data, and other required post-evaluation materials.

Awards are available for programs serving boys and girls in grades K-8. Schools must design an eight-week program that runs before, during-, and/or afterschool and that is offered (to the best of the school's ability) to all students in eligible grades at least twice a week, with a culminating event completed by December 31, 2013. In addition, the program must have a commitment of at least twenty-five students in grades 4 through 8 and must supply PACER data results to NASPE. Any school districts currently involved with ING Run for Something Better or that already participate in an ING U.S.-sponsored culminating event are not eligible to apply.
