Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced that the National Science Foundation awarded \$50,000 to the University of Texas-Pan American UT-PA researchers to determine if one of their scientific discoveries can be used to help burn victims heal.

UTPA researchers and scientists have developed a hand-held device that produces nonwoven nanofiber mats that were originally developed for wound dressings such as abrasions and lacerations as well as hemorrhage control. After more research the nanofiber mats were found to be very helpful in treating burns. The product is being described as "modernized gauze". "It is just fascinating to know of all of the innovative discoveries and inventions that are being made by researchers at UTPA," said U.S. Rep. Hinojosa. "If this new product is found to be marketable it will be able to help many civilians and servicemen and women in the Armed Forces who are suffering from burns."

The grant funding is to be used within a six month period in which students will learn how to move their product out of the laboratory and into the market. So far, they have introduced their idea to Shriners Hospital and Brooke Army Medical Center in San Antonio where burn victims are treated. While they are still working on a prototype Dr. Karen Lozano, who is the principal investigator says there is a lot of interest and therefore a lot of hope that the product will find success.





# **CENSUS BUREAU INTRODUCES NEW INTERACTIVE MAPPING TOOL**



The U.S. Census Bureau released <u>Census Explorer</u>, a new interactive mapping tool that gives users easier access to neighborhood level statistics. The mapping tool uses updated statistics from the 2008-2012 American Community Survey (ACS), which were also released recently.

The new application allows users to map out different social, economic and housing characteristics of their state, county or census tract, and to see how these areas have changed since the 1990 and 2000 censuses. The mapping tool is powered by American Community Survey statistics from the Census Bureau's API, an <u>application programming interface</u> that allows developers to take data sets and reuse them to create online and mobile apps.

"The American Community Survey data are critically important to powering our nation's 21st century economy," U.S. Secretary of Commerce Penny Pritzker said. "Making data more accessible and user-friendly for all Americans is a top priority of our 'Open for Business Agenda' at the Department of Commerce. The rich statistics in the 2008-2012 ACS will help more businesses, policymakers and communities make betterinformed decisions that will help propel U.S. economic growth."

"Census Explorer is another useful tool, like the dwellr and America's Economy mobile apps, that the Census Bureau has developed to disseminate statistics faster and make them easier to access," Census Bureau Director John H. Thompson added. "This interactive map helps users to learn more about the social, economic and housing characteristics of their communities — the same characteristics that drive decision-making from the local to the national level."

The tool allows users to look at the following eight statistics from the American Community Survey:

- Total population
- Percent 65 and older
- Foreign-born population percentage
- Percent of the population with a high school degree or higher
- Percent with a bachelor's degree or higher
- Labor force participation rate
- Home ownership rate
- Median household income

In addition to these characteristics, more than 40 <u>social</u>, <u>economic</u> and <u>housing</u> topics are now available through the American Community Survey statistics for all communities in the nation, regardless of size, down to the block group level. For example, health insurance coverage statistics are now available for the first time at the neighborhood level.

## Additional Exploration Tools

A variety of other Census Bureau data tools have been updated with today's new numbers, including the Census Bureau's <u>application pro-</u><u>gramming interface</u>, <u>Easy Stats</u> and <u>American FactFinder</u>. In addition to the updated exploration tools, the Census Bureau is releasing <u>narrative</u> <u>profiles</u> which allow users to explore a graphical and narrative presentation of the statistics from the American Community Survey.

## About the American Community Survey

The American Community Survey provides a wide range of important statistics about all communities in the country. The American Community Survey gives communities the current information they need to plan investments and services. Retailers, homebuilders, police departments, and town and city planners are among the many private- and public-sector decision makers who count on these annual results. Ever since Thomas Jefferson directed the first census in 1790, the census has collected detailed characteristics about our nation's people.

The Census Bureau uses information collected over five years from the American Community Survey in order to have more accurate and reliable statistics for areas with populations smaller than 20,000. Statistics for larger areas are also included with this release, making comparisons across large and small geographies possible.

The Census Bureau is currently reviewing all of the questions on the American Community Survey to ensure adequate coverage of statistical information that communities rely on. The survey is the only source of local statistics for most of the 40 topics it covers, such as educational attainment, housing, employment, commuting, language spoken at home, nativity, ancestry and selected monthly homeowner costs down to the smallest communities. The Census Bureau is inviting the public to give feedback on each question asked in the survey. ## TREASURY, IRS WILL ISSUE PROPOSED GUIDANCE FOR TAX-EXEMPT SOCIAL WELFARE ORGANIZATIONS

WASHINGTON — The U.S. Department of the Treasury and the Internal Revenue Service has issued initial guidance regarding qualification requirements for tax-exemption as a social welfare organization under section 501 (c)(4) of the Internal Revenue Code. This proposed guidance defines the term "candidate-related political activity," and would amend current regulations by indicating that the promotion of social welfare does not include this type of activity. The proposed guidance also seeks initial comments on other aspects of the qualification requirements, including what proportion of a 501(c)(4) organization's activities must promote social welfare.

There are a number of steps in the regulatory process that must be taken before any final guidance can be issued. Given the significant public interest in these and related issues, Treasury and the IRS expect to receive a large number of comments. Treasury and the IRS are committed to carefully and comprehensively considering all of the comments received before issuing additional proposed guidance or final rules.

"This is part of ongoing efforts within the IRS that are improving our work in the tax-exempt area," said IRS Acting Commissioner Danny Werfel. "Once final, this proposed guidance will continue moving us forward and provide clarity for this important segment of exempt organizations."

"This proposed guidance is a first critical step toward creating clear-cut definitions of political activity by tax-exempt social welfare organizations," said Treasury Assistant Secretary for Tax Policy Mark J. Mazur. "We are committed to getting this right before issuing final guidance that may affect a broad group of organizations. It will take time to work through the regulatory process and carefully consider all public feedback as we strive to ensure that the standards for tax-exemption are clear and can be applied consistently."

Organizations may apply for tax-exempt status under section 501(c)(4) of the tax code if they operate to promote social welfare. The IRS currently applies a "facts and circumstances" test to determine whether an organization is engaged in political campaign activities that do not promote social welfare. Today's proposed guidance would reduce the need to conduct fact-intensive inquiries by replacing this test with more definitive rules.

In defining the new term, "candidate-related political activity," Treasury and the IRS drew upon existing definitions of political activity under federal and state campaign finance laws, other IRS provisions, as well as suggestions made in unsolicited public comments.

# Under the proposed guidelines, candidate-related political activity includes:

1. Communications

Communications that expressly advocate for a clearly identified political candidate or candidates of a political party.

Communications that are made within 60 days of a general election (or within 30

days of a primary election) and clearly identify a candidate or political party.

Communications expenditures that must be reported to the Federal Election Commission.

#### Grants and Contributions

Any contribution that is recognized under campaign finance law as a reportable contribution.

Grants to section 527 political organizations and other tax-exempt organizations that conduct candidate-related political activities (note that a grantor can rely on a written certification from a grantee stating that it does not engage in, and will not use grant funds for, candidaterelated political activity).

#### Activities Closely Related to Elections or Candidates

Voter registration drives and "get-out-thevote" drives.

Distribution of any material prepared by or on behalf of a candidate or by a section 527 political organization.

Preparation or distribution of voter guides that refer to candidates (or, in a general election, to political parties).

Holding an event within 60 days of a general election (or within 30 days of a primary election) at which a candidate appears as part of the program.

These proposed rules reduce the need to conduct fact-intensive inquiries, including inquiries into whether activities or communications are neutral and unbiased.

Treasury and the IRS are planning to issue additional guidance that will address other issues relating to the standards for tax exemption under section 501(c)(4). In particular, there has been considerable public focus regarding the proportion of a section 501(c)(4) organization's activities that must promote social welfare. Due to the importance of this aspect of the regulation, the proposed guidance requests initial comments on this issue.

The proposed guidance also seeks comments regarding whether standards similar to those proposed today should be adopted to define the political activities that do not further the tax-exempt purposes of other tax-exempt organizations and to promote consistent definitions across the tax-exempt sector.

#### **Deadline: Open/Rolling**

The nonprofit NAMM Foundation works to advance active, lifelong participation in music making by supporting scientific research, philanthropic giving, and public service programs of the international music products industry. The organization has announced the availability of grants through its Wanna Play Fund to provide instruments to schools and community organizations that are expanding or reinstating music education programs as part of a core curriculum and/or that employ quality music teachers. Eligible applicants are public schools serving low-income students (percentage of free and reduced lunch data required); community organizations serving low-income students with special needs (community demographic information required); and schools and community programs that have made a commitment to hiring and retaining high-quality music teachers and providing standards-based, sequential learning in music. Online grant applications will be reviewed on a rolling basis. Applicants will be notified within thirty days of submission whether or not a grant will be awarded. #### National Association of Latino Arts and Cultures Invites Grant Applications from Latino Artists and Arts Organizations

#### Deadline: 02/16/2014

Launched in 2005 by the National Association of Latino Arts and Cultures, the NALAC Fund for the Arts provides a variety of grants to Latino artists and arts organizations in the United States for the development, creation, presentation, and sustainability of artistic excellence, as well as the opportunity to participate in activities that contribute to their professional and organizational growth. The fund supports Latino working artists, ensembles, and Latino arts organizations that demonstrate artistic excellence in pursuit of social justice through the arts. To date, NFA has awarded over \$1 million to a diverse range of artists and organizations representing every discipline and region of the country. NFA Grants for Latino Artists and Ensembles support the work of individual artists and ensembles in all disciplines. The NFA offers two grant categories for artists and ensembles, including Artist/Ensemble Project grants and Master Artist grants. These grants are open to Latino artists and ensembles in the United States.

1) NFA Artist/Ensemble Project Grant: Designed to recognize excellence in an artist's body of work and nurture the creative and professional development of the artist, this grant supports individuals whose work demonstrates excellence and the potential for impacting the Latino arts field. Funds may be used to support the creation, development, and/or presentation of work; equipment purchases necessary for artistic production; research and travel; professional and career development; living and studio expenses; technical support, studio assistance, and collaborations; and documentation, production expenses, and maintenance. Up to fourteen project grants of \$5,000 each will be awarded during this grant cycle.

2) NFA Master Artist Grant: This grant recognizes established Latino artists for their cultural contributions and significance in their communities and also provides support that enables the master artist to serve as a professional and artistic mentor to another artist. The Master Artist grant will be awarded in support of an exemplary mentor-mentee project that enables knowledge and skill transfer between a master artist and a mentee artist. Up to three \$15,000 Master Artist grants will be awarded during this grant cycle. In addition, NALAC's NFA Grants for Latino Arts Organizations support the work of arts organizations whose primary focus is Latino arts and culture in any arts discipline. NFA offers two grant categories for organizations, including Project grants and

General Operating Support grants. These grants are open to Latino arts organizations in the United States.

1) NFA Organization Project Grant: These grants are designed to assist organizations in their efforts to provide quality arts programming. Project grant funds may be used to support the creation, development, and presentation of an artistic work or festival; equipment and material purchases necessary for artistic production; research and travel; and marketing, production, and documenting expenses.

2) NFA General Operating Support Grant: GOS grants help arts organizations cover expenses related to strengthening the organization's infrastructure and ability to fulfill its mission. Funds may be used to support several activities, including capacity-building initiatives, strategic planning, investment in technical capacity, and staff development.

Up to eight \$5,000 grants will be awarded to small organizations with operating budgets under \$249,999 and up to four \$10,000 grants will be awarded to larger organizations with operating budgets above \$250,000. Funded projects may take place between September 1 and August 31, 2015. To be eligible, applicants must be NALAC members at the individual or organization level.

#### Arts Midwest Invites Proposals for 2014-2015 Shakespeare in American Communities Program

#### Deadline: 03/12/2014

Shakespeare in American Communities, a national theater program of the National Endowment for the Arts in cooperation with Arts Midwest, brings performances and educational activities to audiences across the country. The program reaches middle- and high-school students in underserved schools throughout the United States with high-quality, professional productions of Shakespeare's plays.

Arts Midwest invites proposals from nonprofit theater companies to perform works by Shakespeare for middle- and high-school students between August 1, 2014 and July 31, 2015. Grants will be awarded to up to forty theater companies to support performances and related educational activities for students from a minimum of ten schools. Applicant review will be based on artistic excellence and merit. The standard grant award is \$25,000. Grants must be matched one to one.

Applicants must be a nonprofit, tax-exempt 501(c)(3) organization or unit of state or local government; be a U.S.-based theater company that compensates all professional performers and related or supporting professional personnel at no less than the prevailing minimum compensation; have produced Shake-speare or classically-based repertoire within the past five years; and have a minimum of three years' experience providing performances and educational activities to middle and/or high schools.

#### Value-Added Producer Grants

Rural Business-Cooperative Service (RBS), U.S. Department of Agriculture (USDA)

### Deadline: 02/24/2014

USDA announces the availability of competitive grant funding through the Value-Added Producer Grant (VAPG) program. Approximately \$10.5 million in carry over funding from fiscal year (FY) 2013 is available to help agricultural producers enter into value-added activities. This NOFA is being published prior to the Congressional enactment of a full-year appropriation for FY 2014. Should additional funding be made available during FY 2014 for this program RBS will continue to fund applications received under this announcement based upon the applications score. At this time, the exact amount of funding that will be made available to this program for FY 2014 is unknown. The program purpose is to help U.S. agricultural producers enter into value-added activities. Awards may be made for either economic planning or working capital activities related to the processing and/or marketing of valued-added agricultural products. The maximum grant amount for a planning grant is \$75,000 and the maximum grant amount for a working capital grant is \$200,000.

Eligible Applicants: Independent producer, agricultural producer group, farmer or rancher cooperative, or majority-controlled producer-based business venture.

Brownfields Cleanup Grants - provides funds to carry out cleanup activities at a specific brownfield site owned by the applicant.

Eligible Applicants: •General Purpose Unit of Local Government. (For purposes of the brownfields grant program, EPA defines general purpose unit of local government as a "local government" as defined under 40 CFR Part 31.)

The Robert Wood Johnson Foundation's New Careers in Nursing initiative aims to alleviate the nursing shortage in the United States and increase the diversity of nursing professionals. The program has a two-fold purpose: to increase the numbers of nurses, and to address diversity among nursing professionals. The primary mission of the Tony Hawk Foundation is to promote high quality, public skateparks in low-income areas throughout the United States. While we realize that not every area can afford to build big, expensive skateparks, we feel strongly that public skateparks should be designed and constructed by experienced contractors. We also believe that local officials should treat public skateparks the same way they treat public basketball courts or tennis courts, meaning that anyone may show up and use them anytime, unsupervised. The foundation primarily considers skatepark projects that: are designed and built from concrete by qualified and experienced skatepark contractors. include local skaters throughout the planning, fundraising, and design process. are in low-income areas and/or areas with a high population of "at-risk" youth. can demonstrate a strong grassroots commitment to the project, particularly in the form of fundraising by local skateboarders and other community groups. have a creative mix of street obstacles (rails, ledges, stairs, etc.) and transition/vert terrain (quarterpipes, bowls, halfpipes, etc.) don't require skaters or their parents to sign waivers. encourage skaters to look after their own safety and the safety of others without restricting their access to the park or over-regulating their use of it. are open during daylight hours, 365 days a year. don't charge an entrance fee.

are in areas that currently have no skateboarding facilities.

If your proposed skatepark is not located in a low-income area, if you are not able to illustrate strong community and grassroots support for the project, and if your project does not meet the criteria listed above, you are unlikely to receive a significant grant from our foundation. All Tony Hawk Foundation Grant Applicants will receive a detailed review of their projects and skatepark designs, whether a grant is awarded or not.
