CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES \$224,322 GRANT FOR PETTUS-TULETA VOLUNTEER FIRE DEPARTMENT

Congressman Rubén Hinojosa (TX-15) announced a grant for \$224,322 was awarded to the Pettus-Tuleta Volunteer Fire Department for a new communications system by the Department of Homeland Security (DHS) and FEMA. The Assistance to Firefighters Grant (AFG) will provide the new communication system that will keep all 5 volunteer fire departments in Bee County on the same frequency for instant communication.


"I want to congratulate Assistant Fire Chief Clifford Bagwell and all of the brave volunteer firefighters for their efforts in securing this very important grant award," said U.S. Rep. Hinojosa. "The residents of Bee County will now be provided with this Operations and Safety grant which will assist the volunteer fire departments in keeping residents and their properties safe."

The AFG will award approximately \$380 million in competitive grants to fire departments and non affiliated EMS organizations. The Pettus-Tuleta Volunteer Fire Department was one of 16,496 applicants. Only 6 other Fire Departments in Texas received AFG's this year.











CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES OVER \$4 MILLION IN HUD GRANTS

U.S. Rep. Rubén Hinojosa (TX-15) announced the U.S. Department of Housing and Urban Development has awarded a total of \$4,729,642.00 to Public Housing Agencies in his Congressional Texas District 15.

The funding comes from the 2012 Capital Fund Program Award. The program provides funds annually to Public House Agencies (PHA's) for capital and management activities, including modernization and development of public housing.

"We continue to support the ongoing process of the upgrading and maintaining of our public housing", said Rep. Hinojosa. "As our population grows and our economy strengthens, our residents will continue to benefit from federal grants that help provide needed housing. The directors and employees who manage the public housing agencies work every day assisting our residents in obtaining public housing and I am very happy to see they are receiving funds to help them continue their hard work in our communities".

CONGRESSMAN HINOJOSA ANNOUNCES A GRANT OF MORE THAN HALF A MILLION DOLLARS FOR STEM SCHOLARSHIPS

Congressman Rubén Hinojosa (TX-15) announced that the **University of Texas-Pan American** (UTPA) was awarded a grant for **\$597,640** by the National Science Foundation (NSF) to provide 20 four-year scholarships and 12 three-year scholarships in Science, Technology, Engineering and Mathematics (STEM) fields of computer engineering, computer science, civil engineering, and mechanical engineering at UTPA.

"This grant will have a direct and positive impact on STEM students who attend UTPA," said U.S. Rep. Hinojosa. "This project will serve as a model for other Hispanic Serving Institutions (HSI's) like UTPA, and other minority serving institutions including African Americans, Native Americans and women in the STEM fields."

The project entitled "A Focused Student Recruitment and Support Model for Attracting Top Achieving Scholars," is under the direction of Arturo Fuentes. It will be used to assist students who are academically talented and students who have financial needs. The goals of the project are to improve educational opportunities for students by combining student preparation with mentoring, tutoring, and research opportunities.

"Striving for educational excellence and providing our students the best opportunities in achieving their goals is our goal," said U.S. Rep. Hinojosa. "We are all working to cultivate more Hispanic engineers by increasing our retention rate of students in helping them earn their college degrees."

The grant is geared to fostering students' growth and interest in their fields of study.



CONGRESSMAN HINOJOSA ANNOUNCES NEARLY \$2 MILLION DOLLAR GRANT FOR THE CITY OF MCALLEN/MCALLEN TRANSIT

Congressman Rubén Hinojosa (TX-15) announced the U.S. Department of Transportation has awarded the City of McAllen/McAllen Express Transit **\$1,905,908** in grant funds for electric buses.

"We continue to support the ongoing process of creating cleaner and more efficient methods for public transportation," said U.S. Rep. Hinojosa. "As our population grows it is increasingly important for all of us to do our part in using green energy. Effective electric roadways are an innovative way to do so, to help our communities and our residents thrive."

The funding comes from the Transit Investments for Greenhouse Gas and Energy Reduction Program (TIGGER).

McAllen Transit will use On Line Electric Vehicle (OLEV) technology to run the electric buses. Three electric buses will be retrofitted to run on electric power with en-route charging technology.



CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES NEARLY ONE MILLION DOLLAR FEDERAL INVESTMENT FOR THE MCALLEN-HIDALGO INTERNATIONAL BRIDGE

Congressman Rubén Hinojosa announced a grant for \$950,000 was awarded to the City of McAllen by the U.S. Department of Commerce Economic Development Administration (EDA) for construction and infrastructure improvements to support commerce at the McAllen-Hidalgo International Bridge.

"These federal investments that are geared to increase trade along our border are very important and very much welcomed" said U.S. Rep. Hinojosa. "Our international bridges serve many purposes including providing an easier means of trade between the U.S. and Mexico. Those of us who live on the border know very well how much our local economy can thrive when trade is allowed to flow."

The EDA investment will fund infrastructure improvements to the McAllen-Hidalgo International Bridge specifically expanding the crossing area of the bridge. The project's goal is to support increased trade and cross-border commerce by facilitating the flow of products through the border



CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES LOAN/GRANT AWARD FOR Almost \$200 Thousand for the expansion and improvements to the Chisolm trail heritage museum

Congressman Rubén Hinojosa announced a grant of \$45,000 and a loan of \$152,000 was awarded by the United States Department of Agriculture (USDA) Rural Development to the Chisholm Trail Heritage Museum, Inc. in Cuero, Texas. The Rural Development funds will be used to improve the parking lot and sidewalks to meet handicap accessible requirements for a public building.

"Over the years USDA Rural Development has made significant improvements to our rural communities through their funding support", said U.S. Rep. Hinojosa. "For many years I, along with my staff, have worked closely with Robert Oli-

ver and others who have been dedicated to the preservation and expansion of this important museum. Congratulations to the leaders and all of the members of the community who helped to make this a successful project."

Other improvements include an educational green space for a multitude of cultural purposes for children and adults to be located behind the historic building. The facility serves a population of 6,571.

The Agricultural Marketing Service (AMS) announces the availability of approximately \$10 million in competitive grant funds for fiscal year (FY) 2012 to increase domestic consumption of agricultural commodities by expanding direct producer-to-consumer market opportunities. Examples of direct producer -to-consumer market opportunities include new farmers markets, roadside stands, community- supported agriculture (CSA) programs, agri-tourism activities, and other direct producer-to-consumer infrastructures. AMS hereby requests proposals from eligible entities within the following categories: Agricultural cooperatives, producer networks, producer associations, local governments, nonprofit corporations, public benefit corporations, economic development corporations, regional farmers market authorities, and Tribal governments. Challenge Grants

National Endowment of the Humanities (NEH)

Deadline: 05/02/2012

NEH challenge grants are capacity-building grants, intended to help institutions and organizations secure long-term improvements in and support for their humanities programs and resources. Through these awards, many organizations and institutions have been able to increase their humanities capacity and secure the permanent support of an endowment. Grants may be used to establish or enhance endowments or spend-down funds that generate expendable earnings to support ongoing program activities. Challenge grants may also provide capital directly supporting the procurement of long-lasting objects, such as acquisitions for archives and collections, the purchase of equipment, and the construction or renovation of facilities needed for humanities activities. Funds spent directly must be shown to bring long-term benefits to the institution and to the humanities more broadly. Grantee institutions may also expend up to 10 percent of grant funds to defray costs of fundraising to meet the NEH challenge. Because of the matching requirement, these NEH grants also strengthen the humanities by encouraging nonfederal sources of support. Applications are welcome from colleges and universities, museums, public libraries, research institutions, historical societies and historic sites, scholarly associations, state humanities councils, and other nonprofit entities. Programs that involve collaboration among multiple institutions are eligible as well, but one institution must serve as the lead agent and formal applicant of record.

Maximum Grant Award: \$500,000

Eligible Applicants: With the exception of elementary and secondary schools (public or private) and school districts, any U.S. nonprofit institution (public agency, private nonprofit organization, federally recognized Indian tribal government) working wholly or in part with the humanities may apply for a challenge grant. Affiliated institutions (for example, a university museum) should consult with NEH staff on questions of separate eligibility. Institutions that support research, education, preservation, and public programming in humanities disciplines are eligible to apply for an NEH challenge grant. NEH generally does not award grants to other federal entities or to applicants whose projects are so closely intertwined with a federal entity that the project takes on characteristics of the federal entities in their projects. Institutions may apply for only one NEH challenge grant in a calendar year. An institution is eligible to apply for a subsequent challenge grant beginning in the third year after the closing date of its most recent NEH challenge grant. For example, if a grant closed in 2011, the institution that received the grant could not apply for a subsequent challenge grant until 2014.

Humanities Initiatives at Hispanic-Serving Institutions

National Endowment of the Humanities (NEH)

NEH Humanities Initiatives are intended to strengthen and enrich humanities education and scholarship at Hispanic-Serving Institutions. These grants may be used to enhance the humanities content of existing programs, develop new programs, or lay the foundation for more extensive endeavors in the future.

NEH Humanities Initiatives may: create opportunities for faculty members to study together while improving their capacity to teach the humanities; help faculty members and administrators develop new humanities programs, which may include but are not limited to academic writing programs, foreign language programs, new humanities minors, first-year seminars, capstone courses, or summer bridge programs for at-risk high school students; help institutions take advantage of humanities resources, especially in the digital humanities; enhance or develop areas of basic need in an institution's core humanities programs; or build ties among faculty at more than one institution of higher learning; among college teachers, secondary school teachers, and students; or among faculty members at institutions of higher learning and their colleagues in museums, libraries, or other organizations such as historical and cultural societies.

Eligible Applicants: This program accepts applications from Hispanic-Serving Institutions. Any U.S. nonprofit 501(c)(3) tax-exempt college or university that is a Hispanic-Serving Institution is eligible to apply.

Preservation and Access Education and Training Grants

National Endowment of the Humanities (NEH)

The Preservation and Access Education and Training program is central to NEH's efforts to preserve and establish access to cultural heritage collections. Thousands of libraries, archives, museums, and historical organizations across the country maintain important collections of books and manuscripts, photographs, sound recordings and moving images, archaeological and ethnographic artifacts, art and material culture collections, electronic records, and digital objects. The challenge of preserving and making accessible such large and diverse holdings is enormous and the need for knowledgeable staff is significant and ongoing.

Preservation and Access Education and Training grants support national or regional (multistate) education and training programs. Grants aim to help the staff of cultural institutions, large and small, obtain the knowledge and skills needed to serve as effective stewards of humanities collections. Grants also support educational programs that prepare the next generation of conservators and preservation professionals, as well as projects that introduce the staff of cultural institutions to new information and advances in preservation and access practices.

Maximum Grant Size: \$175,000

Eligible Applicants: Any U.S. nonprofit organization is eligible, as are state and local governmental agencies and federally recognized Indian tribal governments. Individuals are not eligible to apply.

The Office of Citizenship (OoC), within U.S. Citizenship and Immigration Services (USCIS), Department of Homeland Security (DHS), is charged with promoting the rights and responsibilities of citizenship. Naturalization is not only a benefit in itself, but also a mechanism to foster immigrant integration. Naturalization provides civic and economic opportunities for new citizens, and strengthens our communities and nation as a whole. Through preparing for naturalization, applicants will gain the tools to become successful citizens – ready to exercise their rights and meet their responsibilities as United States citizens. The goal of the grant program is to expand the availability of quality citizenship preparation services for permanent residents in communities across the nation. Activities that support this goal include making citizenship instruction and naturalization application services accessible to low income and other underserved permanent resident populations; developing, identifying, and sharing promising practices in citizenship preparation; supporting innovative and creative solutions to barriers faced by those seeking naturalization; increasing the use of and access to technology in citizenship preparation programs; and engaging receiving communities in the citizenship and civic integration process. Proposed citizenship preparation activities must include the following two components:

Citizenship instruction to prepare lawful permanent residents for the civics (U.S. history and government) and English (reading, writing, and speaking) components of the naturalization test.

Naturalization application services, within the scope of the authorized practice of immigration law, to support lawful permanent residents in the naturalization application and interview process.

Eligible Applicants: Applicants and any proposed sub-awardees must be organizations with public or non-profit status; Applicants must have recent experience providing direct citizenship instruction;

The applicant or any sub-awardees that are proposed to provide naturalization application services must have recent, relevant experience and must: a. Be recognized by the Board of Immigration Appeals and have a BIA accredited representative on staff who provides or supervises the naturalization application services; or b. Have an attorney on staff who provides or supervises the naturalization application services. Eligible organizations include but are not limited to: public or private non-profit organizations such as public school systems; universities or community colleges; civic, community, and faith-based organizations; adult education organizations; public libraries; volunteer and literacy organizations; and state and local governments.

Eileen Fisher Invites Women Entrepreneurs to Apply for Business Grant Program

Deadline: 05/15/2012

Women's clothing retailer Eileen Fisher provides support to woman entrepreneurs through their annual Business Grant Program. The program seeks applicants from wholly women-owned businesses that combine the principles of social consciousness, sustainability, and innovation to create new businesses or invigorate existing ones. In addition to the key social principals, applicants must have a solid business plan and a strategy for long term growth. To be considered for a grant, businesses must produce products that foster environmental and economic health in the global community. (The program is not designed for consulting services, medical practices, and general services. It favors product-based enterprises.) Two business categories are eligible for the grant: established businesses and start-ups. An established enterprise will have been in business at least three years and be ready to develop the next stage of its business plan. A start-up (less than three years in business) will be considered based on a solid business plan, the ability to show how the grant money will enhance the growth of the business at this time, and financial documents that demonstrate the current health and future potential of the business. Only for-profit businesses and for-profit/nonprofit hybrid businesses (social enterprises) are eligible for the grant.
