

CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES NEW AFFORDABLE HEALTH INSURANCE OPTIONS FOR MILLIONS OF AMERICANS

Washington, D.C.- **Congressman Rubén Hinojosa (D-TX-15)** announced that, beginning in October, millions of Americans have had access to affordable, quality health insurance as new online Health Insurance Marketplaces open in every state, under the provisions of the Affordable Care Act.

"The health care law will allow my constituents looking for coverage to purchase affordable, quality health insurance through the new online Marketplace," U.S. Rep. Hinojosa said. "This new online Marketplace provides a very simple way to get health insurance that will meet your needs, your lifestyle, and your budget at almost any income level."

"The new Marketplaces build on the last three years, during which Americans have already been seeing lower costs and better coverage because of the Affordable Care Act," Rep. Hinojosa added. "Because of the Affordable Care Act, 105 million Americans have already received access to free preventive services, 6.6 million seniors have saved more than \$7 billion on their prescription drugs, and more than 100 million Americans have benefited from no longer having a lifetime limit on their coverage."

In the new online Marketplace, the constituents in our congressional district of Texas-15 looking for coverage will be able to shop among affordable choices, explained in easy-to -understand language. It is estimated that substantially more than half of those shopping in the new Marketplace will qualify for discounts on their monthly premium, based on their income, which will make the premiums more affordable.

In this new online Marketplace, there is no denial for preexisting conditions, no annual or lifetime limits on coverage, and no higher rates for women compared to men.

The open enrollment period for the first year of the Marketplaces runs from October 1, 2013 through March 31, 2014. Enrollment is a six-month process and will build over time. For example, under the Massachusetts state health reform, three times as many people enrolled during the second half of the first year, as in the first half.

The constituents in our congressional district of Texas-15 looking for health coverage should go to <u>www.healthcare.gov</u> and by putting in their state and zip code, they will be able to see and compare plans and premiums in our part of the state. "The new online Marketplace will mean new peace of mind for many of my constituents," Rep. Hinojosa concluded. "Many have been unable for years to obtain health insurance because of a pre-existing condition or because they couldn't find an affordable plan. The new Marketplaces across the country will mean brand-new health and economic security for millions of Americans and a healthier, more prosperous nation."

Drinking water systems are basic and vital to both health and economic development. With dependable water facilities, rural communities can attract families and businesses that will invest in the community and improve the quality of life for all residents. Without dependable water facilities, the communities cannot sustain economic development. The Rural Utilities Services (RUS) supports the sound development of rural communities and the growth of our economy without endangering the environment. RUS provides financial and technical assistance to help communities bring safe drinking water and sanitary, environmentally sound waste disposal facilities to rural Americans in greatest need. The Technical Assistance and Training (TAT) Grant Program has been established to assist communities with water or wastewater systems through free technical assistance and/or training provided by the grant recipients. Qualified private non-profit organizations will receive TAT grant funds to identify and evaluate solutions to water and waste disposal problems in rural areas, assist applicants in preparing applications for water and waste grants made at the State level offices, and improve operation and maintenance of existing water and waste disposal facilities in rural areas.

Lego Children's Fund Seeks Grant Proposals for Youth Creativity Programs

Deadline: Open/Quarterly

The Lego Children's Fund is accepting grant proposals for programs dedicated to inspiring and encouraging youth creativity. The fund supports programs serving in children from birth to age 14, with priority consideration for disadvantaged or at-risk youth.

Each quarter, the fund awards grants ranging between \$500 and \$5,000 to organizations working with disadvantaged children and special projects or programs designed to elevate a child's opportunities for exploring creativity. Arthur Vining Davis Foundations Seeks Proposals to Strengthen Secondary Education

Deadline: Rolling

The Arthur Vining Davis Foundations supports innovative professional development programs that strengthen teachers in grades 9-12 and their teaching. Projects may cover a wide range of initiatives intended to improve teaching. For example, projects might be designed to improve professional development for in-service and pre-service teachers, strengthen teaching skills, support practical research in teacher and high school education, or encourage innovative use of technology and new techniques for presentation of classroom materials in high schools. Projects should aim to develop solutions with potential for wide application or replication by others. Requests to support well-established programs should be for initiatives with the potential to improve the program significantly. Special consideration will be given to projects in their early stages that address the concerns and problems of secondary education on a

national level. In considering proposals to support high school teaching, sustained partnerships between the faculties of colleges (e.g., arts and sciences and education) and school districts, or collaborative efforts involving reform organizations, colleges/universities, and high schools are encouraged. Eligible institutions include but are not limited to public and private colleges and universities, graduate schools of education, and freestanding educational institutes. Grants will range from \$100,000 to an upper limit of \$200,000.

Foundation for Rural Education and Development Revises Eligibility Guidelines for Fall Technology Grants

Deadline: 11/15/13

The Foundation for Rural Education and Development has announced changes to the eligibility requirements for its Technology Grants for Rural Schools program. Technology Grants for Rural Schools program was created to help meet the growing need for innovative technology in the classroom. The grants strive to help public schools in rural areas bring modern computers to every classroom, connect schools to the information superhighway, and make sure that effective and engaging software and online resources are an integral part of the school curriculum. Starting in the fall of 2013, eligibility for FRED programs is determined by the foundation's Donor Circle. Applicants must have a letter of nomination from a Donor Circle company and meet the basic requirements outlined in the individual program brochure. Only those applications that meet these two requirements will be considered for FRED funding. The number of applicant nominated by each company is limited and determined by the company. Tech Grants of up to \$5,000 are available to public schools that are working in cooperation with their telecommunications company to enhance learning by increasing the use of technology in the classroom. Projects that are unique and focus on new programs and curriculum for technology education are encouraged. Examples of possible grant requests include but are not limited to computer-assisted learning programs; computer equipment and programs; electronic access to information; and subject-specific tools for art, reading, math, science, etc.

Laura Bush Foundation for America's Libraries Accepting School Library Grant Applications

The Laura Bush Foundation for America's Libraries, a component fund of the Community Foundation for the National Capital Region in Washington, D.C., seeks to provide books and reading materials to school libraries and students that most need them. The foundation provides grants of up to \$5,000 to help school libraries expand, update, and diversify their book collections. In 2013, the foundation received over five hundred applications and awarded more than two hundred grants. All LBF grants are made to individual schools rather than school districts, county systems, private organizations, foundations, or other entities. Only schools where a minimum of 80 percent of the student body qualify for free or reduced- lunch programs are eligible to apply. The foundation gives preference to schools in which 90 percent or more of the students receive free or reduced lunches and are likely to have the fewest books and reading materials at home. Schools in all fifty states, the District of Columbia, all American territories, and Department of Defense schools in other countries are eligible to apply. This includes all public, private, parochial, charter, city, state, county, and reservation schools -- including special schools, social services schools, and juvenile detention center schools in any of those jurisdictions -- that serve any combination of pre-kindergarten through high school students. Funds are only available for library books and magazine/serial copies and subscriptions. The foundation is unable to honor requests for staffing, shelving, furniture, equipment, software, videos, classroom book sets, or any kind of book guides, tests, or exams.

National Science Teachers Association Accepting Entries for Shell Science Lab Challenge

Deadline: 12/20/2013

The National Science Teachers Association, with support from Shell Oil Company, is accepting entries for the fourth annual Shell Science Lab Challenge. The challenge invites middle and high school science teachers (grades 6-12) in the United States and Canada (with special attention to urban and underrepresented groups) to illustrate replicable approaches to science lab instruction utilizing limited school and laboratory resources. Entries will be judged on the basis of a number of criteria, including demonstrated science inquiry and innovation in the classroom with limited laboratory equipment, materials, and resources; demonstrated impact and engagement with students and the school community; and demonstrated need for support to improve science laboratory experiences. Fifty-four regional finalists will be selected and asked to create a short video that displays the school's current science laboratory facilities and provides further explanation of how winning equipment and resources would make a difference in their science teaching and in the learning experience for students. The judging panel will then review the submissions and select eighteen regional winners. Of the eighteen winners, four national finalists will be chosen, and from those finalists a grand-prize winner will be selected. More than \$93,000 in lab makeover prizes will be awarded to the eighteen winning schools. All winners will receive science lab equipment, cash grants, membership to the NSTA, and support to attend NSTA conferences on science education.

Big Read Accepting Grant Applications for Community-Wide Reading Programs

National Endowment of the Arts (NEA)

Deadline: 01/27/2013

The Big Read, a program of the National Endowment for the Arts, aims to restore reading to the center of American culture. Managed by Arts Midwest, the program provides competitive grants to support innovative reading programs in selected communities. Community organizations participating in the Big Read develop and produce reading programs that encourage reading and participation by diverse local audiences. These programs include activities such as author readings, book discussions, art exhibits, lectures, film series, music or dance events, theatrical performances, panel discussions, and other events and activities related to the community's chosen book or poet. Activities must focus on a book or poet from the Big Read Library. Previous grantees must not use the same reading from their earlier participation(s). The program is accepting applications from nonprofit organizations to develop reading programs between September 2014 and June 2015. Organizations selected to participate receive a grant, educational and promotional materials, and access to online training resources and opportunities. Approximately seventy-five organizations will be selected from communities of varying size in the U.S. Eligible organizations may apply for grants ranging from \$2,500 to \$20,000. Grants must be matched on a 1:1 basis with non-federal funds. Grant funds may be used for such expenses as book purchases, speaker fees and travel, salaries, advertising, and venue rental.

Eligible Applicants: organizations must be a 501(c)(3) nonprofit; or a division of state, local, or tribal government; or a tax-exempt public library. Eligible applicants include such organizations as literary centers, libraries, museums, colleges and universities, art centers, historical societies, arts councils, tribal governments, humanities councils, literary festivals, and arts organizations.

Research meeting the regulatory definition of intentional exposure research found in subpart B is prohibited by that subpart in pregnant women, nursing women, and children. Research meeting the regulatory definition of observational research found in subparts C and D is subject to the additional protections found in those subparts for pregnant women and fetuses (subpart C) and children (subpart D). All applications must include a Human Subjects Research Statement (HSRS, as described in Section IV.B.5.c), and if the project involves human subjects research, it will be subject to an additional level of review prior to funding decisions being made as described in Sections V.C and V.D of this solicitation.

Maximum Grant Size: \$15,000

Number of Awards: 40

Eligible Applicants: Public nonprofit institutions/organizations (limited to degree-granting public institutions of higher education) and private nonprofit institutions/organizations (limited to degree-granting private institutions of higher education) located in the U.S. (includes U.S. territories and possessions) are eligible to apply to be the recipient of a grant to support teams of undergraduate and/or graduate students. Profit-making firms are not eligible to receive assistance agreements from the EPA under this program.

The foundation awards both program and operating grants with no geographic restrictions to nonprofit organizations that qualify for tax-exempt status under section 501(c)(3) of the Internal Revenue Code, as well as public schools and libraries.

International charitable organizations, private foundations, for-profit businesses, individuals, churches, and religious, charter, and magnet schools are not eligible for grants from the foundation, and grants will not be awarded for computer or audiovisual equipment purchases or for music or garden programs (or related equipment). Also ineligible for funding are programs and equipment for physical education, recreation, theater performance, hospices or old age homes, political lobbying activities, and voter registration, as well as dinners, balls, and other ticketed events. American Hiking Society Offers Support to Maintain and Protect Hiking Trails

The American Hiking Society's National Trails Fund is dedicated to building and protecting hiking trails in the United States. National Trails Fund grants are designed to give local organizations the resources they need to secure access, volunteers, tools, and materials to repair and protect America's hiking trails. Grants will be awarded for projects designed primarily to serve hikers, although multi-purpose human-powered trail uses; projects that secure trail lands, including acquisition of trails and trail corridors and the costs associated with acquiring conservation easements; projects that will result in visible and substantial ease of access, improved hiker safety, and/or avoidance of environmental damage; and projects that promote constituency-building surrounding specific trail projects, including volunteer recruitment and support also are eligible. Preference often is given to projects that utilize volunteer labor. To be eligible, applicants must be a nonprofit 501(c)(3) organization and must be an AHS Alliance member. Grants will range from \$500 to \$5,000 per project.

The primary mission of the Tony Hawk Foundation is to promote high quality, public skateparks in low-income areas throughout the United States. While we realize that not every area can afford to build big, expensive skateparks, we feel strongly that public skateparks should be designed and constructed by experienced contractors. We also believe that local officials should treat public skateparks the same way they treat public basketball courts or tennis courts, meaning that anyone may show up and use them anytime, unsupervised. The foundation primarily considers skatepark projects that: are designed and built from concrete by gualified and experienced skatepark contractors. include local skaters throughout the planning, fundraising, and design process. are in low-income areas and/or areas with a high population of "at-risk" youth. can demonstrate a strong grassroots commitment to the project, particularly in the form of fundraising by local skateboarders and other community groups. have a creative mix of street obstacles (rails, ledges, stairs, etc.) and transition/vert terrain (quarterpipes, bowls, halfpipes, etc.) don't require skaters or their parents to sign waivers, encourage skaters to look after their own safety and the safety of others without restricting their access to the park or over-regulating their use of it. are open during daylight hours, 365 days a year. don't charge an entrance fee.

are in areas that currently have no skateboarding facilities.

If your proposed skatepark is not located in a low-income area, if you are not able to illustrate strong community and grassroots support for the project, and if your project does not meet the criteria listed above, you are unlikely to receive a significant grant from our foundation. All Tony Hawk Foundation Grant Applicants will receive a detailed review of their projects and skatepark designs, whether a grant is awarded or not. Bikes Belong is a national coalition of bicycle suppliers and retailers working together to put more people on bicycles more often. Bikes Belong welcomes grant applications from organizations and agencies within the United States that are committed to "putting more people on bicycles more often." The Bikes Belong Grants Program funds projects in two categories: 1) facilities; and 2) advocacy.

Eligible Applicants: Bikes Belong will accept applications from nonprofit organizations, public agencies, and departments at the national, state, regional, and local levels. For the advocacy category, Bikes Belong will only fund organizations whose mission is expressly related to bicycle advocacy. New organizations that are not yet legally nonprofit organizations may submit an application with the assistance of another nonprofit that has agreed to serve as fiscal agent. Bikes Belong will not fund individuals. Because of the program's limited funds, it rarely awards grants to organizations and communities that have received Bikes Belong funding within the last three years.
