CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES \$1.4 MILLION AWARDED TO UTPA CONSORTIUM FOR RAILWAY SAFETY

Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced the U.S. Department of Transportation has awarded a grant of \$1,414,100 to the University of Texas-Pan American (UTPA), Texas A&M University and the University of Nebraska to improve railway safety in their areas.

"Living in the Rio Grande Valley, we all have experienced and know of the potential danger in crossing railroads which weave through all of our cities and rural towns," said U.S. Rep. Hinojosa. "As the enrollment at UTPA continues to expand, we must be ever vigilant of finding ways to make our roads and highways safer. I commend UTPA for receiving this U.S. Department of Transportation grant award that will serve as a distinct measure for improving safety for UTPA students and for all of our residents."

The transportation center funding will be used to improve railway safety by reducing fatalities and injuries at highway-rail crossings, reducing failure by developing more durable material and systems. The grant funds will also be

used to develop advanced technology for infrastructure monitoring and developing innovative safety assessments and decision making tools.

The grant would also serve to foster collaboration with the university researchers, industry partners and a variety of education partners and programs to create innovative opportunities for the community.

Members of each university consortium will determine how the funds will be distributed among the universities.

CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES NEARLY \$1 MILLION GRANT FOR MCALLEN MILLER INTERNATIONAL AIRPORT

Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced that the McAllen Miller International Airport was awarded a grant of \$890,000 by the U.S. Department of Transportation for safety improvements.

The funding will be used to improve runway safety areas to meet current design standards. The grant will also fund the replacement of 5,429 feet of the airport perimeter fence to deter unauthorized persons and vehicles from entering onto the airfield.

"McAllen Miller International Airport continues to grow and prosper to keep up with the increasing demand for international travel in our region," said U.S. Rep. Hinojosa. "I am very pleased to see our airport continue to receive federal grant awards for the improvement of safety and expansion. Congratulations to McAllen airport Director Phil Brown and his team and our McAllen City leaders."

The funds will also be used to provide Aircraft Rescue and Fire Fighting Vehicle strut replacement.



CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES GRANT FOR MCALLEN MILLER INTERNATIONAL AIRPORT

Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced the McAllen-Miller International Airport was awarded a Small Community Air Service Development grant of \$750,000 by the U.S. Department of Transportation. The purpose of the Small Community Air Service Development Grant program is to provide funding support to help small airports, such as McAllen, attract air service to locations not being served by other airlines at this time.

"McAllen-Miller International Airport continues to provide an important service to Rio Grande Valley residents year round," said U.S. Rep. Hinojosa. "With our ever growing population, expanding these services is a must to maintain the great quality of air service offered by our airport. I congratulate Director of Aviation, Phil Brown and everyone involved who are keeping our airport at a top notch level."

Director of Aviation, Phil Brown, said "This is great news for McAllen! Air Service is vital to the economic development of McAllen; new air service will open many more travel opportunities for our citizens."

Award of the grant does not guarantee that an airline will initiate service to McAllen, but it does mean that the airport has the ability to provide incentives to airlines. McAllen applied to the Department of Transportation in July of this year and was one of 59 grant applications submitted.

CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES NEW TECHNOLOGY SCIENCE GRANT FOR THE UNIVERSITY OF TEXAS-PAN AMERICAN

Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced the University of Texas-Pan American (UTPA) was awarded a grant of \$158,420.00 by the National Science Foundation (NSF) for biological research.

"The NSF continues to recognize UTPA as an excellent institution that provides quality education," said U.S. Rep. Hinojosa. "Our students are being provided the best opportunities in higher education in Deep South Texas. UTPA continues to be on top of an ever expanding world of technology."

This award will be effective as of September 1, 2013 and be allocated toward a next-generation DNA sequencer. This new technology will be the first of its kind in South Texas, allowing scientists at the University of Texas- Pan American to define DNA structure more easily in order to address major biological questions in microbiology, plant science, zoology, genetics, physiology, ecology.

More specifically, a team of researchers at The University of Texas-Pan American plans to use the award money to implement magnetic resonance imaging (MRI) sequencing, which characterizes DNA much faster than the traditional

method. The technique will make possible valuable experiments on topics such as:

- Comparing the DNA of devastating plant diseases;
- Analyzing the developmental DNA of insects with significant impacts on humans;
- Investigating the distribution of insects that carry the deadly Chagas Disease.

Moreover, learning at the University of Texas- Pan American will be positively impacted by the next-generation sequencer, as faculty mentors will be able to train student researchers and use the technology in upper-division Biology courses.

Because the technology will also be made available to collaborators at institutions near UTPA, it has the potential to transform research and education for the entire South Texas region.

The research team leading this project includes four women, one of whom is Hispanic and one that has a disability. The technology is sure to increase the number of Hispanics, women, and disabled persons conducting biological research in South Texas and in the USA.

CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES OVER \$2 MILLION IN GRANTS AWARDED TO THE CITIES OF EDINBURG, MERCEDES AND PHARR

Washington, D.C.- Congressman Rubén Hinojosa (D-TX-15) announced the City of McAllen was awarded a grant of \$1,020,266 for the Bentsen Road Hike and Bike Trail by the Texas Transportation Commission.

"This grant will give a boost to the successful project already started by the City of McAllen", said U.S. Rep. Hinojosa. "It will greatly improve the quality of living for McAllen residents as well as contribute to a healthier lifestyle by providing more areas for physical fitness opportunities."

The continuous trail will be 1.6 miles and will enhance the City's 17 miles of existing trails that will be used by pedestrians and cyclists.

McAllen Mayor Jim Darling stated, "As the trail competed with other eligible projects from around the state. I commend the support provided for the Bentsen Road Hike and Bike Trail by U.S. Congressman Ruben Hinojosa, State Rep. Bobby Guerra, State Rep. Sergio Munoz Jr. and State Sen. Competitively reviewed and selected under the Texas Department of Transportation's 2012 Transportation Enhancement Program. the grant will provide for the construction of a multi-use pedestrian and bicycle trail with amenities and landscaping, connecting residential neighborhoods, parks, schools and other points of interest along Bentsen Road from Pecan Boulevard (FM 495) to Nolana Avenue. The federally-funded award will be leveraged with a local match of \$255,066 for a total project cost of \$1,275,331.

The total amount anticipated to be awarded under this announcement is approximately \$2,000,000 depending on funding availability, quality of proposals, and other applicable considerations. Awards will range from approximately \$50,000 to \$300,000 of federal funds with each project period being up to three years. A broad range of entities, as described in Section III, are eligible to submit proposals under this announcement for projects in the Gulf of Mexico region and its watersheds in the five states abutting the Gulf of Mexico (Texas, Louisiana, Mississippi, Alabama, Florida), including their out-of-geographic-region contributory watersheds, that address water quality monitoring and/or improvement, coastal habitat and ecosystems enhancement and/or protection, community resilience, and environmental education and outreach.

Eligible Applicants: The following entities are eligible to apply for funding under this announcement unless restricted by the authorizing statute(s); State, local government agencies, districts, and councils; regional water pollution control agencies and entities; Indian tribal governments; State coastal zone management agencies; public and private universities and colleges; and public or private, non-profit organizations and institutions. Non-profit organizations must have documentation of non-profit status from the U.S. Internal Revenue Service or their state of incorporation, except that non-profit organizations as defined in Section 501(c)(4) of the Internal Revenue Code that engage in lobbying as defined in Section 3 of the Lobbying Disclosure Act 1995 or superseding legislation are ineligible.

The American Hiking Society's National Trails Fund is dedicated to building and protecting hiking trails in the United States. National Trails Fund grants are designed to give local organizations the resources they need to secure access, volunteers, tools, and materials to repair and protect America's hiking trails. Since 1995, the U.S. Soccer Foundation has awarded grants to more than six hundred organizations in the United States for projects designed to keep children in underserved communities active, healthy, and safe. Because urban areas often lack space for children to play outside, the foundation is working to provide play spaces for children across the nation. The foundation is accepting Letters of Inquiry for the Safe Places to Play program, which provides grants to organizations to help them build or enhance a field space in their communities. Field Building grants of up to \$200,000 each will be awarded for

the installation of field surfaces, lighting, and irrigation. To be eligible for a Field Building grant, an applicant must apply on behalf of a program or project operating in the U.S.; be a 501(c)(3) not-for-profit organization, school, municipality, college or university, or sovereign tribal nation; apply as, or on behalf of, a field-building project; and own or have a minimum of a ten-year land lease/land use agreement on the land where the field-building project will take place.
