Recent Developments in China's Relations with Taiwan and North Korea

WHAT: Public Hearing on "Recent Developments in China's Relations with Taiwan and North Korea." The hearing will examine economic, political, and security developments in cross-Strait and China-North Korea relations. It will assess the opportunities and risks arising from closer cross-Strait economic integration for Taiwan and the United States, and it will examine Taiwan's ability to defend against military coercion by China. The hearing will also address whether China's views and policies toward North Korea have changed in recent years and the implications for U.S. security interests.
