The Office of Congresswoman Robin L. Kelly compiled the information included in this guidebook. The purpose of this guidebook is to highlight and explain opportunities for federal, state and local assistance for unemployed workers. This guide is not intended to be a comprehensive look at all assistance opportunities, rather it is meant to highlight those programs of interest to Illinois and the 2nd Congressional District. Detailed information can be found by contacting the appropriate federal or state agencies as the information is subject to change. Additional requirements and guidance may be published at the discretion of the relevant agencies.

Unemployment Insurance, Benefits, and Services

Unemployment Insurance: Administered by the Illinois Department of Employment Security (IDES)

Unemployment Insurance (UI) is a state-operated insurance program designed to partially replace lost wages when you are out of work. The Illinois Department of Employment Security (IDES) collects unemployment insurance taxes from the state's liable employers and returns those dollars to eligible Illinois workers as unemployment insurance benefits. Applicants must have earned enough money in the past 18 months for Illinois to establish a weekly benefit amount. The temporary emergency income is provided to workers who are unemployed through no fault of their own and looking for work. The program ensures that if eligibility requirements are met, you will have some income for up to a maximum of 26 full weeks in a one-year period while you looking for a job. Unemployment Insurance does not protect against wage losses while absent from work due to illness or idle by choice.

Applicants found ineligible for unemployment insurance have a right to appeal this decision. In the appeal process claimants have the opportunity to present their case to a referee who will determine if an individual is eligible to receive unemployment insurance benefits.

Workforce Investment Act (WIA): administered by the Illinois Department of Commerce and Economic Opportunity

The Workforce Investment Act (WIA) combines federally funded job training programs in Illinois into a "workforce development" system where individuals can find a job or train for a new career. Services are provided through the state's one-stop delivery system, Illinois workNet Centers. Individuals who wish to apply for available training programs, or obtain other services, should visit the nearest IllinoisworkNet Center for assistance. WIA establishes three basic levels of employment and training services to eligible individuals. All adults (age 18 or older) are eligible to receive "core services". Additional "intensive services" are available to unemployed individuals who have been unable to obtain jobs through core services and those who are employed but need additional training services to reach self-sufficiency. "Training services" are also available for those who meet intensive services eligibility but were unable to find employment through those services. While the employment services and training programs available in each center may be somewhat different, they reflect the opportunities and needs of the Local Workforce Investment Area and are developed by a Local Workforce Investment Board. http://www.illinoisworknet.com/vos_portal/
