RULES:

The competition is open to senior high (grades 9-12) students from schools in the 6th Congressional District. One (1) art entry per student. Each school may submit a total of six entries. (6)

Artwork must be:

- > Two-dimensional,
- No larger than 28 x28" x 4"deep
- Framed or reinforced for hanging,
- Cannot weigh more than 15 lbs

Within the following categories for acceptance for the show:

- > Painting - oil, watercolor, acrylics, etc.
- Drawings
- pencil, pen and ink, pastels, charcoal, crayon.lithographs, silk screens, monotypes, woodcuts and intaglio methods. > Prints

NOTE: - No photographs, no collage.

EACH ENTRY MUST BE AN ORIGINAL CONCEPT: the entry may not reproduce an image from a third party's work in the same or any other medium; the work may not infringe the rights of any third party; the work may not violate the U.S. Copyright Laws.

We ask that you please test hang the artwork for several days to be sure that when it is hung for the exhibition in the gallery it will not fall, resulting in damage to the art piece
