H.R. 4660 – The FY 2015 Commerce, Justice, Science Appropriations Act House Adopted Amendments

Rep. Lynch (D-MA) – The amendment increases funding for Department of Justice (DoJ) drug courts by \$3 million, offset by a reduction to the International Trade Administration. **The amendment was adopted on a voice vote.**

Rep. Reichert (R-WA) – The amendment increases funding for the COPS grant program by \$110 million, offset by a reduction in periodic census funding. **The amendment was adopted on a voice vote.**

Rep. Langevin (D-RI) – The amendment increases funding for the Bureau of Industry Securities by \$5 million, and then decreases it by the same amount. The intent of the amendment is to support a cybersecurity framework survey. **The amendment was adopted on a voice vote.**

Rep. Gibson (R-NY) – The amendment increases funding for the Organized Crime Drug Enforcement Task Force by \$4 million, offset by a reduction in periodic census funding. **The amendment was adopted on a voice vote.**

Rep. McNerney (D-CA) – The amendment increases funding for the COPS program by \$3 million, offset by a reduction in the periodic census funding. The intent of the amendment is to increase the Technology Grant Program. **The amendment was adopted on a vote of 306-106.**

<u>Rep. Bridenstine (R-OK)</u> – The amendment increases weather research activities by \$12 million, offset by a reduction in the periodic census. **The amendment was adopted on a vote of 340-71.**

<u>Rep. Nugent (R-FL)</u> – The amendment increases funding for Veterans Courts and Mental Health Treatment Courts by \$2 million each, offset by a reduction in periodic census funding. **The amendment was adopted on a voice vote.**

Rep. Thompson (D-CA) – The amendment increases funding for grants to improve the National Instant Criminal Background Checks System (NICS) by \$19.5 million, offset by a reduction in Department of Commerce (DOC) departmental management funding and other accounts. The intent of the amendment is to provide additional resources for states to submit additional records of prohibited firearm purchasers. **The amendment was adopted on a vote of 260-145-1.**

Rep. Moore (D-WI) – The amendment increases funding for DOJ's Executive Office of Immigration Review by \$1 million, offset by a reduction in DOJ General Administration funds. **The amendment was adopted on a voice vote.**

Rep. Sinema (D-AZ) – The amendment increases funding for Violence Against Women grants by \$1 million, offset by a reduction in DOJ General Administration funds. **The amendment was adopted on a voice vote.**

Rep. King (R-IA) – The amendment increases DOJ General Administration funds by \$5 million, offset by a reduction of the same account. The intent of the amendment is to focus funding on investigations of the release of criminal aliens. **The amendment was adopted on a vote of 218-193.**

Rep. Brownley (D-CA) – The amendment increases funding for Veterans Treatment Courts by \$1 million, offset by a reduction in DOJ General Administration funds. **The amendment was adopted on a voice vote.**

Rep. McKinley (R-WV) – The amendment increases funding for the International Trade Commission by \$1.5 million, offset by a reduction in DOJ General Administration funds. The amendment was adopted on a voice vote.

Rep. Lujan Grisham (D-NM) – The amendment increases funding for Mentally Ill Offender Treatment and Crime Reduction programs by \$2 million, offset by a reduction in DOJ General Administration funds. **The amendment was adopted on a voice vote.**

Rep. Coffman (R-CO) – The amendment increases funding for U.S. Attorneys Salaries and Expenses by \$1 million, offset by a reduction in DOJ General Administration funds. The intent of the amendment is to encourage criminal investigations into the recent Veterans Administration waiting list scandal. **The amendment was adopted on a voice vote.**

Rep. Lee (D-CA) – The amendment increases funding for "Second Chance Act" programs by \$3 million, offset by reductions to the DOJ Information Sharing Technology account and the Bureau of Prisons Salaries and Expenses account. **The amendment was adopted on a voice vote.**

Rep. Fleming (R-LA) – The amendment cuts the DOJ Legal Activities account by \$866,000, and transfers the funds to the Spending Reduction Account. The intent of the amendment is to protest DOJ's handling of the enforcement of federal marijuana laws. **The amendment was adopted on a voice vote.**

Rep. Gosar (R-AZ) – The amendment increases funding for the Prescription Drug Monitoring Program by \$8 million, offset by a reduction in DOJ General Legal Activities. **The amendment was adopted on a voice vote.**

Rep. Cohen (D-TN) – The amendment increases funding for State and Local Law Enforcement grants by \$5 million, offset by a reduction in the Drug Enforcement Administration (DEA) Salaries and Expenses Account. The purpose of the amendment is to increase funding to address the backlog of sexual assault kits. **The amendment was adopted on a voice vote.**

Rep. Gosar (R-AZ) – The amendment increases funding for Veterans' Treatment Courts by \$6 million, offset by a reduction in the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Salaries and Expenses account. **The amendment was adopted on a voice vote.**

Rep. Jackson-Lee (D-TX) – The amendment increases funding for Violence Against Women Act Programs by \$500,000, offset by a reduction in the Bureau of Prisons (BOP) Salaries and Expenses account. **The amendment was adopted on a voice vote.**

Rep. Delaney (D-MD) – The amendment increases funding for State and Local Law Enforcement Assistance grants by \$1 million, offset by a reduction in the BOP Salaries and Expenses account. The amendment was adopted on a voice vote. **The amendment was adopted on a voice vote.**

Rep. Connolly (D-VA) – The amendment increases funding for Veterans' Treatment Courts by \$1 million, offset by a reduction in the BOP Buildings and Facilities account. **The amendment was adopted on a voice vote.**

Rep. Gallego (D-TX) – The amendment increases funding for the Violence Against Women Act by \$2.5 million, offset by a reduction in state and local law enforcement assistance grants. The intent of the amendment is to help address domestic violence, dating violence, and stalking in rural areas. **The amendment was adopted on a voice vote.**

Rep. Gosar (R-AZ) – The amendment increases funding for Byrne Justice Assistance Grants by \$4.25 million, offset by a reduction to DOJ research funding. **The amendment was adopted on a voice vote.**

<u>Rep. Grayson (D-FL)</u> – The amendment increases funding within Byrne Justice Assistance Grants for gun locks and gun safety literature by \$3 million. **The amendment was adopted on a voice vote.**

<u>Rep. Kaptur (D-OH)</u> – The amendment increases funding for the NASA Space Technology account by \$7 million, offset by a reduction in NASA Space Operations. **The amendment was adopted on a voice vote.**

<u>Rep. Smith (R-TX)</u> – The amendment reduces and then adds back \$15.35 million within the National Science Foundation (NSF) Research and Related Activities account. The sponsor's intent is to support physical sciences. **The amendment was adopted on a vote of 208-201.**

Rep. Hastings (R-WA) – The amendment prohibits funds within the Pacific Coastal Salmon Recovery program from being used for grant guidelines or requirements to establish minimum riparian buffers. **The amendment was adopted on a voice vote.**

<u>Rep. Engel (D-NY)</u> – The amendment prohibits funding to lease or purchase new light duty vehicles, for any executive fleet, or for an agency's fleet inventory, except in accordance with Presidential Memorandum on Federal Fleet Performance. **The amendment was adopted on a voice vote.**

Rep. Bonamici (D-OR) – The amendment prohibits funding for DOJ to prevent a state from implementing laws to authorize the use, distribution, possession, or cultivation of industrial hemp. **The amendment was adopted on a vote of 237-170.**

Rep. Grayson (D-FL) – The amendment prohibits funding for a contract to an offeror that has been convicted of, or is currently indicted or civilly charged with certain crimes, or has delinquent taxes of more than \$3,000 within a three-year period of the offered contract. **The amendment was adopted on a voice vote.**

Rep. Rohrabacher (R-CA) – The amendment prohibits funding for DOJ to prevent states from implementing state laws that authorize the use, distribution, possession, or cultivation of medical marijuana. **The amendment was adopted on a voice vote of 219-189.**

<u>Rep. Holding (R-NC)</u> – The amendment prohibits funds to transfer or temporarily assign employees to the Office of the Pardon Attorney for the purpose of screening clemency applications. The amendment was adopted on a vote of 219-189.

Rep. Flores (R-TX) – The amendment prohibits funding to implement the National Ocean Policy and ocean zoning under Executive Order 13547 without explicit congressional authorization. **The amendment was adopted on a voice vote.**

<u>Rep. Poe (R-TX)</u> – The amendment prohibits funding to impose a fine on individuals for failing to complete the American Community Survey. **The amendment was adopted on a voice vote.**

Rep. Jackson-Lee (D-TX) – The amendment prohibits funds for the DOJ Administrative Review and Appeals to be used in contravention of sections 509 and 510 of title 28, United States Code. **The amendment was adopted on a voice vote.**

Rep. Massie (R-KY) – The amendment prohibits funds for DOJ to contravene section 7606 of the Agricultural Act of 2014 relating to industrial hemp. **The amendment was adopted on a vote of 246-162.**

Rep. Huffman (D-CA) – The amendment prohibits funds from being used to assess or collect the fee established by sec. 660.115 of title 50, Code of Federal Regulations. **The amendment was adopted on a voice vote.**

<u>Rep. Ellison (D-MN)</u> – The amendment prohibits funds in the bill from being used in contravention of certain civil rights laws. **The amendment was adopted on a voice vote.**

<u>Rep. Perry (R-PA)</u> – The amendment prohibits NASA from using funds for its Advanced Food Technology Project. **The amendment was adopted on a voice vote.**

<u>Rep. Broun (R-GA)</u> – The amendment prohibits funding from being used for a loan guarantee under the America Competes Act. **The amendment was adopted on a voice vote.**

<u>Rep. Grayson (D-FL)</u> – The amendment prohibits funding to negotiate agreements that violate the Buy American Act. **The amendment was adopted on a voice vote.**

<u>Rep. Salmon (R-AZ)</u> – The amendment prohibits funding for the NSF to examine climate effects of tea quality and socioeconomic responses under a certain grant award. **The amendment was adopted on a voice vote.**

<u>Rep. Grayson (D-FL)</u> – The amendment prohibits funds to compel a journalist or reporter to testify about information or sources that they regard to be confidential. **The amendment was adopted on a vote of 225-183.**

<u>Rep. Perry (R-PA)</u> – The amendment prohibits funds to design, administer or implement certain climate change reports, assessments, and plans. **The amendment was adopted on a voice vote.**

Rep. Duffy (R-WI) – The amendment prohibits funding to relinquish the responsibility of the National Telecommunications and Information Administration with respect to Internet domain name system functions, including responsibility with respect to the authoritative root zone file and the Internet Assigned Numbers Authority functions. **The amendment was adopted on a vote of 229-178.**

<u>Rep. Garrett (R-NJ)</u> – The amendment prohibits funding for the DOJ pursue litigation using the "disparate impact" legal theory. **The amendment was adopted on a vote of 216-190.**

<u>Rep. Luetkemeyer (R-MO)</u> – The amendment prohibits funding to carryout "Operation Chokepoint." **The amendment was adopted on a voice vote.**

Rep. King (R-IA) – The amendment prohibits DOJ State and Local Grant funding from being used in contravention of the Illegal Immigration Reform and Immigration Responsibility Act of 1996. **The amendment was adopted on a vote of 214-194.**

<u>Rep. Meadows (R-NC)</u> – The amendment prohibits funds from being used for negotiations to enter into a trade agreement that regulates greenhouse gas emissions. **The amendment was adopted on a vote of 226-179.**

<u>Rep. Collins (R-GA)</u> – The amendment prohibits funding from the State Criminal Alien Assistance Program to reimburse "Sanctuary Cities." **The amendment was adopted on a voice vote.**
