

## H.R. 2609 – The Fiscal Year 2014 Energy and Water Development Appropriations Act

### House Adopted Amendments

**Noem (R-SD)** – The amendment increases funding in the bill for the Bureau of Reclamation Water and Related Resources Fund by \$25 million. The account supports the development, maintenance, and restoration of water and natural resources in the western states. The increase is offset by a \$15 million cut to the Renewable Energy, Energy Reliability and Efficiency Program, and a \$15 million cut to administrative funding at the Department of Energy. **The amendment was adopted on a voice vote.**

**Hastings (R-WA)** – The amendment increases funding for the Defense Environmental Cleanup account by \$22.5 million. The increase is offset by a \$9.5 million cut to the Renewable Energy, Energy Reliability, and Efficiency Program, and a \$20 million cut to administrative funding at the Department of Energy. **The amendment was adopted on a voice vote.**

**Reed (R-NY)** – The amendment increases funding for the Non-Defense Environmental Cleanup program by \$18.9 million. The increase is offset by a cut to Department of Energy administrative funding and the National Nuclear Security Administration. **The amendment was adopted on a voice vote.**

**Schiff (D-CA)** – The amendment increases funding for the Advanced Research Projects Agency – Energy (ARPA-E) by \$20 million. The increase is offset by a cut to Department of Energy administrative funding. **The amendment was adopted on a voice vote.**

**Frelinghuysen (R-NJ)** – The amendment modifies a warhead refurbishment reporting requirement in the bill to allow the relevant congressional authorization committees to receive the required reports. **The amendment was adopted on a voice vote.**

**Burgess (R-TX)** – The amendment prohibits funding to implement or enforce incandescent light bulb energy efficiency standards. **The amendment was adopted on a voice vote.**

**Meadows (R-NC)** – The amendment prohibits funding for the salaries of Presidential Recess Appointments until they are confirmed by the Senate. **The amendment was adopted on a voice vote.**

**Scalise (R-LA)** – The amendment prohibits funding for the Army Corps of Engineers in Louisiana to implement or enforce the “Modified Charleston Method” – a new wetlands calculation process. **The amendment was adopted on a voice vote.**

**Lynch (D-MA)** – The amendment increases funding for the Corps of Engineers Civil Construction by \$20 million, offset by a cut to Fossil Energy Research and Development. **The amendment was adopted on a vote of 217-206.**

**Blackburn (R-TN)** – The amendment prohibits funding for the Department of Energy to enforce a proposed rule on conservation standards for ceiling fans. **The amendment was adopted on a voice vote.**

**Higgins (D-NY)** – The amendment prohibits funding to relocate or consolidate resources or personnel in the Buffalo and Chicago districts of the Corps of Engineers, Great Lakes and Ohio River Division. **The amendment was adopted on a voice vote.**

**Walberg (R-MI)** – The amendment prohibits funding for the Department of Energy to use on a national media campaign for “green” technologies. **The amendment was adopted on a voice vote.**

**Grayson (D-FL)** – The amendment prohibits funding for contracts to companies convicted of various types of federal crimes, including fraud, embezzlement, etc., or that have more than \$3,000 in delinquent taxes within a three-year period surrounding the contract. **The amendment was adopted on a voice vote.**

**Scalise (R-LA)** – The amendment increases Army Corps of Engineers Construction by \$2 million, offset by a cut to Department of Energy administrative funding. **The amendment was adopted on a voice vote.**

**Gosar (R-AZ)** – The amendment prohibits funding to implement any new programs under a memorandum by Department of Energy Secretary Chu regarding Power Marketing Administrations from March 16, 2012. **The amendment was adopted on a voice vote.**

**Turner (R-OH)** – The amendment prohibits funding to reduce the U.S. nuclear weapons stockpile below the levels outlined in the new START treaty. **The amendment was adopted on a voice vote.**

**Engel (D-NY)** – The amendment prohibits funding to lease or purchase light-duty vehicles that are not in compliance with the Presidential Memorandum on alternative fuel vehicles. **The amendment was adopted on a voice vote.**

**Garcia (D-FL)** – The amendment increases the Corps of Engineers Civil Construction account by \$1 million, offset by a cut to a Corps of Engineers expenses account. **The amendment was adopted on a voice vote**

**Luetkemeyer (R-MO)** – The amendment prohibits funds for the Missouri River “Authorized Purposes” study authorized by the Energy and Water Appropriations Act of 2009. **The amendment was adopted on a voice vote.**

**Luetkemeyer (R-MO)** – The amendment prohibits funding for an environmental study under the Missouri River Ecosystem Restoration Plan. **The amendment was adopted on a voice vote.**

**Noem (R-SD)** – The amendment prohibits funding to charge fees for the use of surplus water from Missouri River reservoirs. **The amendment was adopted on a voice vote.**

**Kelly (R-PA)** – The amendment prohibits funding to expand the authorized uses of the Harbor Maintenance Trust Fund. **The amendment was adopted on a voice vote.**

**LaMalfa (R-CA)** – The amendment prohibits funding to regulate private property used for certain agriculture activities under the Federal Water Pollution Control Act. **The amendment was adopted on a voice vote.**

**King (R-IA)** – The amendment prohibits funding for the Corps of Engineers to dump sediment or soil into the Missouri River. **The amendment was adopted on a voice vote.**

**Flores (R-TX)** – The amendment prohibits funding to implement, administer, or enforce an Executive Order on National Ocean Policy. **The amendment was adopted on a voice vote.**

**Flores (R-TX)** – The amendment prohibits funding to implement, administer, or enforce section 526 of the Energy Independence and Security Act, which prohibits federal agencies from procuring certain fuels unless the greenhouse gas emissions are less than conventional petroleum sources. **The amendment was adopted on a voice vote.**

**Fleming (R-LA)** – The amendment prohibits funds for officer or employee salaries to implement a “green energy” loan program established in the 2009 “Stimulus” bill. **The amendment was adopted on a vote of 230-194.**
