H.R. 2217 – The Fiscal Year 2014 Homeland Security Appropriations Bill <u>House Adopted Amendments</u>

<u>Reichert (R-WA)</u> – The amendment cuts \$2.8 million from the Office of Secretary and Executive Management, and adds \$1.8 million to the U.S. Fire Administration. **The amendment was adopted on a voice vote.**

<u>Poe (R-TX)</u> – The amendment cuts \$10 million from the Office of the Undersecretary for Management, and adds the funds to the CBP Border Security Fencing, Infrastructure, and Technology (BSFIT) account from improvements of tactical communications along the southern border. **The amendment was adopted on a voice vote.**

<u>Runyan (R-NJ)</u> – The amendment cuts \$5 million the Office of the Undersecretary for Management, and adds \$5 million to increase SAFER and firefighter equipment grant funding. **The amendment was adopted on a voice vote.**

<u>Grimm (R-NY)</u> – The amendment cuts the Office of the Secretary and Executive Management by \$7.7 million, and adds the funds to the Federal Emergency Management Agency (FEMA) Urban Search and Rescue program. **The amendment was adopted on a voice vote.**

<u>Lynch (D-MA)</u> – The amendment cuts the Office of the Undersecretary for Management by \$15.7 million, and adds the funds to TSA's Surface Transportation Security. **The amendment was adopted on a voice vote.**

<u>Tipton (R-CO)/Polis (D-CO)</u> – The amendment cuts \$7.7 million from CBP Automation Modernization, which develops IT systems for CBP missions, and adds the funds to FEMA's Pre-Disaster Mitigation grant program. **The amendment was adopted on a voice vote.**

<u>Tipton (R-CO)</u> – The amendment cuts \$4 million in funding from the administrative budget at TSA, and adds \$3 million in funding for aviation security equipment at rural airports. **The amendment was adopted on a voice vote.**

<u>Hudson (R-NC)/Mica (R-FL)/ DeFazio (D-OR)</u> – The amendment cuts \$12.5 million for TSA Aviation Security Direction and Enforcement, and adds the funds to the Federal Flight Deck Officers program, restoring it to the fiscal year 2013 level. **The amendment was adopted on a voice vote.**

<u>Mica (R-FL)</u> – The amendment cuts \$32 million from a TSA administrative account, and adds the funds to TSA's Screening Partnership Program for privatized screenings. **The amendment was adopted on a voice vote.**

<u>Brownley (D-CA)</u> – The amendment cuts, and then adds back, \$97.5 million for FEMA port security grants. The intent of the amendment was to discuss the importance of these grants. **The amendment was adopted on a voice vote.**

<u>Swalwell (D-CA)</u> – The amendment cuts, and then adds back, \$97.5 million for FEMA mass transit security grants. The intent of the amendment was to discuss the importance of these grants. **The amendment was adopted on a voice vote.**

<u>Pierluisi (D-PR)</u> – The amendment allows CBP in Puerto Rico to supplement funding from the Puerto Rico trust fund with general funding in the event of a shortfall. **The amendment was adopted on a voice vote.**

<u>Grimm (R-NY)</u> – The amendment prohibits funding to implement changes in TSA rules regarding sharp objects carried by passengers on commercial aircraft. **The amendment was adopted on a voice vote.**

<u>Cassidy (R-LA)/Grimm (R-NY)/Palazzo (R-MS)</u> – The amendment prohibits funding to implement, administer, or enforce section 1308(h) of the National Flood Insurance Program (NFIP) Act of 1968. This amendment would stop a scheduled NFIP rate increase from taking effect. **The amendment passed on a vote of 281-146.**

<u>Bustos (D-IL)</u> – The amendment prohibits funding for DHS to purchase U.S. flags that were not manufactured in America. **The amendment was adopted on a voice vote.**

<u>Meadows (R-NC)</u> – The amendment prohibits funding for DHS to initiate any new ammunition purchase until DHS submits a report on these purchases to Congress. **The amendment passed on a vote of 234-192.**

<u>Grayson (D-FL) EN BLOC</u> – The amendment prohibits funding for: 1) awarding contracts to any company convicted of a range of crimes or with delinquent taxes in excess of \$3,000 within a three-year contract; 2) from being used in contravention of the First, Second, or Fourth Amendments of the Constitution; and 3) from being used to purchase or operate armed, unmanned, aerial vehicles. **The amendment was adopted on a voice vote.**

<u>Collins (R-GA)</u> – The amendment prohibits funding for use in contravention of section 236(c) of the Immigration and Nationality Act, which sets mandatory detention requirements. **The amendment was adopted on a voice vote.**

<u>Salmon (R-AZ)</u> – The amendment prohibits any funding for use in contravention of section 642(a) of the Illegal Immigration Reform and Immigrant Responsibility Act of 1996, which prohibits funding for "sanctuary cities." **The amendment was adopted on a voice vote.**

<u>Jackson-Lee (D-TX)</u> – The amendment restates current law regarding the deployment of Federal Air Marshals. **The amendment was adopted on a voice vote.**

<u>Gingrey (R-GA)</u> – The amendment prohibits funding in the bill from being used in contravention of section 287(g) of the Immigration and Nationality Act. **The amendment was adopted on a voice vote.**

<u>Flores (R-TX)</u> – The amendment prohibits funds to implement a regulation under the Energy Independence and Security Act (section 526). The regulation prohibits federal contracts for alternative fuels unless the alternative fuels are proven to produce less greenhouse gas than conventional fuels. **The amendment was adopted on a voice vote.**

<u>Meehan (R-PA)</u> – The amendment prohibits funding for CBP pre-clearance facility operations at the Abu Dhabi International Airport. **The amendment was adopted on a voice vote.**

<u>Lujan (D-NM)</u> – The amendment cuts \$10 million from the DHS Office of the Chief Financial Officer, and adds the funds to FEMA state and local grants. **The amendment was adopted on a vote of 287-136.**

<u>Engel (D-NY)</u> – The amendment prohibits funding to lease or purchase new light-duty vehicles for any executive/government fleet, except in accordance with a Presidential Memorandum on energy-efficient vehicles. **The amendment was adopted on a voice vote.**

<u>King (R-IA)</u> — The amendment prohibits funds for categorical discretion regarding the enforcement of immigration laws. **The amendment was adopted on a vote of 234-201.**

<u>Ellison (D-MN)</u> – The amendment prohibits funds for use in contravention of several existing civil rights laws. **The amendment was adopted on a voice vote**.

<u>Barletta (R-PA)</u> – The amendment prohibits funding for the Office for Secretary and Executive Management to be used for official reception and representation expenses, until the Secretary of Homeland Security fully implements the biometric entry and exit data system authorized in the Intelligence Reform and Terrorism Prevention Act of 2004. **The amendment was adopted on a voice vote.**
