**AMENDMENT TO LEGISLATIVE BRANCH  
APPROPRIATIONS BILL  
OFFERED BY MR. KINGSTON OF GEORGIA**

At the appropriate place in the Committee Report under the heading "Government Accountability Office", insert the following:

Pursuant to the Consolidated Appropriations Act of 2005, the Government Accountability Office was required to analyze the cost, cost effectiveness, benefits, and feasibility of the Architect of the Capitol entering into contracts with private entities for the management and operation of the various functions and duties of the Office of the Architect of the Capitol. As part of that effort, the Government Accountability Office issued an analysis of the feasibility of privatizing the operation of the Capitol Power Plant. However, that analysis did not include a full cost savings analysis that considered other options, and the Committee is therefore concerned that it does not provide a complete answer to the question of the feasibility of privatizing the operation of the Plant. The Committee directs the Government Accountability Office to provide to Congress not later than one year after enactment an update to the original analysis that includes a

full cost savings analysis (using current data) of privatizing the Capitol Power Plant. The Government Accountability Office shall provide recommendations based on its findings.
