A NEW DIRECTION FOR FUNDING THE NEEDS OF OUR VETERANS

H.R. 2642, The Military Construction and Veterans Affairs Appropriations Act of 2008

This bill sent a clear message to America's servicemen and women that House Democrats recognize our veterans as a cost of war. The bill provided the largest increase in funding for veterans health care in the 77 year history of the VA. The bill provided an increase of \$6.7 billion over FY 2007 and \$3.6 billion over the Administration's request for veterans' programs. The bill was passed by the House of Representatives on June 15, 2007 and the Senate on September 6, 2007.

Status: Language from H.R. 2642 added to H.R. 3043 and passed by the House November 6, 2007; Pending action in the Senate

H.R. 2206, U.S. Troop Readiness, Veterans' Care, Katrina Recovery, and Iraq Accountability Appropriations Act of 2007

In May, Congress approved and the President signed into law the emergency supplemental funding package that included \$1.8 billion for veterans' programs, including \$1.3 billion for veterans' health programs, mental health care for Iraq and Afghanistan veterans and VA health facility maintenance. The bill also included \$2.1 billion for military health care, including resources for Post-traumatic Stress Disorder and Traumatic Brain Injury care and research.

Status: Became Public Law 110-28 on May 25, 2007

H.J.Res. 20, Further Continuing Appropriations for Fiscal Year 2007

The bill that funded the government, including the Department of Veterans Affairs, for the remainder of the fiscal year provided \$32.3 billion for veterans' health care, an increase of \$3.6 billion over FY 2006 levels. This funding measure was made necessary by the inability of the Republican Congress to pass a veterans' funding bill last year. The Department of Veterans Affairs was forced to operate at prior year funding levels at the start of the fiscal year on October 1, 2006. This bill was signed into law in February 2007.

Status: Became Public Law 110-5 on February 15, 2007

LEGISLATIVE UPDATE
A New Direction for Our Nation's Veterans

110th Congress – First Session

Legislation Enacted Into Law

P.L. 110-111 (H.R. 1284) – Veterans' Compensation Cost-of-Living Adjustment Act of 2007

- Directs the VA to provide a cost-of-living adjustment (COLA), effective as of December 1, 2007, to the rates of disability compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for survivors of certain service-connected disabled veterans. Requires that the COLA be the same percentage as the increase in benefits provided under title II (Old Age, Survivors and Disability Insurance) of the Social Security Act, on the same effective date.

Signed into law November 5, 2007

P.L. 110-110 (H.R. 327) – The Joshua Omvig Veterans Suicide Prevention Act

- Directs the VA to develop and implement a comprehensive program to reduce the incidence of suicide among veterans, including counseling and treatment, training of VA health care personnel, screening veterans for risk factors of suicide, designation of suicide prevention counselors at all VA medical facilities, mental health research, and a 24-hour toll-free hotline.

Signed into law November 5, 2007

P.L. 110-45 (S. 229) – A bill to designate a Federal building in Albuquerque, New Mexico, as the “Raymond G. Murphy Department of Veterans Affairs Medical Center”

- Names the VA Medical Center in Albuquerque, New Mexico, after Raymond G. Murphy, a Congressional Medal of Honor recipient.

Signed into law July 5, 2007

P.L. 110-28 (H.R. 2206) – U.S. Troops Readiness, Veterans' Care, Katrina Recovery, and Iraq Accountability Appropriations Act of 2007

- Provides \$1.8 billion for veterans, including funding to address increased demand due to servicemembers returning from Iraq and Afghanistan, mental health care, readjustment care, and polytrauma care.

Signed into law May 25, 2007

P.L. 110-5 (H.J. Res. 20) – Revised Continuing Appropriations Resolution, 2007

- Provides VA funding for FY 2007, which ends on September 30, 2007, including a \$3.6 billion increase for veterans' health care.

Signed into law February 15, 2007

Legislation Pending Action by the President

H.R. 2546 – To Designate the Department of Veterans Affairs Medical Center in Asheville, North Carolina, as the “Charles George Department of Veterans Affairs Medical Center”

- Names the VA Medical Center in Asheville, North Carolina, after Charles George, a Congressional Medal of Honor recipient.

Passed by the House of Representatives June 25, 2007; Passed by the Senate November 1, 2007; Pending action by the President

H.R. 1808 – A bill to designate the Department of Veterans Affairs Medical Center in Augusta, Georgia, as the "Charlie Norwood Department of Veterans Affairs Medical Center"

- Names the VA Medical Center in Augusta, Georgia, after Charlie Norwood, a former Member of the House of Representatives and a recipient of the Combat Medical Badge and two Bronze Stars.

Passed by the House of Representatives October 23, 2007; Passed by the Senate October 31, 2007; Pending action by the President

Passed by the House of Representatives and Senate

H.R. 797 – The Dr. James Allen Veteran Vision Equity Act

- Enables veterans who receive veterans disability compensation for impairment of vision in one eye to be eligible to receive additional disability compensation for impairment of vision in the eye that is not service-connected, where that impairment in each eye is to a visual acuity of 20/200 or less, or of a peripheral field of 20 degrees or less (the definition of “legal blindness” adopted by all 50 States and the Social Security Administration). Requires the VA to provide HHS with information for comparison with the National Directory of New Hires for income verification purposes with respect to individuals under age 65 in order to determine eligibility for certain veteran benefits and services. Extends to 2009 VA's authority to provide an educational allowance to persons performing

qualifying work-study activities. Authorizes the VA, in lieu of furnishing a headstone or marker for the grave of a veteran in a private cemetery, to furnish a bronze "V" to be attached to a headstone or marker furnished at private expense.

Passed by the House of Representatives March 21, 2007; Passed by the Senate with an amendment November 2, 2007; Pending House and Senate compromise language

H.R. 1585 – National Defense Authorization Act for Fiscal Year 2008

- DOD authorization bill contains text of H.R. 1538, the Wounded Warriors Assistance Act of 2007 (except for veterans' mileage reimbursement provision).

Passed by the House of Representatives May 17, 2007; Passed by the Senate with an amendment on October 1, 2007

H.R. 2642 – Military Construction and Veterans Affairs Appropriations Act for FY 2008

- FY 2008 VA funding bill provides for a \$4.4 billion increase over FY 2007 and \$1.9 billion over the Administration's request for the Veterans Health Administration. Provides for \$43.2 billion for overall discretionary funding for veterans, an increase of \$6.7 billion over FY 2007 and \$3.8 billion over the Administration's request.

Passed by the House of Representatives June 15, 2007; Passed by the Senate with an amendment September 6, 2007

H.R. 1538 – Wounded Warrior Assistance Act of 2007

- Requires assignment of a Medical Care Case Manager to each servicemember receiving outpatient care at a DOD facility; requires the DOD to provide a written transition plan for veterans' programs and the establishment of a formal process to transmit DOD records to VA on or before date of separation of servicemember. Calls for a joint separation and evaluation physical and fully interoperable medical records between VA and DOD. In addition, mandates reports on TBI classification, an evaluation of the Polytrauma Liaison Officer program, and an evaluation and report on the VA and DOD disability evaluation systems. Provides for increase in mileage reimbursement and elimination of deductible for veterans traveling for VA medical care.

Passed by the House of Representatives March 28, 2007; Passed by the Senate with an amendment on July 25, 2007

Legislation Passed by the House of Representatives

H.R. 513 – The National Heroes Credit Protection Act

- Amends the Servicemembers Civil Relief Act to enhance the protection of credit ratings of active duty military personnel who are activated for military service.

Passed by the House of Representatives November 5, 2007; Referred to the Senate

H.Res. 770 – National Veterans History Project Week

- Expresses support for the designation of a National Veterans History Project Week to encourage public participation in a nationwide project that collects and preserves the stories of the men and women who served our nation in times of war and conflict.

Passed by the House of Representatives November 5, 2007

H.Con.Res. 60 – Veterans Educate Today's Students Day

- Expresses support for the goals of Veterans Educate Today's Students (VETS) Day.

Passed by the House of Representatives November 5, 2007; Referred to the Senate

H.Res. 744 – Recognizing the Contributions of Native American Veterans

- Recognizes the contributions of Native American veterans and to calls upon the President to issue a proclamation urging the people of the United States to observe a day in honor of Native American veterans.

Passed by the House of Representatives November 5, 2007

H.R. 2408 – A bill to designate the Department of Veterans Affairs outpatient clinic in Green Bay, Wisconsin, as the "Milo C. Huempfner Department of Veterans Affairs Outpatient Clinic"

- Names the VA outpatient clinic in Green Bay, Wisconsin, after Milo C. Huempfner, a recipient of the Distinguished Service Cross.

Passed by the House of Representatives October 23, 2007; Referred to the Senate

H.Res. 680 – Condemning the Actions of September 7, 2007, Resulting in Damage to the Vietnam Veterans War Memorial

- This House Resolution condemns all attacks upon the memory of veterans and their service to the United States, as exemplified by the incident of vandalism of September 7, 2007.

Passed by the House of Representatives October 23, 2007

H.Res. 237 – Supporting and Encouraging Greater Support for Veterans Day Each Year

- This House Resolution encourages Americans to demonstrate support of veterans on Veterans Day each year by treating that day as a special day of reflection. The resolution also requests the President to issue a proclamation in connection with the observance of Veterans Day.

Passed by the House of Representatives October 23, 2007

H.R. 2874 – Veterans' Health Care Improvement Act of 2007

- Creates a transportation grant program for rural veterans, provides the VA with greater flexibility in meeting the mental health care and readjustment needs of veterans, and provides for assistance and support to low-income veterans and their families fighting homelessness.

Passed by the House of Representatives July 30, 2007; Referred to the Senate

H.R. 2623 – To amend title 38, United States Code, to Prohibit the Collection of Copayments for all Hospice Care Furnished by the Department of Veterans Affairs

- Prohibits the collection of copayments for all hospice care provided by the VA.

Passed by the House of Representatives July 30, 2007; Referred to the Senate

H.R. 1315 – Veterans' Benefits Improvement Act of 2007

- Provides specially adapted housing assistance to servicemembers transitioning to veteran status and creates a scholarship program for students seeking careers assisting in the rehabilitation of blind veterans.

Passed by the House of Representatives July 30, 2007; Referred to the Senate

H.R. 23 – Belated Thank You to the Merchant Mariners of World War II Act of 2007

- Creates a Merchant Mariner Equity Fund, subject to the availability of appropriations, to provide a monthly benefit of \$1,000 to surviving Merchant Mariners of World War II.

Passed by the House of Representatives July 30, 2007; Referred to the Senate

H.R. 2602 – To Name the Department of Veterans Affairs Medical Facility in Iron

Mountain, Michigan, as the “Oscar G. Johnson Department of Veterans Affairs Medical Facility”

- Names the VA Medical Facility in Iron Mountain, Michigan, after Oscar G. Johnson, a Congressional Medal of Honor recipient.

Passed by the House of Representatives June 25, 2007; Referred to the Senate

H.R. 366 – To Designate the Department of Veterans Affairs Outpatient Clinic in Tulsa, Oklahoma, as the “Ernest Childers Department of Veterans Affairs Outpatient Clinic”

- Names the VA Outpatient Clinic in Tulsa, Oklahoma, after Ernest Childers, a Congressional Medal of Honor recipient.

Passed by the House of Representatives June 25, 2007; Referred to the Senate

H.R. 2199 – Traumatic Brain Injury Health Enhancement and Long-Term Support Act of 2007

- Improves and expands the VA’s ability to care for veterans returning from Iraq and Afghanistan with traumatic brain injuries (TBI), including research, screening, care coordination, and working with non-VA providers to provide optimal care.

Passed by the House of Representatives May 23, 2007; Referred to the Senate

H.R. 612 – Returning Servicemember VA Healthcare Insurance Act of 2007

- Provides an additional three years (for a total of five years) of free VA health care for veterans returning from Iraq and Afghanistan.

Passed by the House of Representatives May 23, 2007; Referred to the Senate

H.R. 1470 – Chiropractic Care Available to All Veterans Act

- Requires the VA to provide chiropractic care and services to veterans through VA medical centers and clinics at no fewer than 75 medical centers by December 31, 2009, and all medical centers by December 31, 2011.

Passed by the House of Representatives May 23, 2007; Referred to the Senate

H.R. 67 – Veterans Outreach Improvement Act of 2007

- Establishes a grant program to assist states to better provide outreach services to veterans regarding benefits and services.

Passed by the House of Representatives May 23, 2007; Referred to the Senate

H.R. 2239 – Early Access to Vocational Rehabilitation and Employment Benefits Act

- Extends vocational rehabilitation benefits to members of the Armed Forces who are hospitalized or receiving outpatient medical care, services, or who are determined to have a permanent, total disability incurred or aggravated in the line of duty; and, who are likely to be discharged or released from active service for such a disability.

Passed by the House of Representatives May 23, 2007; Referred to the Senate

H.R. 1660 – To Direct the Secretary of Veterans Affairs to Establish a National Cemetery for Veterans in the Southern Colorado Region

- Directs the VA to establish a national cemetery in Southern Colorado.

Passed by the House of Representatives May 23, 2007; Referred to the Senate

H. Res. 392 – Urging Americans and People of all Nationalities to Visit the American Cemeteries, Memorials and Markers

- This House Resolution urges Americans and people of all nationalities to visit the American Cemeteries, Memorials and Markers abroad, where the spirit of American generosity, sacrifice, and courage are displayed and commemorated.

Passed by the House of Representatives May 23, 2007

H. Res. 413 – Recognizing the Service of United States Merchant Marine Veterans

- This House Resolution recognizes, on National Maritime Day, the heroic and invaluable sacrifices that the U.S. Merchant Marine veterans have made to help ensure our nation's prosperity and safety.

Passed by the House of Representatives May 22, 2007

H.R. 1642 – Homeless Veterans Housing at Sepulveda Ambulatory Care Center Promotion Act

- Directs the VA to ensure that a lease for a homeless housing project at the Sepulveda Ambulatory Care Center in North Hills, California, be operated as a sober living facility for veterans only.

Passed by the House of Representatives May 7, 2007

H. Con. Res. 5 – Expressing Support for the Designation and Goals of “Hire a Veteran Week” and Encouraging the President to Issue a Proclamation Supporting Those Goals

- Resolution expresses support for the designation and goals of “Hire a Veteran Week.”

Passed by the House of Representatives on January 31, 2007; Referred to the Senate

Legislation Passed by the House Committee on Veterans’ Affairs

H.R. 3882 – The Fair Benefits for National Guard and Reserve Act

- Changes the length of service on active duty required for receiving certain education benefits. The bill seeks to correct a problem that was recognized as a result of the mobilization of the Minnesota National Guard. Currently, to qualify for Active Duty Chapter 30 benefits, a member must be obligated for a two year term and serve 20 continuous months. H.R. 3882 still requires 20 months of service but changes the obligated term to less than three years, which would allow the Guard members to receive Active Duty benefits.

Approved by the House Committee on Veterans’ Affairs November 7, 2007

H.R. 760 – Filipino Veterans Equity Act of 2007

- Restores full veterans’ status to Filipino veterans of World War II. This status was denied under the Rescission Acts of 1946. Permits Filipino veterans of World War II with service-connected disabilities and those eligible for Dependency and Indemnity Compensation (DIC) to receive the same benefits as other U.S. veterans. Permits Filipino veterans of World War II and survivors residing in the United States to receive pensions and death pensions paid at the same rate and under the same conditions as U.S. veterans while providing non-U.S. citizens residing outside the U.S. to be paid at a lower flat rate. Places mileage reimbursement rates for the veterans’ beneficiary program at the same level as government employees; increases maximum amount of insurance coverage for disabled veterans from \$20,000 to \$30,000; expands existing accelerated education benefit list to include commercial drivers’ license training; excludes benefits under the Montgomery GI Bill from being considered as income for purposes of determining eligibility for education grants or student loans; adds osteoporosis to disabilities presumed to be service connected in former POWs with PTSD; and, provides cost-of-living increases for temporary DIC for surviving spouses with children.

Approved by the House Committee on Veterans’ Affairs on July 17, 2007

A NEW DIRECTION FOR VETERANS OUTREACH

Under the leadership of the new Majority, the House Veteran's Affairs Committee, with the direction of Chairman Bob Filner, implemented a series of symposiums to raise the level of awareness on issues important to our nation's veterans and their dependents. This unprecedented style of meeting allows interested stakeholders an opportunity to present new and unique ways of addressing veterans' issues and engage in a dialogue with experts on a wide range of subject matters.

Symposium on Traumatic Brain Injury – July 18, 2007

Chairman Filner led a symposium to address innovative and comprehensive ways to provide treatment for traumatic brain injury (TBI). TBI is considered the signature injury of the war in Iraq. Among veterans and service members from Iraq and Afghanistan treated at Walter Reed for injuries of any type, approximately 65% have TBI as a primary diagnosis or simultaneous injury. Participants discussed the need for a coordinated effort for case management for TBI patients, not just during the initial injury phase, but throughout the life of the patient. The importance of educating and training family members on what to expect from their TBI patient was emphasized during the symposium.

Roundtable Discussion on the Claims Backlog at the VA – May 23, 2007

The Committee held a roundtable discussion between experts and interested stakeholders to discuss various ideas to reduce the claims backlog and improve the claims process. It takes an average of 177 days for a disabled service member to get a VA claim processed – nearly double the 89.5 day wait civilians face in a private health insurance system. The roundtable provided stakeholders an opportunity to present new and unique ways of addressing the growing claims backlog by bringing together top Administration officials, professors, legal experts and veteran service representatives.

Symposium on Post Traumatic Stress Disorder – May 16, 2007

The Chairman held a symposium to examine the issue of Post-traumatic Stress Disorder (PTSD) in light of the need to improve mental health service delivery to veterans. The symposium brought together experts with wide ranges of expertise to help identify the specific issues facing our veterans. This was an excellent venue to bring about productive problem solving strategies for the veteran community.

Stakeholder's Summit – February 12, 2007

Chairman Filner held a "Stakeholder's Summit" where various veterans' service organizations (VSOs) were invited to participate. While this did not replace the formal process of testifying before the committee, it did offer the VSOs the opportunity to raise important issues in an informal setting. The meeting was held on February 12, 2007, and included issues such as Post-traumatic Stress Disorder, improving education benefits, the claims backlog, elimination of the Survivor Benefit Plan Dependency Indemnity Clause, and employment opportunities for new and existing veterans.

Reinstatement of Joint Hearings

In January 2007, the Democratic congressional leadership from both the House of Representatives and Senate made good on their commitment to America's veterans. In a joint statement, House Speaker Nancy Pelosi, Senate Majority Leader Harry Reid, House Veterans' Affairs Committee Chairman Bob Filner, and Senate Veterans' Affairs Committee Chairman Daniel Akaka announced the reinstatement of the traditional joint hearings process in which veterans and military service organizations appear before the Veterans' Affairs Committees. Having the benefit of the joint hearings is a welcomed change from the previous Congress where the GOP leadership drastically limited the ability of allowing veterans' service organizations to testify before the Committee.

The joint House and Senate hearings are traditionally held in the spring, after the President submits his budget request to Congress. The hearings are generally tied to the veterans' service organizations' national meetings occurring in Washington, D.C.

A NEW DIRECTION FOR HOUSE COMMITTEE ON VETERANS' AFFAIRS HEARINGS

After ten months, the House Committee of Veteran's Affairs in the new Congress has held almost 60 hearings to better understand the needs of America's heroes on a wide-range of topics that affect veterans every day.

Under Democratic leadership, the House Committee on Veterans' Affairs has fought to ensure that Congress keeps the promises that have been made to our veterans, including the new generation of veterans returning from active duty along with past generations of veterans who rely on the VA for the benefits they have earned and deserve.
