### **CANDIDATE CRITERIA:**

- Applicant must live in the 5th Congressional District of Alabama.
- Applicant must meet all Academy requirements.
- Applicant must be at least 17 years old, and not have passed their 23rd birthday by July 1 of the year of entry to the Military, Naval or Air Force Academies and have not passed their 25th birthday for the Merchant Marine Academy.
- Applicant must be unmarried, not be pregnant, and have no legal obligation for support to children or other dependents.
- Applicant must be a United States Citizen by the Congressional Nomination application deadline date.

## INSTRUCTIONS FOR APPLICATION FOR CONGRESSIONAL NOMINATION

### **DEADLINE FOR SUBMISSION OF DOCUMENTS: NOVEMBER 7, 2014**

Applicants for Congressional Nomination for the **Class of 2019** must submit the **CONGRESSIONAL NOMINATION FORM** and other **required documents** (see checklist) by **Friday, November 7, 2014 to:**

### **CANDIDATE INTERVIEWS:**

All required documents must be received **no later than Friday, November 7, 2014** to complete each applicant's file. Eligible applicants with a complete file will be scheduled for an interview. Interviews will be held in November. Applicants will be notified as to date/time of their interview.

### **NOMINATIONS AND APPOINTMENTS:**

A member of Congress may nominate up to ten applicants per vacancy and is not permitted to have more than five men or women in each academy at one time. Generally, a vacancy is created only by graduation. A nomination by Congressman Brooks does not guarantee an appointment to an academy.

Congressman Brooks has established a nominating board. The board will review applications, interview prospective candidates and make final selection of Alabama District 5 nominees to be submitted to the academies. Nominations are based on a "whole person" evaluation. Factors such as academic achievement, extracurricular activities, leadership skills, physical aptitude, character and motivation are taken into consideration and compared with other applicants. Nominations will be determined using the competitive method with all nominees submitted unranked to the academies, allowing equal opportunity for each candidate nominated from the district.

Some academies will begin to notify candidates of their admission status as early as January. All offers of appointment are generally sent out by May.

### **REMINDERS:**

- EACH ACADEMY HAS ITS OWN SELECTION PROCESS FOR ADMITTANCE. APPLICANTS MUST COMPLETE THE APPLICATION PROCESS FOR EACH ACADEMY THAT THEY ARE CONSIDERING ATTENDING.
- MEDICAL EXAMINATION: IT IS ADVISABLE THAT APPLICANTS SCHEDULE AN APPOINTMENT WITH THE DEPARTMENT OF DEFENSE EXAMINATION REVIEW BOARD (DoDMERB) AS SOON AS POSSIBLE. MEDICAL SCHEDULING AND EVALUATION ARE TIME-CONSUMING PROCESSES AND MAY TAKE FROM SIX WEEKS TO FOUR MONTHS.
- TO BETTER THEIR CHANCES OF OBTAINING A NOMINATION, APPLICANTS MAY WISH TO APPLY TO EVERY NOMINATING SOURCE FOR WHICH THEY ARE ELEGIBLE. EVERYONE IS ELIGIBLE TO APPLY FOR A NOMINATION FROM THEIR U.S. REPRESENTATIVE, U.S. SENATORS AND THE VICE-PRESIDENT. (VISIT THEIR WEBSITES FOR DETAILS.) THERE ARE ALSO SERVICE CONNECTED NOMINATING SOURCES.

**TRANSCRIPTS**

Official transcripts from your most recent high school and, if applicable, college are required.

**SAT / ACT SCORES**

In order to be considered for a nomination, you must have taken the SAT/ACT prior to October 2014 in order to meet **our November 7, 2014 deadline**. However, your test scores can be updated up to the time of your interview before the nominating board if your score is higher on a later test. You must have official copies of your scores sent to Congressman Brooks' Huntsville office. SAT code is 1226; ACT code is 7215.

**RECOMMENDATION FORMS**

Three (3) completed personal recommendation forms in sealed and signed envelopes from adult non-family members (for example, teacher, counselor, employer, coach, clergy, community leader, scoutmaster) are required. [Click here](#) for recommendation form. **It is your responsibility** to ensure that these forms are completed and returned to you in a timely manner and included in your packet.

**ESSAY**

A 150-200 word essay is required describing why you are interested in attending a service academy.

**RESUME**

Be sure to submit a current resume which includes extracurricular activities, leadership positions, academic and athletic accomplishments, and other relevant awards and distinctions.

**RECENT WALLET-SIZED PHOTO**

Please staple a photograph of yourself, no larger than 2.5" x 3", where indicated on the upper left-hand corner of the application.
