SUBJECT: Congressional Hearings on Disaster Relief

The following list of hearings presents information on congressional investigations held on federal disaster relief assistance provided after significant catastrophes have occurred in the United States. The listing, based upon a review of holdings in our files as well as a search of the database maintained by Congressional Information Services, Inc., (CIS), focuses only on those hearings in which Members or witnesses discussed the quality or quantity of assistance that was provided, or the needs of communities and victims after a catastrophe. Keywords used in the search included various terms associated with catastrophes, disasters, response, and relief.

The list does not include citations to hearings concerned with the adequacy of technology or other technical matters, the preparation of communities for terrorist attacks, pending legislation that would amend statutes authorizing disaster relief, or other matters not related to an investigation of the disaster relief assistance provided by the federal government. Hearing summaries set out by quotation marks are taken verbatim from the CIS entry for each hearing. Summaries not bracketed by quotation marks were developed based on an examination of the opening statement of the committee or subcommittee chair.
