Dear President Bush,


On May 4, 2004, the Office of Management and Budget (OMB) updated their accounting of expenditures from the Emergency Relief Fund. Despite a statutory requirement to update this report quarterly, this was the first report in a year. Like all previous reports, it does not separately identify the amount of aid provided to New York after 9/11 although OMB's own directive specifically requires such information. The OMB Bulletin states that "The report will separately identify the cumulative amounts provided to [New York, Virginia, and Pennsylvania]", but none of the reports issued to date has complied with this instruction. In light of OMB's continued refusal to provide an accounting of aid New York City received after the terrorist attacks we have three requests:

1. Again we ask you to direct OMB to provide a full accounting of recovery funds. A continued refusal can only be seen as proof New York will never receive the full \$21.4 billion you promised in a Rose Garden appearance on March 17, 2002.
2. Last month it was reported that Mayor Bloomberg is concerned that up to \$2.6 billion in aid may never be realized because the tax credits were over-valued. Do you agree with this report that up to \$2.6 billion of the tax credits may never be realized.
3. Considering that the \$21.4 billion aid package to New York does not include any assistance for lost tax revenue or treatment for people who are sick and/or injured as a direct result of 9/11, and provides a much smaller percentage for hazard mitigation compared to that provided after all other disasters -- among other needs -- do you feel the announced aid to New York is adequate?


