DETAILED SUMMARY AND ANALYSIS:

Louis Van Iersel has been [lauded](#) as "the most highly decorated surviving veteran of World War I" and is believed to be the first non-citizen to receive the Medal of Honor. During World War I he was deemed a hero by using his native language skills to spy on the enemy and carrying wounded soldiers to safety. After World War I he became a citizen, and when World War II broke out, he and his sons volunteered to serve. After being turned down by the Army due to his age, he managed to talk his way into the Marine Corps and served in the South Pacific. He died at the age of 93.
