Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2017, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	That the following sums are appropriated, out of any
2	money in the Treasury not otherwise appropriated, for the
3	Legislative Branch for the fiscal year ending September
4	30, 2017, and for other purposes, namely:

8	SALARIES AND EXPENSES
9	For salaries and expenses of the House of Represent-
10	atives, \$1,189,050,766, as follows:
11	House Leadership Offices
12	For salaries and expenses, as authorized by law,
13	\$22,278,891, including: Office of the Speaker,
14	\$6,645,417, including \$25,000 for official expenses of the
15	Speaker; Office of the Majority Floor Leader, \$2,180,048
16	including \$10,000 for official expenses of the Majority
17	Leader; Office of the Minority Floor Leader, \$7,114,471
18	including \$10,000 for official expenses of the Minority

- 10 STANDING COMMITTEES, SPECIAL AND SELECT
- 11 For salaries and expenses of standing committees,
- 12 special and select, authorized by House resolutions,
- 13 \$127,053,373: Provided, That such amount shall remain
- 14 available for such salaries and expenses until December
- 15 31, 2018, except that \$3,150,200 of such amount shall
- 16 remain available until expended for committee room up-
- 17 grading.
- 18 Committee on Appropriations
- 19 For salaries and expenses of the Committee on Ap-
- 20 propriations, \$23,271,004, including studies and examina-
- 21 tions of executive agencies and temporary personal serv-
- 22 ices for such committee, to be expended in accordance with
- 23 section 202(b) of the Legislative Reorganization Act of
- 24 1946 and to be available for reimbursement to agencies
- 25 for services performed: Provided, That such amount shall

- 1 remain available for such salaries and expenses until De-
- 2 cember 31, 2018.
- 3 Salaries, Officers and Employees
- 4 For compensation and expenses of officers and em-
- 5 ployees, as authorized by law, \$181,487,000, including:
- 6 for salaries and expenses of the Office of the Clerk, includ-
- 7 ing the positions of the Chaplain and the Historian, and
- 8 including not more than \$25,000 for official representa-
- 9 tion and reception expenses, of which not more than
- 10 \$20,000 is for the Family Room and not more than
- 11 \$2,000 is for the Office of the Chaplain, \$26,268,000; for
- 12 salaries and expenses of the Office of the Sergeant at
- 13 Arms, including the position of Superintendent of Garages
- 14 and the Office of Emergency Management, and including
- 15 not more than \$3,000 for official representation and re-
- 16 ception expenses, \$15,505,000, of which \$5,618,902 shall

- 6 Legislative Counsel of the House, \$8,979,000; for salaries
- 7 and expenses of the Office of Interparliamentary Affairs,
- 8 \$814,000; and for other authorized employees,
- 9 \$1,183,000.

- 12 resolution or law, \$272,328,000, including: supplies, mate-
- 13 rials, administrative costs and Federal tort claims,
- 14 \$3,625,000; official mail for committees, leadership of-

- 16 Government contributions for health, retirement, Social
- 17 Security, and other applicable employee benefits,

- 5 REQUIRING AMOUNTS REMAINING IN MEMBERS' REP-
- 6 RESENTATIONAL ALLOWANCES TO BE USED FOR
- 7 DEFICIT REDUCTION OR TO REDUCE THE FEDERAL

- 9 Sec. 101. (a) Notwithstanding any other provision
- 10 of law, any amounts appropriated under this Act for
- 11 "HOUSE OF REPRESENTATIVES—SALARIES AND
- 12 Expenses—Members' Representational Allow-
- 13 ANCES" shall be available only for fiscal year 2017. Any
- 14 amount remaining after all payments are made under such
- 15 allowances for fiscal year 2017 shall be deposited in the
- 16 Treasury and used for deficit reduction (or, if there is no
- 17 Federal budget deficit after all such payments have been
- 18 made, for reducing the Federal debt, in such manner as
- 19 the Secretary of the Treasury considers appropriate).
- 20 (b) Regulations.—The Committee on House Ad-
- 21 ministration of the House of Representatives shall have
- 22 authority to prescribe regulations to carry out this section.

- 3 DELIVERY OF BILLS AND RESOLUTIONS
- 4 Sec. 102. None of the funds made available in this
- 5 Act may be used to deliver a printed copy of a bill, joint
- 6 resolution, or resolution to the office of a Member of the
- 7 House of Representatives (including a Delegate or Resi-
- 8 dent Commissioner to the Congress) unless the Member
- 9 requests a copy.
- 10 Delivery of congressional record
- 11 Sec. 103. None of the funds made available by this
- 12 Act may be used to deliver a printed copy of any version
- 13 of the Congressional Record to the office of a Member of
- 14 the House of Representatives (including a Delegate or
- 15 Resident Commissioner to the Congress).
- 16 LIMITATION ON AMOUNT AVAILABLE TO LEASE VEHICLES
- 17 Sec. 104. None of the funds made available in this
- 18 Act may be used by the Chief Administrative Officer of
- 19 the House of Representatives to make any payments from
- 20 any Members' Representational Allowance for the leasing
- 21 of a vehicle, excluding mobile district offices, in an aggre-
- 22 gate amount that exceeds \$1,000 for the vehicle in any
- 23 month.

1	LIMITATION ON PRINTED COPIES OF U.S. CODE TO
2	HOUSE
3	SEC. 105. None of the funds made available by this
4	Act may be used to provide an aggregate number of more
5	than 50 printed copies of any edition of the United States
6	Code to all offices of the House of Representatives.
7	DELIVERY OF REPORTS OF DISBURSEMENTS
8	SEC. 106. None of the funds made available by this
9	Act may be used to deliver a printed copy of the report
10	of disbursements for the operations of the House of Rep-
11	resentatives under section 106 of the House of Represent-
12	atives Administrative Reform Technical Corrections Act
13	(2 U.S.C. 5535) to the office of a Member of the House
14	of Representatives (including a Delegate or Resident Com-
15	missioner to the Congress).
16	DELIVERY OF DAILY CALENDAR
17	SEC. 107. None of the funds made available by this
18	Act may be used to deliver to the office of a Member of
19	the House of Representatives (including a Delegate or
20	Resident Commissioner to the Congress) a printed copy
21	of the Daily Calendar of the House of Representatives
22	which is prepared by the Clerk of the House of Represent-
23	atives.

1	DELIVERY OF CONGRESSIONAL PICTORIAL DIRECTORY
2	SEC. 108. None of the funds made available by this
3	Act may be used to deliver a printed copy of the Congres-
4	sional Pictorial Directory to the office of a Member of the
5	House of Representatives (including a Delegate or Resi-
6	dent Commissioner to the Congress).
7	ADJUSTMENTS TO COMPENSATION
8	SEC. 109. Notwithstanding any other provision of
9	law, no adjustment shall be made under section 601(a)
10	of the Legislative Reorganization Act of 1946 (2 U.S.C.
11	4501) (relating to cost of living adjustments for Members
12	of Congress) during fiscal year 2017.
13	OVERSEAS TRAVEL TO ACCOMPANY MEMBERS OF HOUSE
14	LEADERSHIP
15	Sec. 110. (a) Travel Authorized.—
16	(1) In general.—A member of the Capitol Po-
17	lice may travel outside of the United States for offi-
18	cial duty if—
19	(A) that travel is with, or in preparation
20	for, travel of a Member of the House of Rep-
21	resentatives who holds a position in a House
22	Leadership Office, including travel of the Mem-
23	ber as part of a congressional delegation; and

1	(B) the Sergeant at Arms of the House of
2	Representatives gives prior approval to the trav-
3	el of the member of the Capitol Police.
4	(2) Definitions.—In this subsection—
5	(A) the term "House Leadership office"
6	means an office of the House of Representatives
7	for which the appropriation for salaries and ex-
8	penses of the office for the year involved is pro-
9	vided under the heading "House Leadership Of-
10	fices" in the act making appropriations for the
11	Legislative Branch for the fiscal year involved;
12	(B) the term "Member of the House of
13	Representatives" includes a Delegate or Resi-
14	dent Commissioner to the Congress; and
15	(C) the term "United States" means each
16	of the several States of the United States, the
17	District of Columbia, and the territories and
18	possessions of the United States.
19	(b) Reimbursement From Sergeant at Arms.—
20	(1) In general.—From amounts made avail-
21	able for salaries and expenses of the Office of the
22	Sergeant at Arms of the House of Representatives,
23	the Sergeant at Arms of the House of Representa-
24	tives shall reimburse the Capitol Police for the over-

time pay, travel, and related expenses of any mem-

1 ber of the Capitol Police who travels under the au-2 thority of this section. (2)3 USE OF **AMOUNTS** RECEIVED.—Any 4 amounts received by the Capitol Police for reim-5 bursements under paragraph (1) shall be credited to 6 the accounts established for the general expenses or 7 salaries of the Capitol Police, and shall be available 8 to carry out the purposes of such accounts during 9 the fiscal year in which the amounts are received 10 and the following fiscal year. 11 (c) Effective Date.—This section shall apply with 12 respect to fiscal year 2017 and each succeeding fiscal year. 13 JOINT ITEMS 14 For Joint Committees, as follows: 15 JOINT ECONOMIC COMMITTEE 16 For salaries and expenses of the Joint Economic Committee, \$4,203,000, to be disbursed by the Secretary of the Senate. 18 19 Joint Committee on Taxation 20 For salaries and expenses of the Joint Committee on 21 Taxation, \$10,095,000, to be disbursed by the Chief Ad-22 ministrative Officer of the House of Representatives. 23 For other joint items, as follows:

3	For salaries and expenses of the Office of Congres-
4	sional Accessibility Services, \$1,429,000, to be disbursed
5	by the Secretary of the Senate.
6	CAPITOL POLICE
7	SALARIES
8	For salaries of employees of the Capitol Police, in-
9	cluding overtime, hazardous duty pay, and Government
10	contributions for health, retirement, social security, pro-
11	fessional liability insurance, and other applicable employee
12	benefits, \$325,300,000 of which overtime shall not exceed
13	\$35,305,000 unless the Committee on Appropriations of
14	the House and Senate are notified, to be disbursed by the
15	Chief of the Capitol Police or his designee.
16	GENERAL EXPENSES
17	For necessary expenses of the Capitol Police, includ-
18	ing motor vehicles, communications and other equipment,
19	security equipment and installation, uniforms, weapons,
20	supplies, materials, training, medical services, forensic
21	services, stenographic services, personal and professional
22	services, the employee assistance program, the awards pro-
23	gram, postage, communication services, travel advances,
24	relocation of instructor and liaison personnel for the Fed-
25	eral Law Enforcement Training Center, and not more

- 1 than \$5,000 to be expended on the certification of the
- 2 Chief of the Capitol Police in connection with official rep-
- 3 resentation and reception expenses, \$66,000,000, to be
- 4 disbursed by the Chief of the Capitol Police or his des-
- 5 ignee: Provided, That, notwithstanding any other provi-
- 6 sion of law, the cost of basic training for the Capitol Police
- 7 at the Federal Law Enforcement Training Center for fis-
- 8 cal year 2017 shall be paid by the Secretary of Homeland
- 9 Security from funds available to the Department of Home-
- 10 land Security.
- 11 Administrative Provision
- 12 AUTHORITY TO DISPOSE OF FORFEITED AND ABANDONED
- 13 PROPERTY AND TO ACCEPT SURPLUS OR OBSOLETE
- 14 PROPERTY OFFERED BY OTHER FEDERAL AGENCIES
- SEC. 1001. (a) Section 1003(a) of the Legislative
- 16 Branch Appropriations Act, 2003 (2 U.S.C. 1906(a)) is
- 17 amended by striking "surplus or obsolete property of the
- 18 Capitol Police" and inserting the following: "surplus or
- 19 obsolete property of the Capitol Police, and property which
- 20 is in the possession of the Capitol Police because it has
- 21 been disposed, forfeited, voluntarily abandoned, or un-
- 22 claimed,".
- 23 (b) Upon notifying the Committees of Appropriations
- 24 of the House of Representatives and Senate, the United
- 25 States Capitol Police may accept surplus or obsolete prop-

1	erty offered by another Federal department, agency, or of-
2	fice.

6	OFFICE OF COMPLIANCE
7	Salaries and Expenses
8	For salaries and expenses of the Office of Compli-
9	ance, as authorized by section 305 of the Congressional
10	Accountability Act of 1995 (2 U.S.C. 1385), \$3,959,000,
11	of which \$450,000 shall remain available until September
12	30, 2018: Provided, That not more than \$500 may be ex-
13	pended on the certification of the Executive Director of
14	the Office of Compliance in connection with official rep-
15	resentation and reception expenses.
16	CONGRESSIONAL BUDGET OFFICE
17	Salaries and Expenses
18	For salaries and expenses necessary for operation of
19	the Congressional Budget Office, including not more than
20	\$6,000 to be expended on the certification of the Director
21	of the Congressional Budget Office in connection with offi-
22	cial representation and reception expenses, \$46,500,000.

1	Administrative Provision
2	ESTABLISHMENT OF SENIOR LEVEL POSITIONS
3	Sec. 1101. (a) Notwithstanding the fourth sentence
4	of section 201(b) of the Congressional Budget and Im-
5	poundment Control Act of 1974 (2 U.S.C. 601(b)), the
6	Director of the Congressional Budget Office may establish
7	and fix the compensation of senior level positions in the
8	Congressional Budget Office to meet critical scientific,
9	technical, professional, or executive needs of the Office.
10	(b) Limitation on Compensation.—The annual
11	rate of pay for any position established under this section
12	may not exceed the annual rate of pay for level II of the
13	Executive Schedule.
14	(c) Effective Date.—This section shall apply with
15	respect to fiscal year 2017 and each succeeding fiscal year.
16	ARCHITECT OF THE CAPITOL
17	Capital Construction and Operations
18	For salaries for the Architect of the Capitol, and
19	other personal services, at rates of pay provided by law;
20	for all necessary expenses for surveys and studies, con-
21	struction, operation, and general and administrative sup-
22	port in connection with facilities and activities under the
23	care of the Architect of the Capitol including the Botanic
24	Garden; electrical substations of the Capitol, Senate and
25	House office buildings, and other facilities under the juris-

- 1 diction of the Architect of the Capitol; including fur-
- 2 nishings and office equipment; including not more than
- 3 \$5,000 for official reception and representation expenses,
- 4 to be expended as the Architect of the Capitol may ap-
- 5 prove; for purchase or exchange, maintenance, and oper-
- 6 ation of a passenger motor vehicle, \$88,542,234 (reduced
- 7 by \$100,000) (increased by \$100,000) (reduced by
- 8 \$500,000), of which \$5,268,000 shall remain available
- 9 until September 30, 2021.
- 10 CAPITOL BUILDING
- 11 For all necessary expenses for the maintenance, care
- 12 and operation of the Capitol, \$33,005,499 (increased by
- 13 \$250,000), of which \$9,005,499 shall remain available
- 14 until September 30, 2021.
- 15 Capitol Grounds
- 16 For all necessary expenses for care and improvement
- 17 of grounds surrounding the Capitol, the Senate and House
- 18 office buildings, and the Capitol Power Plant,
- 19 \$12,826,000, of which \$2,946,000 shall remain available
- 20 until September 30, 2021.
- House Office Buildings
- For all necessary expenses for the maintenance, care
- 23 and operation of the House office buildings, \$187,481,000
- 24 (increased by \$250,000), of which \$61,404,000 shall re-
- 25 main available until September 30, 2021, and of which

- 1 \$62,000,000 shall remain available until expended for the
- 2 restoration and renovation of the Cannon House Office
- 3 Building.
- 4 In addition, for a payment to the House Historic
- 5 Buildings Revitalization Trust Fund, \$17,000,000, to re-
- 6 main available until expended.
- 7 Capitol Power Plant
- 8 For all necessary expenses for the maintenance, care
- 9 and operation of the Capitol Power Plant; lighting, heat-
- 10 ing, power (including the purchase of electrical energy)
- 11 and water and sewer services for the Capitol, Senate and
- 12 House office buildings, Library of Congress buildings, and
- 13 the grounds about the same, Botanic Garden, Senate ga-
- 14 rage, and air conditioning refrigeration not supplied from
- 15 plants in any of such buildings; heating the Government
- 16 Publishing Office and Washington City Post Office, and
- 17 heating and chilled water for air conditioning for the Su-
- 18 preme Court Building, the Union Station complex, the
- 19 Thurgood Marshall Federal Judiciary Building and the
- 20 Folger Shakespeare Library, expenses for which shall be
- 21 advanced or reimbursed upon request of the Architect of
- 22 the Capitol and amounts so received shall be deposited
- 23 into the Treasury to the credit of this appropriation,
- 24 \$104,480,000, of which \$27,339,000 shall remain avail-
- 25 able until September 30, 2021: Provided, That not more

- 1 than \$9,000,000 of the funds credited or to be reimbursed
- 2 to this appropriation as herein provided shall be available
- 3 for obligation during fiscal year 2017.
- 4 LIBRARY BUILDINGS AND GROUNDS
- 5 For all necessary expenses for the mechanical and
- 6 structural maintenance, care and operation of the Library
- 7 buildings and grounds, \$47,080,000, of which
- 8 \$22,137,000 shall remain available until September 30,
- 9 2021.
- 10 Capitol Police Buildings, Grounds and Security
- 11 For all necessary expenses for the maintenance, care
- 12 and operation of buildings, grounds and security enhance-
- 13 ments of the United States Capitol Police, wherever lo-
- 14 cated, the Alternate Computing Facility, and Architect of
- 15 the Capitol security operations, \$26,697,000, of which
- 16 \$9,164,000 shall remain available until September 30,
- 17 2021.
- 18 BOTANIC GARDEN
- 19 For all necessary expenses for the maintenance, care
- 20 and operation of the Botanic Garden and the nurseries,
- 21 buildings, grounds, and collections; and purchase and ex-
- 22 change, maintenance, repair, and operation of a passenger
- 23 motor vehicle; all under the direction of the Joint Com-
- 24 mittee on the Library, \$14,067,000; of which \$4,054,000
- 25 shall remain available until September 30, 2021: Provided,

- 1 That of the amount made available under this heading,
- 2 the Architect may obligate and expend such sums as may
- 3 be necessary for the maintenance, care and operation of
- 4 the National Garden established under section 307E of
- 5 the Legislative Branch Appropriations Act, 1989 (2
- 6 U.S.C. 2146), upon vouchers approved by the Architect
- 7 of the Capitol or a duly authorized designee.
- 8 CAPITOL VISITOR CENTER
- 9 For all necessary expenses for the operation of the
- 10 Capitol Visitor Center, \$20,557,000.
- 11 Administrative Provisions
- 12 NO BONUSES FOR CONTRACTORS BEHIND SCHEDULE OR
- 13 OVER BUDGET
- 14 Sec. 1201. None of the funds made available in this
- 15 Act for the Architect of the Capitol may be used to make
- 16 incentive or award payments to contractors for work on
- 17 contracts or programs for which the contractor is behind
- 18 schedule or over budget, unless the Architect of the Cap-
- 19 itol, or agency-employed designee, determines that any
- 20 such deviations are due to unforeseeable events, govern-
- 21 ment-driven scope changes, or are not significant within
- 22 the overall scope of the project and/or program.
- 23 SCRIMS
- SEC. 1202. None of the funds made available by this
- 25 Act may be used for scrims containing photographs of

1 building facades during restoration or construction

2	projects performed by the Architect of the Capitol.
3	WORKING CAPITAL FUND
4	Sec. 1203. (a) Establishment.—There is hereby
5	established in the Treasury of the United States a working
6	capital fund (hereafter in this section referred to as the
7	"Fund") for the Architect of the Capitol.
8	(b) Availability of Amounts.—Amounts in the
9	Fund shall be available to the Architect of the Capitol for
10	such common agency services, activities, and equipment
11	such as construction, capital repairs, renovations, rehabili-
12	tation, maintenance of real property, and similar agency
13	expenses, on a reimbursable basis within the Architect of
14	the Capitol as the Architect determines to be appropriate
15	efficient, and economical.
16	(c) Contents.—The capital of the Fund consists
17	of—
18	(1) amounts appropriated to the Fund;
19	(2) the reasonable value of stocks of supplies
20	equipment, and other assets and inventories or
21	order that the Architect transfers to the fund, less
22	related liabilities and unpaid obligations;
23	(3) receipts from the sale or exchange of prop-
24	erty held in the Fund;

1	(4) all miscellaneous receipts compensating the
2	Architect of the Capitol for loss or damage to any
3	Government property under the Architect's jurisdic-
