Congressman Todd Young introduces 2016 Congressional Veteran Commendation

Area residents asked to nominate local veterans, community servants

U.S. Congressman Todd Young (R-IN) takes the opportunity to launch the 2016 Congressional Veteran Commendation (CVC) program created to recognize the wartime sacrifices and peacetime community involvement of veterans across the Ninth Congressional District of Indiana.

The CVC, in conjunction with the Veterans History Project sponsored by the Library of Congress, is a nomination-based program designed to formally honor distinguished veterans of Indiana's Ninth District and to preserve their stories for future generations of Americans.

"Our service men and women deserve the utmost gratitude for their sacrifices to this nation, and it's the responsibility of each of us to ensure that their patriotic service does not go unrecognized," said Young, who is himself a graduate of the U.S. Naval Academy and veteran of the U.S. Marine Corps. "Each year the CVC gives us the opportunity to honor those brave soldiers, sailors, and Marines who have gone above and beyond the call of duty to protect the freedoms we all enjoy. Indiana has a proud tradition of military service, and I have personally met with numerous Hoosier veterans deserving of this honor, which is why I'm encouraging constituents to nominate a veteran living in the Ninth District."

In order to be considered for the prestigious award, veterans must currently reside in the Ninth Congressional District. Nominees must have served as active duty military personnel or been reservists called to active duty. They also must be retired or honorably discharged from a branch of the United States Armed Forces.

Anyone may serve as a nominator and may nominate as many veterans as desired. Complete nomination packets should be mailed or hand-delivered to Young's local office no later than <u>Tuesday</u>, <u>June 28, 2016</u>. CVC recipients are selected by a board and are publicly honored during a special ceremony to take place later this year. In addition, an in-depth interview of each honoree may be conducted and forwarded to the Veterans History Project to be added to the Library of Congress collection should the veteran choose to participate. - Veteran must currently reside in the Ninth Congressional District of Indiana. To verify, please

 Representative."
- Veteran was active duty in the United States Armed Forces or was a reservist called to active duty.
- Veteran retired from the United States Armed Forces or was honorably discharged.

Please send the following items, in one cohesive package, to: Congressman Todd Young, 279 Quartermaster Court, Jeffersonville, IN 47130 **by Tuesday, June 28, 2016**:

- This Nomination Form, completed in its entirety.
- A 1-2 page letter, addressed to Congressman Todd Young, which details why you believe the nominee should receive the Ninth District's Congressional Veteran Commendation. The letter should contain as much information as possible about the veteran's heroism while in the military **and** community involvement thereafter.
- A current photo of the veteran.
- Copies of photos, military records, news clippings and other two-dimensional memorabilia which help you to tell the story of the veteran's military and community service. *These items are considered supplemental and are not required*; should you choose to submit them, do not submit originals. Please limit your nomination packet to three 8.5x11" pages of supplemental materials.
