#### **Nomination Procedures**

Congressman Scott Rigell is pleased to invite students in Virginia's Second Congressional District to apply for a nomination to one of four U.S. Service Academies – United States Air Force Academy (USAFA), United States Merchant Marine Academy (USMA), United States Military Academy (USMA) and United States Naval Academy (USNA).

To be considered for a nomination, applicants must meet the following minimum criteria:

- Be a legal resident of the Second Congressional District of Virginia.
- Will graduate from or has already graduated from high school in 2015.

To be considered for the Academy graduating class of 2020, applicants must meet the following minimum criteria:

- Be unmarried, not pregnant, and have no legal obligation to support children or other dependents.
- Must be a United States citizen and a legal resident of the Second Congressional District
- Must be at least 17 years old, but not yet 22 years old (as of July 1st the year of admission, 2016).

#### **Summary of Selection Process**

Admission to a Service Academy is two-steps. First, the applicant must directly apply to the Academy and meet prerequisites as published by the Academy. These include, but are not limited to; medical, physical and academic qualifications. An individual must meet these minimum admissions requirements to advance to the second step.

The second step is an interview by Congressman Scott Rigell's U.S. Service Academy Advisory Board. A Congressional Nomination for an appointment is determined by the content of the application package combined with the outcome of the interview. **NOTE**: Those who receive a nomination are not guaranteed admission by the Academy.

Applications from students interested in entering one of the Services in the summer of 2016 will be accepted beginning **September 1, 2015**. All applications and supporting documents must be received no later than **October 30, 2015**. All applications, supporting documents, correspondence or questions must be directed to:

Application acceptance begins.

#### October 30, 2015

**Application Deadline:** All applications and supporting documents MUST be postmarked no later than November 1, 2015. All materials received with postmarks after this date are considered incomplete.

In addition to the application, the following materials are <u>required</u> to complete the application:

#### 1. "Letter of Intent" addressed to Congressman Scott Rigell:

Letter should include your request for a nomination, full name, social security number, gender, legal address, phone number, email address, date of birth, high school name (or college) and address, class rank, test scores, month and year of high school graduation, academy preferences and your accomplishments to date. NOTE: Letter of intent is not the same as the required essay and resume, described below.

#### 2. Essay:

Narrate in one double-spaced page why you want to attend an Academy.

#### 3. Resume:

Must include a summary of achievements that you consider significant in each of the following categories: Academic, Civic Engagement, Athletic, Extra Curricula Activities, and Accomplishments.

#### 4. Academic Transcripts:

Certified high school transcript or most recent college or preparatory school transcript; transcript must include class rank, GPA and Fall 2015 course load.

#### 5. SAT/ACT Scores:

Request Scholastic Achievement Test (SAT) scores be sent directly to Mrs. Terri Dunn-Campbell in my District Office; SAT code is 5944 and the ACT code is 7725; and, Applicants must have taken the SAT/ACT at least once prior to November 1.

#### 6. Three Letters of Recommendation:

References must come from individuals other than applicant's relatives.

One letter from a high school administrator or teacher is required.

ONLY letters of recommendation which arrive sealed to the Office of Congressman Scott Rigell will be considered.

#### Mid-November-Early December 2015

Interviews with Congressman Scott Rigell's U.S. Service Academy Advisory Board will be held for candidates with completed files. Congressman Rigell's office will notify each applicant with specific information regarding interviews after the application deadline has passed.

#### Early January 2016

Students selected for Nomination will be notified by mail.
