- 3. Three letters of recommendation limited to your principal, guidance counselor, high school teachers, and coaches.
- 4. Official high school transcripts which show your cumulative grade point average (GPA) and your class ranking. If you are in prep school or college, please provide transcripts through your senior year.

Please remember that we must have all of these items included with your application to complete this process. Although your SAT and/or ACT scores must accompany the completed application, we will accept supplementary scores after the application deadline, if you choose to take the exam again. If your application is completed in full by October 31, 2016, we will contact you to schedule an interview with the Senator's Academy Selection Committee. Interviews will be held on November 19th, and you will be notified by mail of location and appointment time.

Please note that this is not a substitute for the application/admission process for each of the military academies. Please contact the military academies' admission offices to begin their application process.
