- ⇒ On Jan. 22, the VA CT Healthcare System unveiled its new **Women's Health Center** at the West Haven campus.
- ⇒ The new space provides women veterans access to 3 primary care physicians, 2 nurses (1 nurse practitioner and 1 licensed practical nurse), 2 gynecologists, and 3 mental health professionals
- ⇒ The VA provides a variety of services to veterans & their families, including: healthcare, disability compensation, pensions, educational assistance, home loans, and more.

Summer 2016

Legislative Update

- ⇒ **H.R. 2460:** Directs the VA to provide no cost adult day health care at state veterans' homes to those with a 70%+ service-connected disability.
- ⇒ **Final Farewell Act of 2016 (H.R. 3715):** Directs the VA to permit weekend funerals at national cemeteries—excepting a federal holiday—for religious or cultural reasons.
- ⇒ **Support Our Military Caregivers Act (H.R. 3989):** Requires the VA to contract an independent entity to conduct external reviews of appeals regarding determinations for the Caregivers Program
- ⇒ **Improving Transition Programs for All Veterans (H.R. 5229):** Requires the VA to evaluate the effectiveness of programs to help veterans—especially women, minorities, and the disabled—transition to civilian life.
- ⇒ **VA Health Center Management Stability and Improvement Act (H.R. 3956):** Directs the VA to develop and implement a plan to fill pending medical center vacancies. Also directs VA to withhold bonuses for directors who fail to certify their medical facility is complying with all laws and regulations.

- ⇒ The VA recently unveiled their **MyVA** initiative to better serve veterans. The nation's first MyVA Forum took place last August at Central Connecticut State University.

- ⇒ We mourn the loss of **Renaud "Rene" Albert**, a decorated Korean War veteran. I had the great honor of presenting him with his medals last year in Bristol. My thoughts and prayers are with his loved ones.
