# CONGRESSMAN RUBÉN HINOJOSA AND THE CITY OF PHARR ANNOUNCE FEDERAL GRANT AWARD

*October 5, 2015*—Congressman Rubén Hinojosa joined City of Pharr Mayor Ambrosio Hernandez, Pharr City Commissioners, and Police Chief Ruben Villescas at a press conference today to announce a \$732,551 grant award to the City of Pharr from the U.S. Department of Justice (DOJ) through its Community Oriented Policing Services (COPS) program. The funds will be used to hire six new police officers for the City of Pharr Police Department.

"I want to congratulate the City of Pharr for receiving this important grant from the Department of Justice," said U.S. Rep. Hinojosa. "I am very proud to have been an advocate in their grant application process for this federal funding. Our law enforcement officers put their lives on the line every day for our safety. We must continue our efforts to ensure all of our law enforcement officers are properly staffed, trained, and equipped to meet today's challenges."

The COPS Hiring Program (CHP) is designed to advance public safety through community policing by addressing the full-time sworn officer needs of state, local, and tribal law enforcement agencies nationwide. CHP provides funds directly to law enforcement agencies to hire new or rehire career law enforcement officers and to increase their community policing capacity and crime prevention efforts. The FY 2015 CHP grant program was an open solicitation. All local, state, and tribal law enforcement agencies that have primary law enforcement authority were eligible to apply.

# CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES USDA AWARDS \$750,000 IN GRANTS TO UTRGV

October 21, 2015 Congressman Rubén Hinojosa announced the Grants Program, which U.S. Department of Agriculture's (USDA) National Institute of Food and Agriculture has students who will enter awarded two separate grants to the University of Texas Rio Grande Valley in the amount of \$500,000 and \$250,000. Funding from these two grants will support the future workforce with food and agriculture sector professionals who instructional materials and will manage programs serving underrepresented students.

Hinojosa. "UTRGV continues to provide the best in education for their students and faculty. I congratulate them once again on their high achievement."

# CONGRESSMAN RUBÉN HINOJOSA ANNOUNCES OVER \$20 MILLION GRANT AWARD FOR TEXAS TRANSPORTATION

#### October 29, 2015

Congressman Rubén Hinojosa announced the state of Texas will receive \$ 20,802,400.00 in grant funding from the U.S. Department of Transportation through the Transportation Infrastructure Generating Economic Recovery (TIGER) program for increasing mobility and accessibility to transportation for thousands of Texans living in rural areas. The applications were submitted by the Texas Department of Transportation and supported by Congressman Hinojosa.

"The Texas Department of Transportation is to be commended for their leadership and efforts to increase the mobility and accessibility for our rural Texas residents,' said U.S. Rep. Hinojosa. "This critical project will replace or operating update four and maintenance facilities and 325 transit vehicles. This grant funding will allow improvements in almost every county in Texas, including the counties in my 15<sup>th</sup> Congressional District of Texas."

The Lower Rio Grande Valley Development Council will receive \$264,222 in TIGER funds and \$405,778 in other funds to be awarded by the Texas Transportation Commission for a total of *\$670,000*. Texas is the largest federally funded rural transit program in the country. Texas collaborates with 38 rural transit districts to provide an integrated, seamless network of critical mobility services supported with essential fleet, operating/ maintenance and passenger facility

investments.




