[S. 1707](#) would designate a federal building in Helena, Arkansas, as the Jacob Trieber Federal Building, United States Post Office, and United States Court House.

The bill would designate the federal building located at 617 Walnut Street in Helena, Arkansas, as the “Jacob Trieber Federal Building, United States Post Office, and United States Court House”. [Jacob Trieber](#) was the first Jewish federal judge and served on the United States Circuit Court for the Eastern District of Arkansas from 1900 to 1927.

Mr. Chenault was a U.S. Army veteran, who served in the Pacific Theater during WWII. He was a Clearcreek Township Volunteer Firefighter for 45 years and served 23 years as Fire Chief. He served as a part-time police officer in Springboro during the 1950s, 60s, and early 70s. Mr. Chenault was a charter member of the Springboro Lions Club, at one time serving as its President. Mr. Chenault spent 23 years with the U.S. Postal Service and was the first letter carrier hired to deliver mail in Springboro when home delivery of mail began in 1965.

DETAILED SUMMARY AND ANALYSIS:

James Robert “Bob” Kalsu attended Del City High School in Del City Oklahoma. He was the All-American offensive tackle for the University of Oklahoma and was selected by the Buffalo Bills in the 1968 college draft, earning Rookie of the Year his first AFL season as guard. This was also his final season of football. In 1969 Bob was called to duty to serve with the 101st Airborne Division in Vietnam. Though he was told as a professional football player, arrangements could be made so he did not have to serve, Bob instead said “I gave my word to my country. Just because I play pro football doesn't make me any better of a man or any different of a man than the men already serving our country. I'm going to live up to that commitment and the word I gave.” On July 21, 1970 Bob was killed in action at Fire Support Base Ripcord near the Ashua Valley, Thua Thien, South Vietnam, leaving behind his beloved wife, Jan, who was pregnant, and a young daughter. Bob was awarded the Bronze Star and Purple Heart.
