### **Nomination Information**

## Eligibility

Nominees must meet the following requirements to be eligible for consideration. Please make sure the individual you nominate:

- Is committed to improving the community through activism, education, business, outreach and/or social services
- Resides, works or owns a business in the 34th Congressional District
  - o If you are not sure whether the nominee is a resident or works in the 34th Congressional District, please visit www.House.gov or call the office
- Has made a significant impact in the community
- Is of American Indian and/or Alaska Native heritage

#### Rules

Please adhere to the following rules when submitting your nominations:

- The Candidate Nomination Form must be submitted by November 21, 2016
  - No late entries will be considered
- Nominees cannot be self-nominated
- All nominations must include the Candidate Nomination Form along with a description of your nominee's accomplishments and a biography
  - If you have additional supporting documents, they must be submitted at the same time as the Nomination Form
  - Supporting documents may include: newspaper articles, awards and other printed
  - o Please do not submit more than three pages of supporting documents
  - Audio and video clips will not be accepted
