

**AMENDMENT TO THE RULES COMMITTEE PRINT  
OF H.R. 7  
OFFERED BY MR. FLAKE OF ARIZONA**

Beginning on page 12, strike line 6 and all that follows through page 13, line 13.

Page 25, strike lines 1 through 21 (and redesignate any subsequent sections accordingly).

Page 26, strike lines 14 through 18.

Beginning on page 45, strike line 3 and all that follows through page 46, line 3.

Page 55, beginning on line 23, strike “, including” and all that follows through “System”.

Page 64, strike lines 17 and 18 (and redesignate any subsequent subparagraphs accordingly).

Page 64, strike lines 21 through 23.

Page 93, strike line 10 and all that follows through page 94, line 6 (and conform the table of contents accordingly).

Strike title II of the Rules Committee Print (and redesignate any subsequent titles accordingly and conform the table of contents).

Page 682, strike line 6 and all that follows through page 684, line 2 (and redesignate any subsequent sections accordingly and conform the table of contents).

Page 911, strike line 1 and all that follows through line 23 on page 912 and insert the following:

1 **SEC. 15004. MASS TRANSIT ACCOUNT.**

2 (a) REPEAL OF MASS TRANSIT ACCOUNT.—

3 (1) Section 9503 of the Internal Revenue Code  
4 of 1986 is amended by striking subsection (e).

5 (2) Section 5312(b) of title 49, United States  
6 Code, is amended by striking paragraph (5).

7 (3) Section 5338 of title 49, United States  
8 Code, is repealed.

9 (b) TRANSFER OF AMOUNTS IN MASS TRANSIT AC-  
10 COUNT.—

11 (1) TRANSFER TO HIGHWAY ACCOUNT OF 2012  
12 APPROPRIATED AMOUNTS BASED ON FUELS TAX RE-  
13 CEIPTS.—Amounts transferred before the date of the  
14 enactment of this section to the Mass Transit Ac-  
15 count of the Highway Trust Fund under section  
16 9503(e) of the Internal Revenue Code of 1986 (as

1 in effect on the day before the date of the enactment  
2 of this section) for fiscal year 2012 are hereby  
3 transferred to the Highway Account of the Highway  
4 Trust Fund (as defined in section 9503(e)(5)(B) of  
5 the Internal Revenue Code of 1986, as in effect on  
6 the day before the date of the enactment of this  
7 Act).

8 (2) TRANSFER OF ALL OTHER AMOUNTS TO  
9 GENERAL FUND.—All amounts in the Mass Transit  
10 Account of the Highway Trust Fund (other than  
11 amounts described in paragraph (1)) are hereby  
12 transferred to the general fund of the Treasury.

13 (c) EFFECTIVE DATE.—The amendment made by  
14 subsection (a) shall take effect on the date of the enact-  
15 ment of this Act.

Page 912, after line 23, insert the following:

16 **SEC. 15006. NO REVENUES, NO SPENDING.**

17 (a) OMB CALCULATIONS.—Not later than 60 days  
18 after the date of the enactment of this Act, the Director  
19 of the Office of Management and Budget shall determine  
20 the difference between the spending authorized by this Act  
21 and the amendments made by this bill and the revenues  
22 available in the Highway Trust Fund.

23 (b) SPENDING REVENUE IMBALANCE.—If the Direc-  
24 tor determines that amount available in the Highway

1 Trust Fund on such date is less than the amount author-  
2 ized by this Act and the amendments made by this Act—

3 (1) no additional funds are authorized to be  
4 spent; and

5 (2) the Secretary shall reduce proportionately  
6 the amount of sums authorized to be appropriated  
7 from the Highway Trust Fund for programs under  
8 this Act and to programs amended by this Act.
