4 Any reference in this Act, or an amendment made
5 by this Act, to the Alternative Transportation Account of
6 the Highway Trust Fund shall be deemed to refer to the
7 Mass Transit Account of the Highway Trust Fund.

8 **SEC. 15005. APPROPRIATION FOR HIGHWAY TRUST FUND**
9 **AND MASS TRANSIT ACCOUNT.**

10 (a) **IN GENERAL.**—Subsection (f) of section 9503 of
11 the Internal Revenue Code of 1986 is amended by insert-
12 ing after paragraph (2) the following new paragraph:

13 “(3) **2012 APPROPRIATION.**—Out of money in
14 the Treasury not otherwise appropriated, there is
15 hereby appropriated—

1 “(A) \$32,000,000,000 to the Highway Ac-
2 count (as defined in subsection (e)(5)(B)) in
3 the Highway Trust Fund; and

4 “(B) \$8,000,000,000 to the Mass Transit
5 Account in the Highway Trust Fund.”.

6 (b) EFFECTIVE DATE.—The amendment made by
7 subsection (a) shall take effect on the date of the enact-
8 ment of this Act.
