

## **Executive Order to Prevent Discrimination**

The President this week announced that he planned to sign an Executive Order on LGBT discrimination. This is a huge step forward, as it bans all federal government contractors from discriminating against employees based on their sexual orientation and gender identity.

Congress must now pass the Employment Non-Discrimination Act (ENDA) so we can finally close this chapter of inequality. ENDA has 205 bipartisan cosponsors and will ban all workplace discrimination against the LGBT community; this bill will bring the change we need and the dignity the LGBT community deserves.

On Monday, I led a Los Angeles County Congressional Delegation member letter to U.S. Department of Housing and Urban Development (HUD) Secretary Shaun Donovan commenting on the Promise Zone rule making process. Promise Zones are specially designated areas that are eligible for critical federal resources to invest in manufacturing and job creation.

While I am appreciative that President Obama announced that the City of Los

Angeles would be one of our nation's first Promise Zones, I believe that the opportunity should be expanded to other parts of the region, due to our geographic make-up and population density.

## Sergeant Paul T. Nakamura

There will be a memorialization ceremony and building dedication of the Sergeant Paul T. Nakamura United States Army Reserve Center this Saturday, June 21st at the Joint Forces Training Base in Los Alamitos. Sergeant Nakamura was the first Asian American United States Army Reservist to be killed in 2003 in "Operation Iraqi Freedom."

While I did not know Sergeant Nakamura personally, I thank him and his family for their sacrifice to our nation. My hope is that this building dedication will serve as a testament to his bravery and dedication.

# **On The Hill**

## **Customer Protection and End User Relief Act**

This week, I voted "no" on H.R. 4413, the Customer Protection and End User Relief Act. This disingenuous bill would actually hamstring our financial agencies' efforts to regulate derivatives and roll-back the critical protections in the Dodd-Frank Act, which was made law after the financial collapse that was turned into the Great Recession.

I believe that unregulated derivatives contributed to massive taxpayer bailouts that caused great harmto the American economy just a few years ago. We must not undo the work that was done to enact some of the most important provisions of Wall Street Reform, including enacting consumer financial protections that keep the financial industry accountable for their actions.

## **Continuing the Fight for STEM Education in the 47th District**

This week, I introduced a bipartisan amendment to the Department of Defense Appropriations Act (DoDAA) that directed an additional \$5 million to the STARBASE Youth Program, which provides Science, Technology, Engineering and Math (STEM) education to underserved students nationwide, including students right here in the 47th District. The amendment was accepted , and the DoD App Act passed by a vote of 340 to 73.

I learned from the Appropriations Committee that, because of a letter I sent in March, \$25 million was made available to STARBASE programs. I still think we need more funding for STEM education which is why I requested the additional \$5 million. And I was pleased that it was added to the overall appropriations bill.

In the 47th District, the STARBASE Youth Program Facility at the Los Alamitos Joint Forces Training Base (JFTB) serves nearly 4,000 students a year, and is funded by \$1 million in state funds and \$750,000 in federal funds.

Our 21st century economy requires 21st century skill sets. Investing in our children's education in the STEM fields will make them better prepared for the job market and equipped for success. I have been an educator for much of me adult life, so I appreciate the importance of programs such as STARBASE. Our STARBASE program at the Joint Forces Training Base is doing great work for our community, and we must invest in their continued success.

#### **Department of Defense Appropriations Act**

During the floor action on the Department of Defense Appropriations Act (DoDAA) I voted against an amendment which prohibited the use of funds to transfer or release any individuals detained at U.S. Naval Station Guantanamo.

Unfortunately, the amendment passed and detainees must remain at Guantanamo indefinitely. I also voted for an amendment to prohibit the use of funds for combat operations in Iraq. And unfortunately this amendment failed.

However, I did vote for the overall DoDAA. While the DoDAA did not go far enough in cuts to the DoD, and contained provisions I did not agree with, I felt, overall, it was important to fund and support our troops.

## Violence in Iraq

One of the reasons we went to Iraq in the first place, a reason we shed American blood there, was to create a strong foundation for the Iraqi people to provide their own security and stability. The current situation in Iraq is a culmination of the country's civil war and deep-rooted religious differences.

We must make sure Iraqi forces are able to defend themselves. However, putting our boots on the ground and potentially sacrificing more American lives is not the answer. If we learned nothing from our headlong and ill-conceived rush to start the Iraq War, I hope we at least learned that in these situations we must proceed carefully, cautiously, and with full consideration of all of our options.

Any solution to the problem must include a unity government with all factions participating. This is not the case today. And, whatever we do, we cannot do it alone – this must be a unified effort on the part of our allies both internationally and inside Iraq.

# **Congress U**

### "Revenue Neutral"

Many Members of Congress often introduce bills that are "revenue neutral," meaning they do not cost the federal government, or the taxpayers, any addition money. Bills that are revenue neutral typically may involve removing funds from one program to give to another program; tax rates for certain people or products may also be decreased in one area, then increased in another. It is important to note that bills do not always need to be revenue neutral. However, given the current fiscal climate, the odds of revenue neutral bills passing and becoming law are much higher than if they were not revenue neutral.
