#### **Arming Syrian Rebels**

This week the House voted to arm and train Syrian rebels as part of a plan to combat the terrorist group ISIS in Iraq and Syria as outlined by President Obama last week.

I voted no on the proposal.

As part of a plan to defeat ISIS, I do support airstrikes and building a broad multi-national coalition including allies in the Middle East to combat ISIS.

However, I do not support using U.S. resources to train and equip Syrian rebels. These groups are already mired in a civil war of their own, and what we don't know about them far outweighs what we do know. I'm concerned that members of the Free Syrian Army we train today could turn on us in the future.

The vote was not a simple choice, as some have opined, between supporting the President and ignoring the threat of ISIS. I share the President's belief that ISIS is a brutal terrorist group with no respect for the sanctity of life or basic human rights.

However, I believe our role in dealing with ISIS should be as part of a broad, multi-national response. American safety and security requires us to be smart, not just tough.

#### **Discussing Maritime Issues**

This week I joined a panel with Rep. Janice Hahn, the executive directors of the ports of Long Beach and Los Angeles, and the chairman of the Federal Maritime Commission (FMC), former Long Beach Harbor Commissioner Mario Cordero, for an industry listening session at the Port of Los Angeles.

The purpose was to hear from those in the maritime, ports, and transportation industries regarding congestion at U.S. ports.



In less than a decade, the typical cargo container vessel calling at the ports of Long Beach and Los Angeles has grown from carrying the equivalent of 5,000 containers to upward of 15,000 containers. Efficient cargo handling now makes it possible to discharge all of these containers at a marine terminal in the span of a single day. This can lead to road and rail congestion as this crush of containers has to be picked up by trucks or loaded onto railcars.

The listening session was the first in a series to be held across the country by the FMC to address factors causing port congestion, use of technology to reduce congestion, infrastructure needs, increasing global efficiency, and more.

#### Speaking with PFLAG

This week I had the opportunity to serve as the keynote speaker at the PFLAG Southern Regional Conference in Long Beach.

Formerly known as Parents, Friends and Family of Lesbians and Gays, PFLAG was founded in 1972 and is made up of parents, families, friends, and allies united with people who are lesbian, gay, bisexual, and transgender (LGBT). PFLAG is committed to advancing equality and full societal affirmation of LGBT people through its threefold mission of support, education, and advocacy.

With over 350 chapters and 200,000 members in all 50 states, PFLAG is the nation's largest family and ally organization.

I gave the attendees a legislative update and talked about some of the actions I have taken on the issues of equality and non-discrimination.

I also told them how I proudly fly the Pride Flag outside my Washington, D.C. office in solidarity with the fight for equality (the first House office to do so) and how privileged I was to have been able to stand on the steps of the Supreme Court with hundreds of others when the court handed down their rulings overturning the Defense of Marriage Act and California's Prop 8, which both barred same-sex marriage.

#### Congress on TV

If you have watched any debate, vote, or other action on the House floor, the chances are you were watching it on C-SPAN. The cable channel first began broadcasting live unedited House sessions in 1975 and live unedited Senate proceedings on C-SPAN2 starting in 1986.

Established as a private, nonprofit organization, C-SPAN is funded by a 6¢ per subscriber fee paid by cable providers. C-SPAN operates without advertisements and operates independently--neither the cable industry nor Congress has control of the content of its programming.

The cameras on the House and Senate floors (and many hearing rooms) that C-SPAN pulls feeds from are actually owned and maintained by the respective legislative bodies, not C-SPAN.

A 2013 study found that approximately 47 million Americans, or 24% of adult cable viewers, watch C-SPAN weekly.
