It was a brief legislative week here in Washington, D.C. Now I am back in Southern California for a district work period so I can focus on better serving you, your neighbors, and all of the constituents in the 47th District.

Just a quick legislative update: On Monday, my colleagues from the House of Representatives and Senate convened in a conference committee to negotiate a budget for Fiscal Year 2014. As they begin negotiations, I urge my colleagues on the conference committee to set high standards that tackle long-term government spending and repeal the devastating sequestration cuts that have so negatively impacted our district and our national economy. The time to get this right is now.

With Veterans Day being just around the corner, the House also considered a bill this week that would establish a commission to evaluate the backlog of disability claims at the Department of Veterans Affairs. I voted in favor of this bill. Two other bills aimed to reduce consumer protections that were put in place after the financial collapse, which led to the "Great Recession", were also considered in the House. I voted against these two bills. While we're still in the midst of recovering from the downturn, now is not the time to roll back these important protections.

I have already begun the district work week, which continues until November 11. I just attended the promotion ceremony for Lt. Col. Armstrong who has been the guiding force behind the Sunburst Youth Academy at the Joint Forces Training Base in Los Alamitos. Later in the week, I will be meeting with elected officials in Los Alamitos and Buena Park, as well as hosting a health fair.



# Conference Committee

As I mentioned earlier, Congress has entered into a "conference committee" on the budget. This committee is a temporary, ad hoc panel composed of House and Senate conferees which is formed for the purpose of reconciling differences in legislation between what passed the House and what passed the Senate.

The conference committee is usually composed of the senior members of the respective House and Senate standing committees that originally considered the legislation. After deliberation, the conferees may make one or more recommendations, and they conclude business by having a majority of both House and Senate delegations to the conference sign the conference report. The report is then presented as an amendment to the original bill passed by each chamber, and then it proceeds to the floor of each chamber for a vote where it cannot be amended.

This conference committee must negotiate on a long-term budget deal that will be voted upon by both Chambers of Congress, before going to President Obama. According to the U.S. Constitution, both houses of Congress must pass identical legislation for the bill to become law. I am looking forward to voting on a long-term bipartisan budget deal that not only funds key programs and services, but also restores the funding cuts to critical federal programs by sequestration.
