14 closure rates, and (ii) have the capacity to
15 begin using the financial assistance within 90
16 days after receipt of the assistance; as a condi-
17 tion of the receipt of a grant under this sub-
18 paragraph, the grantee shall submit to NRC in-
19 formation relating to the demographic charac-
20 teristics of the assisted homeowners or tenants,
21 the dollar amount and terms of the relevant
22 mortgages and the outcome of legal proceedings
