- H.R. 2882, "Improving Opportunities for Service-Disabled Veteran-Owned Small Businesses Act of 2013"
- H.R. 776, "Security in Bonding Act of 2013"
- H.R. 4121, "Small Business Development Centers Improvement Act of 2014"
- H.R. 2452, "Women's Procurement Program Equalization Act of 2013"

**The Chairman will be offering amendments in the nature of a substitute to H.R. 2882 and H.R. 776.**

**Any Member wishing to submit an amendment for consideration should provide the amendment along with a 1-2 sentence factual description of the amendment no later than Tuesday, March 4, 2014 at 1:00 P.M. to the attention of Susan Marshall, Committee Clerk ([susan.marshall@mail.house.gov](mailto:susan.marshall@mail.house.gov)).** Members are encouraged to work with Legislative Counsel and Committee staff in drafting their amendments. While Members may file amendments, in writing, at any time prior to or during the markup, the Chair prefers that amendments be prefiled. This will enable all Members to have sufficient time to review the amendments. Please be aware that:

- Amendments filed prior to 1:00 P.M. on March 4<sup>th</sup> will be given priority consideration at the markup.

- The Chairman may refuse a unanimous consent request to consider the amendment as read if it is not filed before the 1:00 P.M. deadline.
- Amendments filed after the deadline may not be distributed to Members until the markup.
- Amendments drafted and offered after the commencement of the markup may necessitate the Chair recessing the markup to enable Committee staff to copy and distribute such amendments.
- For purposes of drafting amendments, please use the bill as introduced for H.R. 4093, H.R. 4094, H.R. 2751, H.R. 4121, and H.R. 2452. For H.R. 776 and HR 2882, please draft amendments to the amendments in the nature of a substitute.
