Rich,

I received a call yesterday from Edgar Garcia (Puerto Rico COE office) requesting help with a safety section of an EIS that they are trying to write (it is a 90-mile-long non-jurisdictional pipeline). I stated that we might be able to give them a pipeline safety jumping off point for their EIS, but would have to check with management to make sure that sending it would be ok. I know that we have a lot of standard language in our safety sections and I was wondering if it would be ok to send him a word version. He also had several questions regarding safety requirements. Therefore I forwarded his contact information to a CATS person with PHMSA. He also stated that in order to construct the pipeline, EcoElectrica would have to expand. I told him that we currently don't have an application before us with Eco (I confirmed this with Turpin and Zerby). However, I gave him David Hanobic's contact information, as he is much more versed in what expansion activities have occurred at the EcoElectrica LNG plant. What I need to know from you is if it would be ok to send him a generic safety section in word.
