Thank you for your inquiry. Following is the U.S. Army Corps of Engineers, Jacksonville District's statement on the transfer of the Via Verde permit evaluation from the San Juan to Jacksonville office.

Due to the high level of interest in and the nature of the Via Verde project, review of the permit application was shifted to the Jacksonville District Office. The new lead project manager is a senior technical expert who will work closely with a multi-disciplinary team, which includes members of the San Juan staff. This team will continue to report to the same branch chief, also in Jacksonville, who has been involved since the beginning of the process. The U.S. Army Corps of Engineers' is continuing its permit evaluation process without interruption and with the goal of a fair, flexible and balanced decision in accordance with the law and appropriate regulations.

Local residents will continue to have the opportunity to provide input, which will become part of the official record and will be considered in the Corps' decision.
