VALPARAISO | An unusual ceremony will be held in Carlsbad, N.M., on July 17 to honor John Lloyd Silliman, a Marine killed in Vietnam in 1969, who is buried in Valparaiso.



It was while John Silliman was in the seventh grade in 1961 in Powder Wash that he wrote an essay for a national contest based on President John Kennedy's "Ask not what your country can do for you. Ask what you can do for your country." Silliman's essay on "What I can do for my country" was chosen as the best in the state.

As the state winner, he was flown to Washington, D.C., met Kennedy and got to

read his essay in the House of Representatives. It was thought the essay was included in the Congressional Record, but when his sister, Kathy, tried to obtain a copy of it for the family, nothing could be found.

Finally, Bobby Lee, who lives in Mount Vernon, Ill., wrote his congressman, Mike Bost, asking for help locating the essay written more than 50 years ago. The request eventually ended up in Illinois Rep. Randy Hultgren's office, where it was determined, with the help of the Legislative Information System staff, it was not made a part of the Congressional Record...
