As President Reagan said on the 40th Anniversary of this fateful battle: "Strengthened by their courage, heartened by their valor, and borne by their memory, let us continue to stand for the ideals for which they lived and died."

Honoring our Commitment to Veterans...

As we remember D-Day, we must honorably keep our promise to care for those who fought for our freedoms. Our veterans deserve the same bolstered support at home that we provide our military on the battlefield and it is shameful to deny our veterans treatment and force them to endure extensive waiting periods for care.

Department of Veterans Affairs (VA) Secretary Eric Shinseki has resigned amid gross allegations of VA mistreatment of veterans, and I thank him for his many years of service to our nation. But it will take more than a resignation and duct tape to fix this mess. We must deal with the debacle resulting from the bureaucratic nightmare at the VA, and focus on giving relief to veterans who have suffered egregiously long wait times and lack of care. The VA system is under duress, failing under its own weight as another result of bureaucracy run amok.

Illinois veterans whose healthcare needs may have been neglected or ignored <u>deserve immediate relief</u>, and I encourage all veterans in the 14th District to contact my Geneva district office for assistance.

...and Ensuring Proper Care at Illinois VA Centers

Fortunately, I was greatly encouraged by my visit to the Capt. James A. Lovell Federal Health Care Center in North Chicago, a combined Department of Veterans Affairs (VA) and Department of Defense (DoD) facility serving veterans and active duty military. I requested a meeting with Director and Commanding Officer Captain Jose Acosta and Acting Deputy Director Michelle Blakely to share my concerns regarding the care Illinois veterans are receiving in light of recent events.

Captain Acosta and Michelle Blakely assured me that Lovell does not operate with a waiting list and they have taken proactive steps to ensure all veterans and active duty military are receiving quality care.

Seeing this country's first federal health center that partners the VA and the DOD into a single, integrated health care facility was an eye opener. The center oversees a full patient workload. But the constant need to navigate bureaucratic red tape can impede them from providing care in a timely fashion.

Capt. James Lovell, for whom the Center is named, successfully piloted Apollo 13 home after diverting near tragedy. If Capt. Lovell could get to the moon and back, then we as a nation can fulfill the promise of taking care of our veterans.

Showcasing Strong Economic Ties with Sweden's Ambassador

## New June Dates for Congressional Assistance

In May, my staff was able to assist many of you in Marengo, Harvard, Plainfield, Sugar Grove, Woodstock and Antioch with their concerns, questions and requests for assistance with federal agencies. Staff members from my Geneva office will continue to travel throughout the 14th District during June to meet with constituents. All of these meetings are in addition to the many meetings I hold with constituents during each district work period.

I urge those in Wauconda, Gurnee, Oswego and Sycamore to bring your concerns and issues with the federal government. If you are a veteran who has felt neglected or ignored by the Department of Veterans Affairs, I especially want to hear from you and assist you as you seek out proper care. Let my staff know your situation and how I can help.

## Appropriations Season in Full Swing

After Congress agrees to spending levels for various federal functions via budget and authorization bills, appropriations bills are the tools which direct that money to the proper agencies. So far, the House has passed three of the 12 standard appropriations bills.

H.R. 4486, the Military Construction and Veterans Affairs and Related Agencies Appropriations Act, ensures we provide for our veterans and active duty military service members. Among other things, it includes \$158 billion for our veterans' benefits and medical care, and \$6.6 billion in discretionary spending for military construction and family housing. H.R. 4487, the Legislative Branch Appropriations Act, cuts wasteful and duplicitous spending within the House of Representatives and includes funding for U.S. Capitol's operations, so that the building may be open and functioning for tourists when they visit Washington, D.C. In addition, for Fiscal Year (FY) 2015 the House has passed:

• H.R. 4660, the Commerce, Justice, Science, and Related Agencies Appropriations Act, 2015, by a vote of 321-87. H.R. 4660 funds the Department of Commerce, Department of Justice (DOJ), the National Aeronautics and Space Administration (NASA), the National Science Foundation (NSF) and other related agencies. This legislation provides \$51.2 billion in total discretionary funding--\$398 million below the FY 2014 enacted level. The bill also eliminates 33 programs, resulting in savings of more than \$250 million, and rescinds \$469 million in unused prior-year funding.

o Included in this bill was an amendment (H.AMDT. 697) which increased funding to combat the heroin epidemic plaguing northern Illinois. It gives \$4 million to the Organized Crime Drug Enforcement Task Force, which supports multi-jurisdictional investigations to target drug trafficking organizations. As heroin and prescription drug abuse rises in the Chicago area, local law enforcement requires strong support federal law enforcement agencies to stop drug trafficking in our communities. I joined the majority of the House in supporting this amendment's passage.

• Additionally, the House passed H.R. 4681, the Intelligence Authorization Act for Fiscal Years 2014 and 2015, by a vote of 345-59. H.R. 4681 authorizes appropriations for all U.S. intelligence activities, including CIA personnel and activities, support to combat units in Afghanistan, monitoring of foreign militaries, analysis of international political and economic events, and research and technology. In light of the recent unauthorized disclosures of classified information, H.R. 4681 provides for continuous evaluation of individuals authorized to access classified information. The bill also requires a declassification review of documents collected during the mission that killed Obsama bin Laden.
