Mr. COLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the Senate amendments to the bill (H.R. 3547) to extend the application of certain space launch liability provisions through 2014; providing for proceedings during the period from January 17, 2014, through January 24, 2014; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to take from the Speaker's table the bill
3 (H.R. 3547) to extend the application of certain space
4 launch liability provisions through 2014, with the Senate
5 amendments thereto, and to consider in the House, with-

1 out intervention of any point of order, a single motion of-
2 fered by the chair of the Committee on Appropriations or
3 his designee that the House (1) concur in the Senate
4 amendment to the title and (2) concur in the Senate
5 amendment to the text with an amendment inserting the
6 text of Rules Committee Print 113-32 in lieu of the matter
7 proposed to be inserted by the Senate. The Senate amend-
8 ments and the motion shall be considered as read. The
9 motion shall be debatable for one hour equally divided and
10 controlled by the chair and ranking minority member of
11 the Committee on Appropriations. The previous question
12 shall be considered as ordered on the motion to adoption
13 without intervening motion or demand for division of the
14 question.

15 SEC. 2. Upon adoption of the motion specified in the
16 first section of this resolution, House Concurrent Resolu-
17 tion 74 shall be considered as adopted.

18 SEC. 3. The chair of the Committee on Appropria-
19 tions may insert in the Congressional Record not later
20 than January 16, 2014, such material as he may deem
21 explanatory of the Senate amendments and the motion
22 specified in the first section of this resolution.

23 SEC. 4. On any legislative day during the period from
24 January 17, 2014, through January 24, 2014—

1 (a) the Journal of the proceedings of the previous day
2 shall be considered as approved; and

3 (b) the Chair may at any time declare the House ad-
4 journed to meet at a date and time, within the limits of
5 clause 4, section 5, article I of the Constitution, to be an-
6 nounced by the Chair in declaring the adjournment.

7 SEC. 5. The Speaker may appoint Members to per-
8 form the duties of the Chair for the duration of the period
9 addressed by section 4 of this resolution as though under
10 clause 8(a) of rule I.
