	Two letters of recommendation supporting your nomination. Letters may not come from immediate or extended members of your family. Suggested individuals include: teachers, coaches, school principals and staff, employers, clergy, counselors, community leaders, etc.		
	Essay of 500 words or less entitled, "Why I wish to attend the (name of academy) Academy." Evaluations will be based upon both writing skill and content of essay		
	Sealed/official copy of high school transcript
