During the month of March, the general administrative and legislative business of the Committee was conducted as usual.

Full Committee

On March 6, the committee held a Markup of H.R. 803, “Supporting Knowledge and Investing in Lifelong Skills Act” or the “SKILLS Act,” which was ordered favorably reported, as amended, to the House by a roll call vote of 23 yeas and 18 not voting.

On March 13, the committee held a hearing on “Keeping College Within Reach: Examining Opportunities to Strengthen Federal Student Loan Programs.”

On March 20, the committee held a Markup of H.R. 1120, “The Preventing Greater Uncertainty in Labor-Management Relations Act,” which was adopted and ordered favorably reported, as amended, to the House by a roll call vote of 23 yeas and 16 noes.

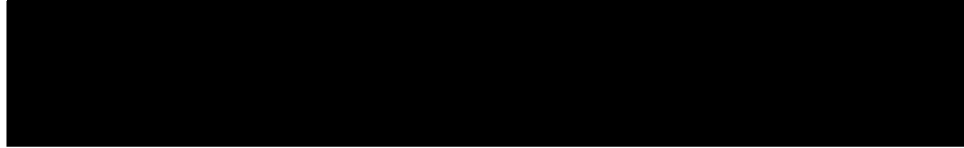

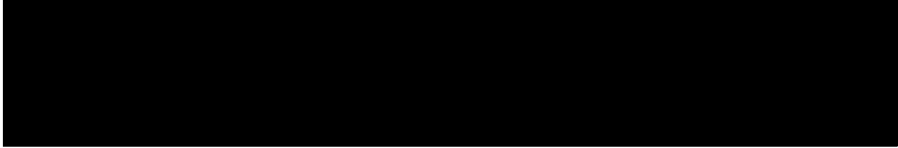
