On Thursday, I objected to the decision by Eric Holder's Department of Justice to grant early release to Lynne Stewart, a former lawyer convicted of aiding terrorism. News reports suggest a massacre of tourists in Egypt may have occurred because of her actions.

No More Taxpayer Bailouts

On Wednesday, I announced my co-sponsorship of the ObamaCare Taxpayer Bailout Prevention Act (H.R.3541), which prevents taxpayer bailouts under ObamaCare. This legislation repeals the part of ObamaCare that grants the Obama Administration unilateral authority to establish a program that could result in taxpayer-funded bailouts of companies forced to do business under ObamaCare.

Hardworking taxpayers shouldn't be on the hook for ObamaCare's failures. We simply can't allow this Administration to pass bad policy and then bail itself out to avoid admitting that ObamaCare is an unworkable disaster. Protecting ObamaCare Identity Theft Victims

On Friday, I voted in favor of and the House passed the Health Exchange and Transparency Act (H.R. 3811), which requires the Obama Administration to notify within two business days any individual whose personal information has been unlawfully accessed through an ObamaCare exchange. Any private business that used sloppy and negligent safety methods that resulted in a breach of private

information would be held accountable in a court of law. The Federal Government should have at least some similar responsibility.
