This past week, the misplaced priorities of President Obama and his administration were on full display. The dangerous Iran Deal, sanctuary city policies that have resulted in the death of innocent Americans and the reported profiting from harvesting organs from unborn babies during abortions, should be concerning to all Americans. These events provided further evidence that this president values his far-left agenda at any and all costs, and over the best interests of the American people. These discouraging actions have only reaffirmed the need for bold action from Congress. Continue reading to learn about the actions I am taking to defend YOUR priorities and put the brakes on the Obama Administration.

### The Iran Deal is a Historic Mistake

The obvious and transparent desperation by the Obama Administration to strike a legacy-defining deal with Iran has put the United States in a position of weakness and vulnerability. We have gone from preventing, to managing, to encouraging Iran's nuclear capabilities while scuttling every red line and breaking every goal established before these negotiations. The deal lifts sanctions almost immediately rather than tying them to verifiable progress; it does not allow for a sufficient inspections regime; fails to curb Iran's ballistic missile program and it

allows Iran to keep its advanced centrifuges. Even the arms embargo will become porous in the near term and will be completely lifted in five years—despite the fact that billions of dollars will be unfrozen for Iran to support terrorist organizations across the world. Each of these provisions makes this so called ‘deal’ unacceptable.

The announced agreement is a historic mistake that will destabilize the region and jeopardize the security of the United States and our allies. Since the Obama Administration has failed to meet its own predetermined goals of these negotiations, the responsibility of rejecting this flawed "deal" falls on Congress. On Thursday, I joined 171 cosponsors in introducing legislation that rejects the Joint Comprehensive Plan of Action agreed to by the P5+1 and Iran. [H. Res. 367](#) is intended to help build support for a formal joint resolution of disapproval that is expected to be voted on in September. I stand with Israel and will continue to do everything I can to prevent this bad deal and to prevent Iran from obtaining nuclear capabilities.

### **Cracking Down on Sanctuary Cities, Illegal Immigrant Releases**

The recent murders of innocent American citizens by illegal immigrants are a direct result of the Obama Administration’s failure to uphold our immigration laws. The silence from supporters of dangerous “sanctuary city” policies is deafening as they continue to ignore the fatal consequences of incentivizing increased lawlessness.

The actions of this administration have violated the first and foremost role of the federal government, to defend our homeland and protect our citizens. President Obama and Secretary Johnson have blood on their hands. How many innocent lives have to be lost before this administration understands the dangers associated with their failed policies? I have pledged my full support to overturning President Obama’s disastrous executive amnesty orders and in demanding legislation that will save American lives and enforce the rule of law. Three bills, of which I am an original cosponsor, were recently introduced to crack down on cities that employ these policies. H.R. 3009, H.R. 3011 and H.R. 2942, respectively aim at withholding federal funds for sanctuary cities, establishing mandatory jail time for illegal aliens that reenter the country and preventing illegal immigrants charged with crimes from being released into the public. We have an amazing panel of Arizona women from all walks of life who will share their stories and tips for success.

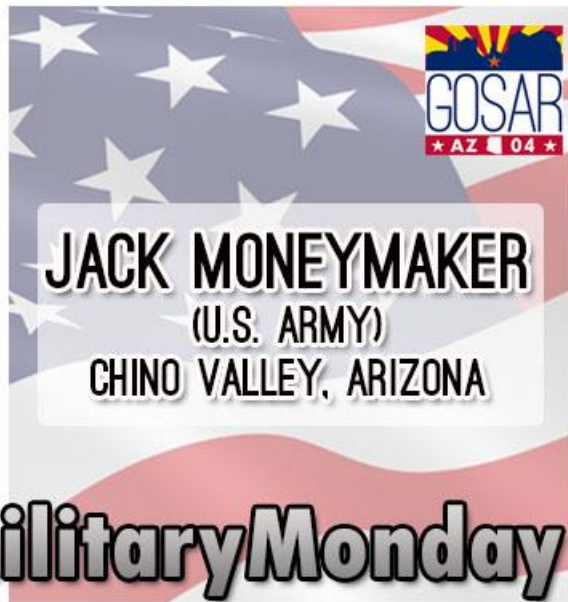
