8	"In this title, the following definitions apply unless
9	otherwise provided:
10	"(1) The term 'United States' when used in a
11	territorial sense, includes all places and waters, con-
12	tinental or insular, subject to the jurisdiction of the
13	United States.
14	"(2) The term 'department' means one of the
15	executive departments enumerated in section 1 of
16	title 5, unless the context shows that such term was
17	intended to describe the executive, legislative, or ju-
18	dicial branches of the Government.
19	"(3) The term 'agency' includes any depart-
20	ment, independent establishment, commission, ad-

1	ministration, authority, board, or bureau of the
2	United States or any corporation in which the
3	United States has a proprietary interest, unless the
4	context shows that such term was intended to be
5	used in a more limited sense.
6	"(4) The term 'State' means a State of the
7	United States, the District of Columbia, or any com-
8	monwealth, territory, or possession of the United
9	States.
10	"(5) The term 'special maritime and territorial
11	jurisdiction of the United States' is as follows:
12	"(A) The high seas, any other waters with-
13	in the admiralty and maritime jurisdiction of
14	the United States and out of the jurisdiction of
15	any particular State, and any vessel belonging
16	in whole or in part to the United States or any
17	citizen thereof, or to any corporation created by
18	or under the laws of the United States, or of
19	any State, when such vessel is within the admi-
20	ralty and maritime jurisdiction of the United
21	States and out of the jurisdiction of any par-
22	ticular State.
23	"(B) Any vessel registered, licensed, or en-
24	rolled under the laws of the United States, and
25	being on a voyage upon the waters of any of the

1	Great Lakes, or any of the waters connecting
2	them, or upon the Saint Lawrence River where
3	the same constitutes the International Bound-
4	ary Line.
5	"(C) Any lands reserved or acquired for
6	the use of the United States, and under the ex-
7	clusive or concurrent jurisdiction thereof, or any
8	place purchased or otherwise acquired by the
9	United States by consent of the legislature of
10	the State in which the same shall be, for the
11	erection of a fort, magazine, arsenal, dockyard,
12	or other needful building.
13	"(D) Any island, rock, or key containing
14	deposits of guano, which may, at the discretion
15	of the President, be considered as appertaining
16	to the United States.
17	"(E) Any aircraft belonging in whole or in
18	part to the United States, or any citizen there-
19	of, or to any corporation created by or under
20	the laws of the United States, or any State,
21	while such aircraft is in flight over the high
22	seas, or over any other waters within the admi-
23	ralty and maritime jurisdiction of the United
24	States and out of the jurisdiction of any par-
25	ticular State.

1	"(F) Any vehicle used or designed for
2	flight or navigation in space and on the registry
3	of the United States pursuant to the Treaty on
4	Principles Governing the Activities of States in
5	the Exploration and Use of Outer Space, In-
6	cluding the Moon and Other Celestial Bodies
7	and the Convention on Registration of Objects
8	Launched into Outer Space, while that vehicle
9	is in flight, which is from the moment when all
10	external doors are closed on Earth following
11	embarkation until the moment when one such
12	door is opened on Earth for disembarkation or
13	in the case of a forced landing, until the com-
14	petent authorities take over the responsibility
15	for the vehicle and for persons and property
16	aboard.
17	"(G) Any place outside the jurisdiction of
18	any nation with respect to an offense by or
19	against a national of the United States.
20	"(H) To the extent permitted by inter-
21	national law, any foreign vessel during a voyage
22	having a scheduled departure from or arrival in
23	the United States with respect to an offense
24	committed by or against a national of the
25	United States.

1	"(I) With respect to offenses committed by
2	or against a national of the United States as
3	that term is used in section 101 of the Immi-
4	gration and Nationality Act—
5	"(i) the premises of United States
6	diplomatic, consular, military, or other
7	United States Government missions or en-
8	tities in foreign states, including the build-
9	ings, parts of buildings, and land appur-
10	tenant or ancillary thereto or used for pur-
11	poses of those missions or entities, irre-
12	spective of ownership; and
13	"(ii) residences in foreign states and
14	the land appurtenant or ancillary thereto,
15	irrespective of ownership, used for pur-
16	poses of those missions or entities or used
17	by United States personnel assigned to

1	"(6) The term 'vessel of the United States'
2	means a vessel belonging in whole or in part to the
3	United States, or any citizen thereof, or any cor-
4	poration created by or under the laws of the United
5	States, or of any State.
6	"(7) The term 'obligation or other security of
7	the United States' includes all bonds, certificates of
8	indebtedness, national bank currency, Federal Re-
9	serve notes, Federal Reserve bank notes, coupons,
10	United States notes, Treasury notes, gold certifi-
11	cates, silver certificates, fractional notes, certificates
12	of deposit, bills, checks, or drafts for money, drawn
13	by or upon authorized officers of the United States,
14	stamps and other representatives of value, of what-
15	ever denomination, issued under any Act of Con-
16	gress, and canceled United States stamps.
17	"(8) The term 'foreign government' except in

5	"(12) The term 'Postal Service' means the
6	United States Postal Service established under title
7	39, and every officer and employee of that Service,
8	whether or not such officer or employee has taken
9	the oath of office.
10	"(13) The term 'crime of violence' means—
11	"(A) an offense that has as an element the
12	use, attempted use, or threatened use of phys-
13	ical force against the person or property of an-
14	other; or
15	"(B) any other offense that is a felony and
16	that, by its nature, involves a substantial risk
17	that physical force against the person or prop-
18	erty of another may be used in the course of
19	committing the offense.
20	"(14) The term 'organization' means a person
21	other than an individual.
22	``(15) The term 'petty offense' means a Class B

- 2 "(a) Whoever commits an offense against the United
