**A BILL**

To ensure that small business providers of broadband Internet access service can devote resources to broadband deployment rather than compliance with cumbersome regulatory requirements.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business  
5 Broadband Deployment Act”.

1 **SEC. 2. EXCEPTION TO ENHANCEMENT TO TRANSPARENCY**  
2 **REQUIREMENTS FOR SMALL BUSINESSES.**

3 (a) IN GENERAL.—The enhancements to the trans-  
4 parency rule of the Federal Communications Commission  
5 under section 8.3 of title 47, Code of Federal Regulations,  
6 as described in paragraphs 162 through 184 of the Report  
7 and Order on Remand, Declaratory Ruling, and Order of  
8 the Federal Communications Commission with regard to  
9 protecting and promoting the open Internet (adopted Feb-  
10 ruary 26, 2015) (FCC 15–24), shall not apply to any  
11 small business.

12 (b) SUNSET.—Subsection (a) shall not have any force  
13 or effect after the date that is 5 years after the date of  
14 the enactment of this Act.

15 (c) REPORT BY FCC.—Not later than 180 days after  
16 the date of the enactment of this Act, the Federal Commu-  
17 nications Commission shall submit to the Committee on  
18 Energy and Commerce of the House of Representatives  
19 and the Committee on Commerce, Science, and Transpor-  
20 tation of the Senate a report that contains the rec-  
21 ommendations of the Commission (and data supporting  
22 such recommendations) regarding—

23 (1) whether the exception provided by sub-  
24 section (a) should be made permanent; and

1           (2) whether the definition of the term “small  
2           business” for purposes of such exception should be  
3           modified from the definition in subsection (d)(2).

4           (d) DEFINITIONS.—In this section:

5           (1) BROADBAND INTERNET ACCESS SERVICE.—

6           The term “broadband Internet access service” has  
7           the meaning given such term in section 8.2 of title  
8           47, Code of Federal Regulations.

9           (2) SMALL BUSINESS.—The term “small busi-  
10          ness” means any provider of broadband Internet ac-  
11          cess service that has not more than 250,000 sub-  
12          scribers.
