

MAP-21 Protects 1.9 Million Jobs Nationwide and Creates 1 Million More Jobs Through Leveraging Transportation Funds

The information in this table was prepared by the U.S. Department of Transportation (US DOT). Job figures rounded to the nearest hundred based on average funding provided over fiscal years 2012 and 2013.

Based on US DOT's job calculation models that assume every \$1 billion in Federal highway funding that is matched by State and local investments supports 34,779 jobs through all sectors of the economy and every \$1 billion in Federal transit funding that is similarly matched provides 37,500 jobs.

Historically, every dollar made available through the Transportation Infrastructure Finance and Innovation Act (TIFIA) program can mobilize up to a total of \$30 in transportation investments through leveraging transportation funds. MAP-21 increases funding for TIFIA to \$1 billion per year which will create up to 1 million more jobs.
