# **A BILL**

To direct the Secretary of Agriculture to exchange certain public lands in Ouachita National Forest, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Walnut Grove Land Ex-*  
5 *change Act”.*

6 **SEC. 2. DEFINITIONS.**

7        *In this Act:*

8            (1) *CHURCH.*—*The term “Church” means the*  
9 *Walnut Grove Church in Garland County, Arkansas.*

10           (2) *OFFERED TRACT.*—*The term “Offered Tract”*  
11 *means all right, title, and interest of the Church in*  
12 *and to approximately 6.3 acres of non-Federal land*  
13 *identified as “Offered Tract 5742” on the Detail Map*  
14 *of the Walnut Grove Exchange, Ouachita National*  
15 *Forest map (printed date May 11, 2017).*

16           (3) *SECRETARY.*—*The term “Secretary” means*  
17 *the Secretary of Agriculture.*

18           (4) *SELECTED TRACT.*—*The term “Selected*  
19 *Tract” means all right, title, and interest of the*  
20 *United States in and to approximately 4 acres identi-*  
21 *fied as “Selected Tract 5743” on the Detail Map of*  
22 *the Walnut Grove Exchange, Ouachita National For-*  
23 *est map (printed date May 11, 2017), subject to the*  
24 *reservation of a road easement by the Secretary.*

1 **SEC. 3. EXCHANGE OF LAND; EQUALIZATION OF VALUE.**

2 (a) *EXCHANGE AUTHORIZED.*—Subject to the provi-  
3 sions of this Act, not later than 2 years after the date of  
4 the enactment of this Act, if the Church offers to convey  
5 the Offered Tract to the United States, the Secretary shall—

6 (1) convey to the Church all right, title, and in-  
7 terest of the United States in and to the Selected  
8 Tract; and

9 (2) accept from the Church a conveyance of all  
10 right, title, and interest of the Church in and to the  
11 Offered Tract.

12 (b) *REQUIREMENTS.*—The exchange under subsection  
13 (a) shall be—

14 (1) subject to valid existing rights;

15 (2) conditioned on an equalization payment  
16 made by the Church in accordance with subsection  
17 (c); and

18 (3) conditioned on the payment of the costs de-  
19 scribed in subsection (g).

20 (c) *EQUAL VALUE AND CASH EQUALIZATION.*—

21 (1) *IN GENERAL.*—Except as provided in para-  
22 graph (2), the exchange under subsection (a) shall be  
23 for equal value or the values shall be equalized by a  
24 cash payment.

1           (2) *EXCEPTION.*—*If the value of the Offered*  
2           *Tract exceeds the Selected Tract, an equalization pay-*  
3           *ment shall not be required.*

4           (d) *APPRAISALS.*—

5           (1) *IN GENERAL.*—*The value of the land to be ex-*  
6           *changed under this Act shall be determined by ap-*  
7           *praisals conducted by one or more independent and*  
8           *qualified appraisers.*

9           (2) *APPRAISAL STANDARDS.*—*The Secretary shall*  
10          *complete an appraisal of the land to be exchanged*  
11          *under this Act in accordance with—*

12                   (A) *the Uniform Appraisal Standards for*  
13                   *Federal Land Acquisitions; and*

14                   (B) *the Uniform Standards of Professional*  
15                   *Appraisal Practice.*

16          (e) *FORMAT.*—*Title and valuation to the land to be*  
17          *exchanged under this Act shall be in a format acceptable*  
18          *to the Secretary and the Church.*

19          (f) *MAP AND LEGAL DESCRIPTIONS.*—

20           (1) *IN GENERAL.*—*As soon as practicable after*  
21           *the date of the enactment of this Act, the Secretary*  
22           *shall finalize a map and legal descriptions of all land*  
23           *to be conveyed under this Act.*

1           (2) *CORRECTIONS.*—*The Secretary may correct*  
2           *any minor errors in the map or in the legal descrip-*  
3           *tions.*

4           (3) *MAP ON FILE.*—*The map and legal descrip-*  
5           *tions shall be on file and available for public inspec-*  
6           *tion in appropriate offices of the United States Forest*  
7           *Service.*

8           (g) *COSTS OF CONVEYANCE.*—*As a condition of con-*  
9           *veyance, any costs related to the conveyance under this sec-*  
10          *tion shall be paid by the Church.*
