SILVER SPRING

Washington Metro Red Line, extensive Washington Metrobus and Ride-On services.

KENSINGTON

Ride-On Routes 4 and 5 (from Silver Spring) and 33 (from Medical Center Metro).

GARRETT PARK

Ride-On Route 38 (from Wheaton and White Flint Metro).

ROCKVILLE

Washington Metro Red Line, numerous Metrobus and Ride-On routes.

WASHINGTON GROVE

Ride-On Route 61 (from Shady Grove Metro).

GAITHERSBURG

Ride-On Routes 57 (from Shady Grove Metro) and 55 (from Rockville Metro, operates along MD 355 - Frederick Ave.).

GAITHERSBURG PARK-AND-RIDE (Route 124 at I-270 interchange)
 MTA Commuter Bus routes: Route 201 (Arundel Mills Mall, Maryland Live Casino, and BWI Marshall Airport), Route 202 (Camden Line Savage MARC Station and Fort Meade), Route 204 (FDA White Oak facility and University of Maryland-College Park).

METROPOLITAN GROVE

Ride-On Route 61 (from Shady Grove Metro).

GERMANTOWN

Bus 94 - Ride-On Routes 100/97 (Shady Grove Metro via Germantown Transit Center).
 Route 61 (direct from Shady Grove) operates along Germantown Road - MD 118.

MONOCACY

MTA Commuter Bus 515 (from Shady Grove Metro). MARC weekly and monthly passes to and from Monocacy and Frederick are honored on the 515 bus route. The 515 bus does not accept MARC one-way tickets. Also, Frederick TransIT (301-600-2065) Routes 10 and 20, www.frederickcountymd.gov/transit

FREDERICK

Station is downtown hub for Frederick TransIT buses (see link above). Also served by MTA Commuter Bus Route 515 (see above).

HARPERS FERRY

Eastern Panhandle Transit Authority (304-263-0876) "Orange Line" service between Harpers Ferry and Charles Town, www.eptawv.com

MARTINSBURG

Several Eastern Panhandle Transit Authority routes, including service to the VA Hospital and other points in Berkeley County (see link above).

- f** Flag Stop, passengers must be on the platform and visible to the engineer, or the train will not stop. Passengers wishing to de-train must notify the conductor when boarding.
- d** Discharge only stop, passengers wishing to de-train must notify the conductor when boarding.
- L** Train may depart up to five minutes early.
- R** This schedule will be in effect as announced by MTA during inclement weather and other special operating circumstances.

 Frederick County TransIT Meet-the-MARC Bus Service connects Frederick and Point of Rocks to this train. For schedule and route information call 301-600-2065. These buses will stop at the Frederick or Monocacy stations upon request to the driver after buses have completed their normal afternoon route.

There will be no MARC Train service on New Year's Day, Memorial Day, Labor Day, Thanksgiving Day, and Christmas Day. The operational status of the Camden/Brunswick Line on the following holidays will be posted on the MARC website www.mta.maryland.gov/marc-train/advisories no later than 30 days prior to the holiday: Martin Luther King, Jr. Day, Presidents Day, Independence Day, Columbus Day, Veterans Day, the day after Thanksgiving, and the week between Christmas and New Years.



MARC PASSENGER CODE OF CONDUCT

- For your safety, passengers must be on the proper platform prior to the train's arrival. Passengers who cross in front of, or behind the train while it is at the station will be denied boarding.
- The conductor is in charge of the train. Follow his or her instructions while riding any MARC train. Please inform the conductor of any service problems you may experience or if you need assistance prior to arriving at your destination.
- Passengers must have tickets out for inspection or collection by any authorized MARC representative. Tickets may be inspected more than once during a trip.
- Improper fare, improper conduct, intoxication, or offensive actions will not be tolerated. Passengers displaying any of these behaviors will not be transported, and will be asked to leave the train.
- Please listen to announcements as they are made for your safety and convenience. Not all doors open at every station. Listen for announcements regarding which doors will open.
- Please do not stand in the aisles when seats are available. Standing is never permitted on stairs or in vestibules. Conductors will direct standing passengers to seats when available.
- No seats are reserved on MARC trains. Please do not inconvenience others by blocking or holding seats with personal items. Please do not place your feet on the seats.
- On all trains, Car 1 (the first car behind the locomotive) is the Quiet Commute Car. This car is intended to have a library-like atmosphere, with no electronic devices or loud conversations. The Quiet Commute Car is to be self-regulated by passengers, not enforced by the conductor.
