
# NATIONAL ARCHIVES ORDER FOR COPIES OF ALIEN CASE FILES (A-FILES)

To determine whether a file is located in Kansas City or San Francisco you **must** complete a search in the National Archives Online Catalog (<a href="www.archives.gov/research/catalog">www.archives.gov/research/catalog</a>). The catalog contains the names of every individual presently contained in our A-Files holdings. The location of each file can be found by completing a name search, selecting the matching file (<a href="mailto:must">must be titled "Alien Case File for [name]"</a>) from the result list, and noting the <a href="mailto:Contact">Contact listed within the Online Catalog entry. ## IMPORTANT INFORMATION ABOUT YOUR ORDER

You may use this form to order copies of Alien Case Files (A-Files). You may request only one A-File per form.

The Immigration and Naturalization Service (INS) began issuing aliens an Alien Registration number in 1940, and on April 1, 1944, began using this number to create individual case files, called Alien Files or A-Files.

A-Files contain the records of any active case of an alien not yet naturalized as they passed through the United States immigration and inspection process. Since the early 20th century, the United States collected increasing amounts of information from immigrants, and A-Files from mid-century hold a wealth of data, including visas, photographs, applications, affidavits, correspondence, and more.

The success of our search depends on the completeness and accuracy of the information you provide in blocks 1-4 on this form. Before submitting a request, you **must** search for the individual in the National Archives Online Catalog (<a href="www.archives.gov/research/catalog">www.archives.gov/research/catalog</a>). The catalog contains the names of every individual presently contained in our A-Files holdings. Information for blocks 1-3 can be found within the initial results list that populates (*Title, National Archives Identifier*), while the *Scope & Content Note* within each catalog entry provides information for block 4.

If the name of the individual you are researching does not appear within the Online Catalog, we ask that you refrain from submitting a record request as we will be unable to provide reference service. #### PRIVACY ACT STATEMENT

Collection of this information is for a voluntary commercial transaction authorized by 44 U.S.C. 2108. ### **ELECTRONIC TRANSFER**

Electronic transfer allows you to download your files from a site, as opposed to having them mailed to you. You will be sent a link for the download. Click the link and download the file to a location of your choosing. Download speeds will vary based upon file size and your internet connection. A valid email address is necessary for electronic transfer. Total file transfers can be in excess of 10GB. However, files of that size are typically separated into multiple, smaller files – none larger than 5GB. Files will be available for 30 days from date of upload; downloads of the files should take place within that period.
